

Two candidates running for sheriff position

Voters have two Republican candidates to choose from for the position of Alcona County sheriff in the primary election on Tuesday, Aug. 7.

Douglas M. Atchison, the incumbent, was born and raised in Alcona County. He graduated from Alcona High School in 1979. He attended classes at Alpena Community College after graduation and then graduated from Macomb Community College Police Academy in 1981.

"I've always had an interest in police work and when a local police officer was retiring and gave me an opportunity, I decided to pursue it," Atchison said.

Atchison's attendance at the police academy was sponsored by the City of Harrisville, which had its own police department at the time. Upon graduation, he was hired as the city's police chief. He held that position until 1983 when the city council voted to disband the police department.

Atchison was hired at the Alcona County Sheriff's Department, starting out part-time. On September 1, 1984 he became a full-time



deputy, a position he held for nine years. He was appointed to the position of undersheriff in January of 1993. As undersheriff he was responsible for the day-to-day operations of the department and directly supervised operations of the county jail.

During his time as a deputy and as undersheriff, Atchison received training in various aspects of law enforcement including accident investigation, criminal sexual conduct investigation, street survival techniques and was a state certified firearms instructor for the county and conducted firearms training for county deputies.

He was appointed to the position of sheriff in October 2007 when then sheriff Douglas Ellinger decided to retire. "After 14 years of being undersheriff, it was always my goal to be sheriff," Atchison said. "I recognized areas

in the department that could be enhanced or improved upon and I had the support of all staff members". Atchison was elected to the position in 2008.

Atchison decided to run for re-election because, "I really enjoy my job. I recognize that over the last five years there have been a lot of economic hardships at all levels. I've worked hard to maintain law enforcement services to the citizens of Alcona County at a time when other county departments and area law enforcement departments are making budget cuts," Atchison said. "It was very important to me that citizens of Alcona County could trust that law enforcement responded when they requested it."

While there are a number of continuing goals that Atchison plans to achieve if he is re-elected, he will work "to improve upon the respect and integrity of the department and make sure I provide a more friendly, approachable agency."

One of the more challeng-

ing goals, besides dealing with budget issues, is keeping up with advances in technology. Law enforcement technology advances at a rapid rate," Atchison said. "It is an absolute requirement to stay on top of that. However, technology comes at a cost. I actually pursue, on an almost daily basis, alternative funding sources to offset the financial burden on the county.

"As an example, last Monday I was notified that we will be awarded an equipment grant for \$11,000 and Friday morning we were awarded another equipment grant for

\$1,000. This is for equipment to keep the department updated," Atchison said.

"I've spent 31 years as a dedicated law enforcement officer in Alcona County. I've done my job to the absolute best of my ability and respecting the citizens of Alcona County," Atchison said. "I hope that my reputation is something that is recognized in the community and would ask for the opportunity to continue my career as sheriff of Alcona County."

Atchison and his wife, Linda, have two children.

HUNT seeks millage renewal

A county-wide millage renewal for the Huron Undercover Narcotics Team (HUNT) will be on the August 7 ballot for voters to consider.

The millage renewal request is asking voters to approve a tax levy of .1453 mills (\$.1453 per thousand dollars) of taxable value for six years "for the purpose of enhancing law enforcement efforts and preserving and protecting the safety of the citizens of Alcona County, specifically for funding the drug interdiction program known as the Huron Undercover Narcotics team, raising an estimated \$111,000 in the first year the millage is levied."

HUNT came into existence in 1990, according to Alcona County Prosecutor Thomas J. Weichel, when an inter-local government agreement was signed between the counties of Alcona, Alpena, Montmorency and Presque Isle, the City of Alpena, Rogers City and Onaway. With the exception of Onaway, all of the entities are still financially involved in the agreement.

Weichel said HUNT has a \$900,000 annual budget of which each governmental entity is asked to provide a percentage of funding for operation of the team. Alcona County's percentage has been between 10 and 12 percent and is provided by the levy of a millage. "The percentage is based on participating gov-

ernmental entities," Weichel said.

Alcona County's percentage pays for the wages and benefits of one full-time and one part-time deputy from the Alcona County Sheriff's Department to serve on HUNT. It also helps fund the salary of the HUNT secretary and the purchase of equipment for the team, according to Weichel, who is a member of the HUNT Board of Directors.

He explained the millage renewal request has been increased from four to six years to help with financial planning. "This is an attempt to look into the future as best we can. This helps us out in financial planning for the team," Weichel said.

Weichel said HUNT and other teams like it across the state focus specifically on enforcing drug laws. "Over the years drug enforcement has always been a specific type of enforcement. It is necessary to have undercover law enforcement (officers) to be able to effectively battle the illegal drug trade that we see," he said. "That especially holds true in small communities where officers are known...with this team we can use officers from other areas for undercover (work).

"Having a team like HUNT provides the ability to focus on illegal drug activity...the sheriff's department could not effectively enforce controlled substance laws in our county without HUNT. Even if they had the manpower of



six or seven (officers) and the nearly \$1 million budget, they still couldn't do what HUNT does - there needs to be others involved to rotate officers in and out so undercover officers are protected. Additionally, we don't have the need for that many officers and that kind of budget (for drug enforcement).

Weichel encouraged voters to consider the fact that Alcona County doesn't stand alone in the need to keep



To the Editor,
In the August 7 election, the Huron Undercover Narcotics Team (HUNT) is asking again for Alcona County property owners to levy a tax against ourselves. This time it would be for six years, not four and would cost Alcona taxpayers \$660,000 (over six years).

What would this buy us and is it worth \$660,000?

Using HUNT's annual reports (available on HUNT's website) for the past four years, it appears the tax we voted for in 2008 didn't buy Alcona County much, though the citizens of Alpena County

did well by us. Consider the following: Alcona County's HUNT tax cost our average property owner 1.5 times what the Alpena County's HUNT tax cost Alpena County property owners.

Alcona County residents paid an average of \$4,586 for each HUNT arrest in our county while Alpena County residents paid just \$1,006 for an arrest in Alpena County.

Alpena County benefitted from 75 percent of all HUNT investigations while Alcona got just 10 percent of HUNT investigations, only 13 per cent.

The Alcona County ballot will have three millages on it: for the seniors' center, for the MSU Extension and for HUNT. All of the funds raised for the seniors' center and the MSU Extension will be spent on services here in Alcona County. Using HUNT's own statistics, HUNT cannot make that claim.

If the Alcona Sheriff's Department believes that drugs are that big a problem here, maybe it should put a millage on the ballot asking for the \$660,000. The citizens of Alcona County would know where their money is being spent and the county would benefit from that money having its impact entirely here instead of mostly in Alpena County. And because of that, maybe a millage for say \$330,000 would do the trick.

illegal drugs out of its boarders. "What occurs in surrounding counties in reference to the illegal drug trade has an impact on the citizens of our community, Weichel said. "We have had, in the past, a number of heroin arrests where people were driving through our county to Alpena County with drugs in their vehicle and under the influence of heroin."

Edward Black, chairman of the HUNT board and prosecutor in Alpena County, explained the importance of HUNT's work also addressed the related issue of smaller crimes. "If we didn't have HUNT we wouldn't have the ability to deal with addiction issues...all of us know that addiction issues lead to the vast majority of crime - larceny, et cetera."

"I think we are a team of communities working together and that is important," Black said. "I appreciate the fact that Alcona County is part of that team. I hope that voters will continue to support this effort."

"The impact HUNT has in surrounding counties also impacts Alpena County. Just the fact that HUNT is around provides a level of security for us," Weichel said. "The fact that HUNT is necessary is not a luxury. It provides a necessary public service that they county can't afford without the millage."

Carl Watkins was raised in Detroit, Mich. and graduated from Western High School in 1959. He graduated from the Detroit Police Academy in 1962 and was hired by the Detroit Police Department upon graduation. Over his 32 year career with the department Watkins worked his way up through the ranks from sergeant to lieutenant to inspector and, served as commander of the precinct for 10 years.

He served in the U.S. Army Reserve from 1964 to 1970. He has a bachelor's of science degree in police administration and a master's degree in public law from Wayne University in Detroit, Mich. He has attended training sessions at the Federal Bureau of Investigations (FBI) National Academy and the U.S. Secret Service School. He has also received "thousands of hours of in-service training across the country" over the years and is "certified as an expert witness in police training in circuit and federal courts" and served on the National Domestic Violence Task Force. Watkins has taught criminal justice at Henry Ford Community College in Dearborn, Mich. and other colleges in the Detroit area.

In 1995 Watkins retired from the Detroit Police Department. In 1996 he became the chief of police in Eaton Rapids, Mich., and held that position for six and a half years. He was the chief of police in Northfield, Mich. for six and a half years, until retiring in 2009.

While he considers himself retired from law enforcement, Watkins does part-time consulting work in the field of testing for police recruitment and promotions.

Watkins and his wife, Barbara Jayne, have four daughters. They started coming to the Oscoda-Harrisville area to visit friends. They purchased property in Harrisville four years ago and Watkins has been living in their home full time for the last year. His wife has a veterinary practice downstate.

If elected, Watkins said he would "like to see some changes and improvements in the delivery of law enforcement services in the county. I'm not in it for the money. If elected, I will donate my first

week of pay, at least, to local churches and food banks."

He decided to run for the position because, "several people have asked me to run to help make changes," Watkins said. "They referred to it as 'good ol' boys club' where we hand down the sheriff position to their friend in the middle of an elected term. They see a problem with the sheriff being married to the deputy magistrate. I think it gives an unfavorable perception of a conflict of interest."

If he is elected, Watkins said, "I would like to develop a program of open transparency and look into a better directed patrol approach to see if we can get better results from the small force...use volunteers — senior citizens and others to assist with anything in our office that would put deputies on the street. I would develop a volunteer chaplain corps that would bring ministers from a church to assist deputies with death notifications. I would develop a good strong working relationship with the Alcona Humane Society as they are the animal control agency for the county."

"I would also develop a website for the department — like the one in Crawford County — which is user friendly and informative. I'd like to (develop) a closer relationship with businesses, service organizations and schools. Lastly, I'd like to serve in a friendly and approachable manner, as I always have," Watkins said.

"I think there is a rumor that you have to be a resident of Alcona County for about 300 years before you are accepted or can run for office," Watkins said. "The best police officer I worked with in Detroit was from Calumet in the U.P. I think if you had cancer you would want the best doctor available, not just a doctor who got their training in Alcona County."

"I think if I were at the end of my term as sheriff, I would be able to say that I developed many lasting programs — which I mentioned earlier. If you've not developed a lot of successful working programs in your term as sheriff the only thing you can do is put out more campaign yard signs than your challenger."

Understanding reverse mortgages

Dear Savvy Senior,
Where can I get reliable, unbiased information on reverse mortgages? My wife and I are thinking about getting one but want to do some research first.

Need Money

Dear Need,
For seniors that are house rich but cash poor, a reverse mortgage is a viable option, but there's a lot to know and consider to be sure it's a good choice for you. Here are some tips and tools to help you research this complex financial product.

Let's start with a quick review. A reverse mortgage is a loan that lets older homeowners convert part of the equity in their home into cash that doesn't have to be paid back as long as they live there.

To be eligible you must be age 62 or older, own your home (or owe only a small balance) and currently be living there.

You can receive the cash either as a lump sum, a line of credit, regular monthly checks or a combination of these. And with a reverse mortgage, you, not the bank, own the house, so you're still responsible for property taxes, insurance and repairs.

Currently, 99 percent of all reverse mortgages offered today are Home Equity Conversion Mortgages (HECM), which are backed by the Federal Housing Administration.

Repayment is due when you or the last borrower dies, sells the place or lives elsewhere for 12 months. Then you or your heirs will have to pay off the loan (which includes the money you borrowed plus accrued interest and fees) either with the proceeds from selling the place, or if you want to keep the house, with money from another source.

To get a better handle on reverse mortgages and how they work, there are several

excellent resources you can turn to for reliable information, but you're going to need access to the Internet utilize them.

To get started, the National Council on Aging recently created a free new website called the Home Equity Advisor that's designed to help you think through the best way to leverage your home – a reverse mortgage isn't your only option.

Just go to homeequityadvisor.org and click on their "Quick Check" tool which will ask you a series of questions about your personal and household situation to define exactly what you might need or want. Then, based on your answers, you'll receive an individualized report offering information, tools, and consumer advice on a range of possible solutions that includes reverse mortgages and other alternatives.

If you find that you are a good candidate for a reverse

mortgage, your next stop is at reversmortgage.org, a new consumer website created by the National Reverse Mortgage Lenders Association.

This site offers lots of educational information including "Your Road Map" which will help guide you through all the features of reverse mortgages and the process of obtaining one.

It also has a calculator to estimate how much you'd be eligible to receive from a reverse mortgage, and offers has a comprehensive directory of licensed HUD-approved mortgage lenders, banks, and credit unions that offer reverse mortgage loans in your state.

Another important resource to help you understand the pros and cons of a reverse mortgage and how it would work in your particular situation is through counseling.

In fact, because reverse mortgages are such compli-

cated products, the federal government requires that all reverse mortgage borrowers receive counseling through a HUD approved independent counseling agency before they take out a HECM loan.

Counseling can be done in person or over the phone and some agencies today provide it for free or at a minimal fee. Some locations charge around \$125. To locate counseling agencies in your area, visit hud.gov/offices/hsg/sfh/hecm/hecmhome.cfm or call (800) 569-4287.

Incumbent **James Burger** was raised in Barton City and graduated from Alcona High School in 1966. He spent four years in the U.S. Air Force prior to being employed by General Motors Company in Bay City, Mich.

Burger began his career at General Motors in production working on the floor. Over the years he advanced to production supervisor, maintenance supervisor, to maintenance engineer, to an administrative planner and then to general supervisor for maintenance for manufacturing equipment - which is the position he held when he retired in 2005.

Upon retirement, Burger and his wife, Gloria, moved to Barton City. He has been involved with the Barton City Improvement Association, is on the finance committee of the Barton City Eagles and is the commander of the VFW Post 8135.

He has been township su-

pervisor since 2008 and is the secretary for the Millen Township Board of Review.

Burger decided to run for re-election because he wants to continue to serve the township in a fiscally responsible capacity and to continue to work toward improving the township's roads. He also works to promote Barton City inside and outside of the county whenever he has the chance.

"I think paying attention to the budget is important - especially in these difficult economic times," Burger said. "These are rough times and we don't have a lot of money. However, since I've been supervisor we haven't used any of our savings (revolving fund). I've felt strongly about managing the budget and I work with volunteers to make that happen. It's important to me that our money is spent wisely and that we get the most out of it. I have the ambition and willingness to make that happen for four more years."

Burger said he strongly supports the townships request for a road millage renewal (1 mill) because it is "really important. We have been working well with the road commission and have the full board support. We are keeping up on maintenance and I think we are making improvements... If we pay attention, listen and stay active - it makes it all work."

"I like to get out and get things done (in the township)... I'd like the opportunity to do it again. We have a lot of talent out here and we just have to continue to use (that talent), Burger said.

James Siebert was raised in Barton City and graduated from Alcona High School in 1971. He worked for Jenson Buick Sales in Harrisville in general automobile maintenance for several years following graduation. He owns and operates a beef cattle farm that has been in his family for many, many years. Over the years, Siebert has worked in construction and has worked at both marinas on Hubbard Lake. He is a member of St. Raphael Catholic Church in Mikado.

He was the supervisor of Millen Township for several terms in the 1990s. "I learned a lot from former supervisor Al Scully," Siebert said. Scully had been supervisor prior to Siebert taking over the position.

Siebert said he decided to run for the supervisor position because several people had asked him to consider it and because "there are some things that I don't like that are going on," he said and cited the work being done on Trask Lake Road. "You shouldn't give them money to tear up the road."

Siebert said he had a good relationship with the board when he was supervisor and, if he is elected, plans to go to meetings put on by the Michigan Township Association. "My slogan is, 'I want to bring the honesty back to Millen Township,'" Siebert said.

If elected to the position of supervisor, Siebert said he "wants to keep the park going nice... It needs some repairs. I'd like to get a dock in the lake in our town. There is no place to launch a boat decently. I'd also take better care of the cemetery. I used to be pretty fussy about how it was cared for."

"I'd like to treat the kids better at the park - that's why it's there - for the kids. They are pretty important," Siebert said.

Search starts for state Christmas tree

The search for the state of Michigan Christmas tree is underway. The state is taking nominations for the 2012 Christmas tree that will sit on the front lawn of the Capitol in Lansing, Mich. in November. The Department of Technology, Management and Budget (DTMB) is searching for a 65-foot spruce or fir. DTMB partners with the Michigan Association of Timbers and the Great Lakes Timber Professionals Association to bring the tree to Lansing. In past years, trees have been found in various locations across the state, including the far reaches of the Upper Peninsula. "We make this as easy as possible for anyone interested in donating" said Phil Jeffery,

chief deputy director for DTMB. "We will come on site to cut and remove the tree from the homeowner's property, so there is no expense for the donator. We accept nominations from any location in Michigan." The state requires the following in order for the tree to be considered:

- Must be a spruce or a fir
- Height must be a minimum of 65 feet, with a maximum crown of 30 feet and a maximum trunk diameter of 30 inches.
- Easy access from a road with no interference from wires.
- Available at no cost.

After delivery of the tree, a DTMB crew then works with Hi-Ball Company of Lansing,

Mich. who volunteers a crane and crew to set the tree. It all culminates with the lighting of the tree in downtown Lansing as part of the Annual Silver Bells in the city celebration. Nominations are requested by July 31, 2012. Individuals wishing to nominate a tree are asked to send their name, telephone number, a photograph of the tree and location to ChristmasTree@michigan.gov, or by mail to: Holiday Tree Search, Michigan Department of Technology, Management and Budget, Facilities Administration, Building Operations Division, P.O. Box 30026, Lansing, Mich. 48909.

Three candidates seek two trustee seats in Caledonia Township

Three Republican candidates are running for two trustee positions on the Caledonia Township Board and voters will choose who will fill these seats in the August 7 primary election.

Gary Grove was raised in Lachine, Mich. and graduated from Alpena High School in 1965. He attended Alpena Community College for a year after graduation. He took what was to be a summer job with Ford Motor Company and it turned into a 41 year career. He retired as a design leader in 2007 and moved "back home to northern Michigan."

He and his wife, Kay, had vacationed on Hubbard Lake for years and decided to make it their retirement home. They have two sons and three grandchildren. He is a member of and involved with Grace Community Church.

Grove decided to run for the position of trustee after attending several meetings. "I had an issue a while back where I was falsely accused of something and I started attending meetings (to resolve the issue). I saw how money was being spent on roads and how ordinances were passing," he said.

He was appointed to the planning commission and was eventually asked to run for the position of trustee. "There were some things that were passing that I didn't feel were conducive to everyone - just full time residents," Grove said. "Some things didn't agree with me and I figured I can not agree or I can get involved and try to make it so everyone has a fair say."

If he is elected, Grove said he doesn't have any specific issues he would like to address. "I want to be as fair to everyone as I can. I know I can't please everyone. But I want to make everyone aware of issues that may or

may not affect them... Ordinances and the use (of property) is a concern. I think there are some ordinances that need to be addressed and resolved to be fair to everyone."

"I got involved (in township government) because I was wrongfully accused, then interested and then appointed," Grove said. "I never expected to do this, but if elected I will be as fair as possible, try to explain (issues) and have a reason for doing something," Grove said.

Kenneth Hubbard was raised in northern Illinois and graduated from Grays Lake Community High School in 1964. Following graduation, he worked for the Department of the Navy for two years as a computer operator. He was drafted into the U.S. Army during the Vietnam War, serving two years in computer repair and operations.

Hubbard received a bachelor's degree in management and organization development from Spring Arbor University in Jackson, Mich. After six years working as a computer operator, and three more years with All State Insurance in the IT department, he and his wife, Maryann, and their daughter, Wendy, moved to Alcona County in 1978. They were looking for a lifestyle change.

In 1982 he was hired by Alpena Community College as an instructor in network computer administration. He officially retired in 2007, but worked another year with ACC afterwards.

Hubbard, who is not running for the 106th State Representative position (that is another person with the same name), is a board member of the Alcona Historical Society and is a member of the Alcona County Veteran's Affairs committee. He is also on the Alcona team of the US-23 Heritage Route, is a member of the Hubbard Lake

North End Park committee and sits on the Caledonia Township Zoning Board of Appeals.

"I became interested in township politics in 2000 over an issue and started going to planning commission meetings," Hubbard said. "Then I decided to (attend) township meetings because I got interested. I realized this is where all decisions are made in regard to ordinances and much of the decisions are made in regard to taxes. I thought about (running) in 2008 and decided to go for it this year - with some encouragement."

If he is elected, Hubbard said he didn't have specific goals or issues he wanted to address, "except to be the gatekeeper or devil's advocate in regard to where tax dollars go. I want to make sure it is spent wisely. I would come to township meetings with fresh ideas and an open mind. I don't have any preconceived ideas about anything. I am fair, impartial and committed," Hubbard said.

Incumbent **Brad (Jack) Scott** was raised in Troy, Mich. and graduated from Troy High School in 1976. Following graduation, he worked at his father's auto body shop for several years. When he was 21 Scott decided to go into radio broadcasting. This career choice served him well until he "walked away from full time radio broadcasting 10 years ago" to do full time voice over work for radio and television commercials. His company is Jack Scott Voice Productions in Spruce.

Scott came to northeastern Michigan after he met his wife, Kerry, who was from the area. They moved to Spruce, with their four boys, in 2000. While raising their children he was involved with Little League activities and is a past member of the North End Park committee.

He has been a township trustee for the last four years and decided to run for reelection because he wanted to continue working on the board. "I've enjoyed what we've accomplished," Scott said. "I've met a lot of residents and have enjoyed working with them. (As a board) we deal with a host of things, but I've stayed focused on improvements to the township hall building and road improvements. I helped develop and manage the website for the township so residents can stay connected with the township."

As a member of the township planning commission,

Three seek Mitchell Township trustee seats

Mitchell Township residents have a choice of three Republican candidates who are vying for two trustee positions on the Mitchell Township Board in the primary election on Tuesday, Aug. 7.

Carla Brimm was born and raised in Shelby Township, a northern suburb of Detroit, Mich. She graduated from Utica High School in 1977. After graduation, she served in the U.S. Navy for four years working in inventory control and supply.

She spent three years working in quality control with an electronics shop and while there moved into the area of accounting. Brimm eventually moved into a position where she conducted audits for different companies - a freelance position she held until 1999. From there she joined an advertising company and worked with the broadcast department to convert to a new computer system. She was the system administrator with that firm until 2006 when she joined its parent company, Publicis Group, where she worked on a conversion team traveling to companies to train employees on the new computer system. In 2008 she became a systems analyst and works from home in that position.

Brimm remembers coming to Curran as a toddler - her grandmother was Alice (LaForge) Tloczynski - and always had the goal to live in the community. That goal started to become reality in 1999 when she and her husband, Ray, purchased acreage that had been in her family since 1894. They moved to Curran in 2004 and even though she traveled quite a bit for work, she considered it home. In 2008 they purchased the final piece of property and now live on her family's farm.

"Even though I've never run for office before, I've always paid attention and been interested in what was going on," Brimm said. "It's important to know what is going on in the community where you work and live. I want to make sure the government is doing what people want it to."

Brimm said she first thought about running the first time she voted in Mitchell Township and saw there wasn't a choice of candidates - one person running for one seat or two people running for two seats. "As I went to meetings I thought that another woman on the board, fresh ideas and a new perspective would help. I also thought it was important to get someone (on the board) who is here all year," she said.

If elected Brimm would like to have the township website updated and for it to become more user friendly. "I'd like to find more ways to get the community involved and give their input," she said. "I'd like to encourage people to take part - even in small levels of government.



(If elected) I would always be willing to take people's comments and point of views...they should use their right of freedom of speech to be heard by local officials," Brimm said.

Incumbent **Linda Lay** did not return telephone calls from the Review prior to press time.

Sheri L. Sanford was born and raised in Lincoln. She graduated from Alcona High School in 1989. She received an associate degree in general business from Davenport College in Lansing, Mich. Her husband, Mike, owns Sanford Builders, where she works as the office administrator. She also works from home doing research and data collection for a legal copy service which assists attorneys regarding various legal issues.

Sanford has served on the Mitchell Township Planning Commission for about one year.

"I'm interested in knowing more about the area," Sanford said. "I feel like I can be more responsible, make decisions and be more involved in the community...I think Mitchell Township has the potential to grow. I'd like to see improvements and help the community with decisions.

"I want to meet my neighbors - not just in our township, but throughout the county and in the area," Sanford said.

Scott hopes to continue working on several ongoing projects including ordinance reviews and changes. He would like to continue to make improvements on the park and hall. He is working to acquire grant money to give the hall a facelift. "It's an old building that needs attention...I enjoy things like this and I think I have a good eye for it," Scott said.

"I am proud of my suggestion of a salary freeze for board members for each and every year I've been on the board. Times are tough...it's not a great amount of money, but I don't think people want to hear about politicians voting themselves an increase when people are struggling economically," Scott said. He is also proud of his attendance record. "I think I have a pretty close to perfect record on the two committees I'm a member of. When you are accountable, people need to know you are there. I don't think anything like this should be taken for granted. If you are going to do it, do it. Be involved," Scott said.

Time for Menard to get it in gear

Say this for Paul Menard. He can pick them.

The Crown Royal Presents the Curtiss Shaver 400 — named after a firefighter from Alabama — was the 203rd Sprint Cup race of Menard's career. The last time NASCAR visited Indianapolis Motor Speedway, Menard was the driver who won.

It was quite a story. Menard's family has a long history at the Brickyard. He is from Eau Claire, Wisc. Even now, Menard, 31, has only six top-five finishes at the Sprint Cup level. So far this year, his best finish was a sixth in the Daytona 500. He is 15th in the point standings.

Repeating at Indy would seem to require a great deal of magic being re-created.

"I've got the trophy in a spot right between my bed-

room and the kitchen," Menard said, "so I walk by it a dozen teams a day, at least."

If it's been a humdrum season so far for Menard, it mirrors the performance of his team, Richard Childress Racing, which hasn't won a race yet, either. One of Menard's teammates, Kevin Harvick, ranks sixth in the point standings, but the other, Jeff Burton, is 19th.

"RCR, as a whole, has run competitively this year, but we need to get better to make the next step up, everywhere from Kevin and myself and Jeff, across the board, and we have been doing some testing, trying to develop some new ideas and theories to get better," Menard said. "Really, this week is no different."

No different? Maybe not for his team or his teammates. For Menard, though, it's a return to a scene he will remember always.

Menard is a long shot to make the Chase. He has to win. Only seven races remain in the NASCAR regular season.

"We have to take more risks," he said. "If it comes to fuel mileage at the end, maybe gamble a little bit to stretch the mileage out. We are working hard on improving the race cars every week.

"That's a big part of it, too, just putting yourself in contention of winning. If you run top 10, and especially top five, you can put yourself in position to win."

Even, at least once, at the Brickyard.



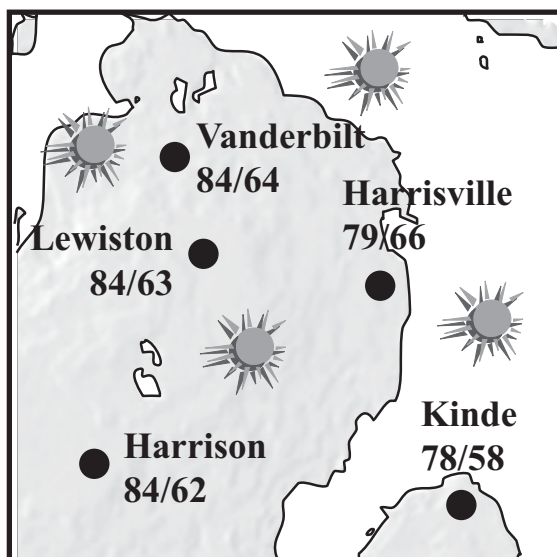

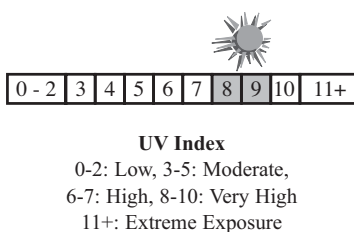

StarWatch By Gary Becker - Great Year for the Perseids

I always think of the meteor season beginning with the August Perseids. It is true that rates pick up somewhat after the Lyrid Meteor Shower which reach maximum on April 21, but it really does not become dramatic until the Perseids. This year, Perseid action is slated to be normal, but the moon is being more than cooperative. On the morning of maximum, August 13, when activity can approach one meteor per minute, Luna will rise as a thin waning crescent just after 2 a.m., a delicate ornament to the brightening dawn sky. The annals of Perseid activity go back for nearly two thousand years. The Chinese wrote about an abundant display of summer meteors in 36 AD, and references appear in early Japanese and Korean records, but it wasn't until 1835 when the Belgium astronomer, mathematician, and sociologist, Adolphe Quetelet, brought the Perseids to the scrutiny of the scientific community. In the mid-1860's, Giovanni Schiaparelli, the Italian astronomer who introduced the world to channels (canals) on the Martian surface, discovered that Perseid meteors orbited the sun in a similar path to periodic Comet Swift-Tuttle. Thus the association of meteors having parent bodies, mostly comets, but later also asteroids, was conceived. The summer Perseids are undoubtedly the most observed meteor event of the year. I have traveled several times to dark locations in New England and even as far west as New Mexico in 1994 to view them. When Swift-Tuttle made a return appearance in 1992, astronomers anticipated the Perseids might storm in 1994. Numbers were much higher than normal, but storm activity, rates of 1000 or more meteors per hour, failed to materialize. Sadly, my 11-day stay in the mountains north of Las Vegas, NM yielded only one clear period, but fortunately, that was the night of Perseid maximum. I'll write more about observing the Perseids next week. www.astronomy.org

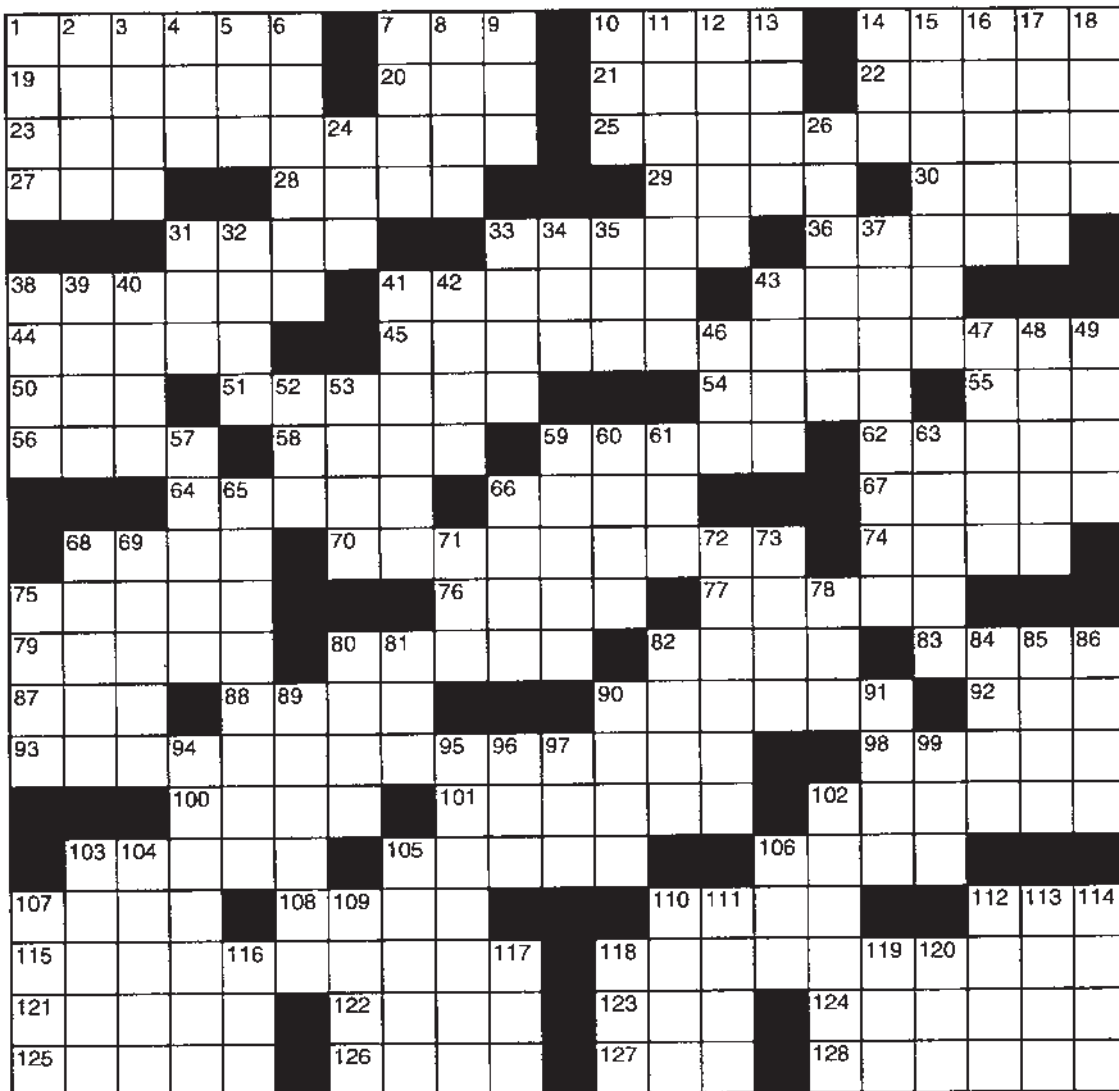

MOMENTS IN TIME The History Channel

• On Aug. 16, 1896, George Carmack spots nuggets of gold in a creek bed near the Klondike River in Canada's Yukon Territory. His lucky discovery sparks the last great gold rush in the American West. Over the next two years, as many as 50,000 would-be miners arrived in the region.

• On Aug. 17, 1915, Charles F. Kettering is issued a patent for his "engine-starting device" — the first electric ignition for automobiles. In the early years, drivers used hand cranks to start the internal combustion process that powered car engines.

• On Aug. 14, 1935, President Franklin D. Roosevelt signs into law the Social Security Act. Although it was initially created to combat unemployment during the Great Depression, Social Security now functions primarily as a safety net for retirees and the disabled.

• On Aug. 18, 1940, Walter Percy Chrysler, the founder of the American automotive corporation that bears his name, dies in New York. Aside from automobiles, Chrysler was known for financing the 77-story Art Deco Chrysler Building skyscraper in midtown Manhattan. When completed in 1930, it was the tallest building in the world and the first manmade structure to top 1,000 feet.

• On Aug. 19, 1953, the Iranian military, with the assistance of the United States government, overthrows the government of Premier Mohammed Mosaddeq and reinstates the Shah of Iran. As thanks for the help, the Shah signed over 40 percent of Iran's oil fields to U.S. companies. However, the Shah was toppled from power in 1979.

• On Aug. 13, 1961, East German soldiers begin building a wall between Soviet-controlled East Berlin and the democratic western section of the city. Berlin residents found themselves cut off from friends or family until the wall was dismantled in 1989.

• On Aug. 15, 1983, Hurricane Alicia forms south of Louisiana in the Gulf of Mexico. Three days later, the Texas Gulf Coast is slammed by the storm, causing 21 deaths. The \$2 billion in damages recorded was a record for hurricane damage in Texas at the time.

- More than 50% of Americans ingest this drug on a regular basis. 17 million Americans are addicted to this drug.
- According to the National Institute on Drug Abuse (NIDA), this drug costs the United States economy \$185 billion a year in increased health care costs, crime, and lost productivity.
- Fifty percent (50%) of U.S. homicides are related to this drug.
- Estimates range from 60 to 80 percent of all violent crimes (rape, domestic abuse, assault, etc.) committed under the influence of this drug.
- According to the British medical journal The Lancet, this drug is more harmful than heroin and crack cocaine, and is the gateway drug to other drugs.
- This drug is so dangerous, that for 13 years there was a Constitutional Amendment that prohibited its manufacture and consumption.

Of course, this drug is alcohol, dispensed from bars and party stores throughout Alcona County.

Roadside surveys in the United States indicate that about three percent of drivers at any particular time are legally impaired by alcohol. On weekend evenings, that number is nearly tripled.

It is shameful that supposed role models will consume the most abused and dangerous drug in America and then put a young adult in jail for up to a year for having one joint.

The definition of hypocrisy in Alcona County is asking our taxpayers to send \$660,000 to Alpena for HUNT to terrorize medical marijuana patients and caregivers (93% of HUNT seizures are cannabis), while providing no additional funds to protect our citizens from drunk drivers.

Stop the hypocrisy. Vote NO on the HUNT tax and say NO to the scare tactics and lies used by a government interdiction unit to justify their bloated budget. Instead, fund our local police to fight drunk driving.

I do believe that most people can use alcohol responsibly. And I do believe that most people can use cannabis responsibly. But by every measure on health and crime, alcohol is by far the more dangerous.

GUSTIN TOWNSHIP ORDINANCE

Ordinance Addressing Floodplain Management Provisions of the State Construction Code Gustin Township-Alcona County Ordinance No. 2012-3

An ordinance to designate an enforcing agency to discharge the responsibility of the township of Gustin located in Alcona County, and to designate regulated flood hazard areas under the provisions of the State Construction Code Act, Act No. 230 of the Public Acts of 1972, as amended.

The Township of Gustin ordains:

Section 1. Agency Designated. Pursuant to the provisions of the state construction code, in accordance with Section 8b(6) of Act 230, of the Public Acts of 1972, as amended, the Alcona County Building inspectors office of the county of Alcona is hereby designated as the enforcing agency to discharge the responsibility of the township of Gustin

under Act 230, of the Public Acts of 1972, as amended, state of Michigan. The county of Alcona assumes responsibility for the administration and enforcement of said act throughout the corporate limits of the community adopting this ordinance.

Section 2. Code Appendix Enforced. Pursuant to the provisions of the state construction code, in accordance with Sections 8b(6) of Act 230, of the Public Acts of 1972, as amended, Appendix G of the Michigan Building Code shall be enforced by the enforcing agency within the county of Alcona.

Section 3. Designation of Regulated Flood Prone Hazard Areas. The Federal Emergency Management Agency (FEMA) Flood Insurance Study (FIS) entitled Alcona County Michigan 26001CV000A, as dated September 28, 2012 and the Flood Insurance Rate Maps (FIRMS) panel numbers of 270, 275, 407 and 410

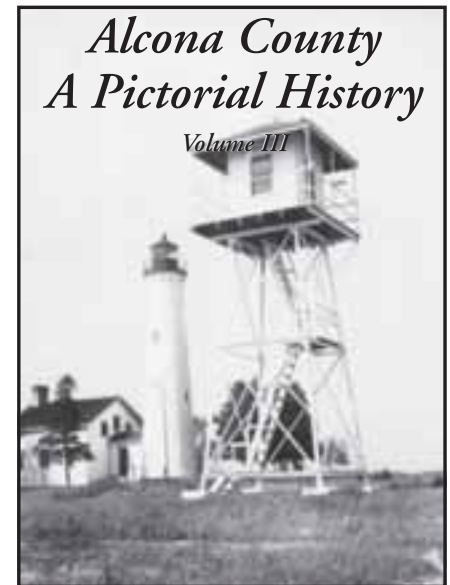
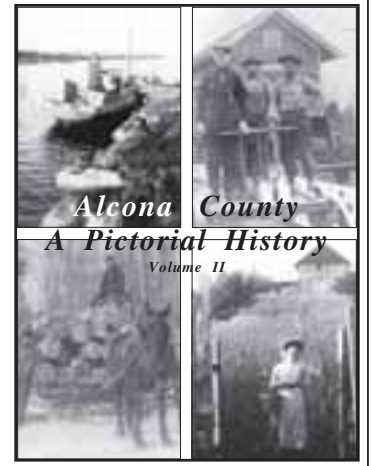
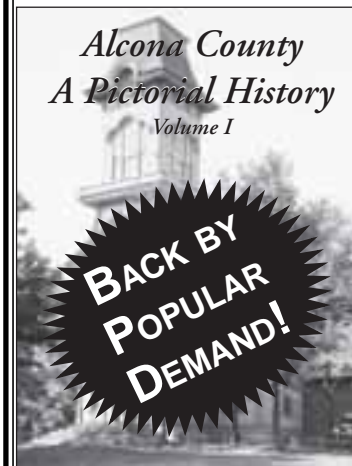
and dated September 28, 2012 are adopted by reference for the purposes of administration of the Michigan Building Code, and to provide the content of the "Flood Hazards" section of Table R301.2(1) of the Michigan Residential Code.

Section 5. Publication. This ordinance shall be effective after legal publication and in accordance with the provisions of the act governing same.
