

## Teacher-coach becomes assistant principal-athletic director

Moving from teaching in a classroom into the role of an administrator can be a difficult transition, but for Alcona Community Schools' new assistant principal, this career change is going smoothly thanks to the support from everyone around him.

On July 1 Dan O'Connor became the assistant principal and athletic director for the school district. "Dan is hard working and he has a lot of creative ideas," said Alcona Community Schools Principal Terry Allison. "He's not afraid to share ideas. He

is from our school district and knows the students, teachers and staff so the learning curve is really low."

While he hadn't planned on moving into an administrative role this early in his teaching career, O'Connor has been preparing for this move for several years. He earned a master's degree in administration from Grand Valley State University in 2010.

"One passion I've always had was administration," O'Connor said. "I grew more interested while working with Jim Watts (retired Alcona high school principal), who I considered a mentor... This

is something I always wanted to do on down the line, not six years into teaching - because I love teaching and coaching kids. That direct contact is something that I really enjoy. But, when an opportunity presents itself you have to seize the advantage and adjust," O'Connor said.

"I'm excited. I've felt welcome in this community from the minute we came here and we are excited to still be a part of it and hope to continue to make Alcona schools a great place to be," O'Connor said.

He began teaching at Alcona Community Schools in the fall of 2006, following

spring graduation from Central Michigan University with a degree in education, majoring in English and minoring in history. During the last six

years he taught high school English and history and middle school social studies with creative writing mixed in. "It seemed to change each year, which made it fun," O'Connor said. "Change is a good thing. (Change) it keeps it fun and moving in good directions."

He also began coaching girls junior varsity basketball and junior varsity baseball. He was an assistant junior varsity football coach for two years. Following the retirement of girls varsity basketball coach John Katona, O'Connor took over for three years until he accepted the assistant principal position.

Deciding to apply for the position was a "family" decision, O'Connor said. He and his wife, Ashlie, who have an 18 month old daughter, talked it through. "Without her support I could not take this leap," O'Connor said. "It's definitely a position that has time requirements, and with

## Boards suspend programs at Sprinkler Lake Education Center

Educational programs at Sprinkler Lake Education Center have been suspended and the annual autumn community event, Nature Fest, has been cancelled this year.

According to Brian Wilmot, superintendent of Alpena Montmorency Alcona Educational Service District (AMA ESD), the suspension of educational programs is due to economic conditions and shortfalls.

The AMA ESD holds a rolling 30 year lease for the Sprinkler Lake Education Center (SLEC) which is owned by the U.S. Forest Service, Wilmot explained. The 120 acre site, located between Mikado and Glennie in the Huron National Forest, has fully equipped

classroom facilities, five dormitories, a dining hall and was used to enhance hands-on education in math and science.

Wilmot said he believes the lease is renewed annually, so the term does not diminish, but was working on securing a copy of the lease to verify that information.

According to Wilmot, the decision to suspend use of the facility was made after receiving recommendations from superintendents of Alpena, Alcona and Hillman school districts.

"It is the mission of the AMA ESD to serve and support student achievement. We act as an intermediary fiduciary agent responsible for the best utilization of our resources," Wilmot said. "The

AMA ESD would have liked to keep the Sprinkler Lake facility going, but we couldn't go it alone."

Wilmot said at one time there were many schools participating in the math and science programs offered at the Sprinkler Lake site including schools in Iosco County and Kirtland and Alpena community colleges.

"With state and local funding for education diminishing, schools have had to make some tough choices on programs to enhance education to its fullest potential," Wilmot said. "Cutbacks have included the loss of many programs. Iosco pulled out (of SLEC) last year leaving only the AMA ESD, Alpena, Hillman and Alcona."

Shawn Thornton, super-

intendent of Alcona Community Schools said, "The superintendents did, unfortunately, have to make that recommendation to the AMA ESD. We are all highly appreciative of the opportunities that Sprinkler Lake Education Center has afforded our students. However, faced with continued declining revenue from the state to support the education of our students, we had to prioritize our areas of immediate need in terms of student achievement and make tough recommendations about programs we support.

"Sprinkler Lake instruction is simply not the most cost effective model to utilize to help our students, so we

## Varsity volleyball team places third in Oscoda Invitational

The Alcona Varsity Volleyball team earned third place in the Oscoda Invitational Tournament on Saturday, Sept. 15 after winning seven out of 12 matches.

The Alcona Lady Tigers joined Hale, Oscoda, AuGres-Sims, Whittemore-Prescott and Tawas to battle for the Oscoda Volleyball Championship. The first two games started at 9 a.m. and the last match between Alcona and

Whittemore finished around 6 p.m.

It was a long day but tournaments like this are important as it gives local athletes a chance at a closer look at their competition. Athletes have the opportunity to play and meet a number of experienced seasoned athletes and figure out for themselves who to watch and how to adjust to be more competitive against them.

During the tournament each team played a total of 12 games. All games were played to 25 points, rally score, win by two, no cap. The championship and runner-up teams were determined by win loss record.

Alcona started out splitting a match with Oscoda 25-23, 15-25. The next two games against AuGres-Sims didn't go in the Tigers favor as they trailed in both games and couldn't catch up. Plagued by missed serves and poor communication from Alcona, AuGres was able to make some key points when they needed them most. They finished 20-25, 20-25 over Alcona.

The Tigers went on a four game winning streak against Hale 25-15, 25-14, and Hillman 25-17, 25-16, winning both games in each set.

Tawas was a different story. Alcona had trouble knocking down the ball to score and digging the ball up on defensive. The Braves were unstoppable playing remarkably well on all levels. They defeated the Tigers easily in both matches 11-25, 9-25. However, the Tigers were able to finish the day on a positive note as they defeated Whittemore-Prescott 25-15, 25-15 to finish the day.

Tawas worked extremely hard to capture the first place trophy with a perfect score of 12-0, Oscoda came in second place with 8-4 and Alcona finished third with 7-5. "Throughout the tournament the girls played hard to compete. They continued to show improvements in all areas of the game as they work together to strive to accomplish our team goals," said Coach Kristi Arnold.

The day was a combined team effort with Alcona's Carly Mitchell and Katelyn Nelson having 10 aces each. Karina Cole and Nelson had two blocks each. Mitchell and Cole each had 16 kills. Nikki Smith had 41 assists and Katelyn Nelson had 13 digs for the day. Alcona junior varsity team split the day with five wins and five losses.

Earlier in the week, the Ti-

gers traveled to Whittemore-Prescott on September 12 for their first Huron Shores Conference game of the season. They captured their first conference win after playing four tough matches against the Whittemore Cardinals.

Alcona led the first match sealing the deal with an ace from senior Tori Keerl. Alcona won 25-23. The second match was little more challenging, Whittemore fought back to





a young daughter and, hopefully, a growing family, we knew it would be a 'team O'Connor' effort to make it work. I'm very thankful to have the support of my wife."

Over the last six years O'Connor said he has "gained a better understanding of the whole school concept" and feels good about changing from the direct connection with students as a teacher to working to "help kids in (planning) curriculum - so they can do better that way," he said. "Jim Watts, (superintendent) Shawn Thornton and Terry Allison trusted me (over the years) to take on some leadership positions... to trust a young teacher to do these things..."

Allison said the decision to change from having a principal in the high school/middle school and a principal in the elementary school to a principal and assistant principal for the district was made last school year. This change is

an effort to streamline responsibilities. "If I'd been in the high school and Dan was over at the elementary school we'd both be doing the same thing - curriculum, discipline, evaluations, et cetera. By doing it this way it's fewer hats, but bigger hats," Allison said.

He said O'Connor will be handling athletics, discipline and curriculum for English and language arts for the district. He will be doing teacher evaluations, handling special education, parental concerns and math and science curriculum for the district.

This division of responsibilities puts both Allison and O'Connor in each building several days a week. "I think it's going well," Allison said. "It's been busy, but that is expected. We are modifying things as we go along to make it better. The staff in both buildings is great. The kids are great (in the elementary) too. They are eager to learn,

inquisitive and like lots of hugs," he said.

Allison, who also came into administration at Alcona Community Schools by way of teaching, was the middle school principal for nine years. Two years ago he took over as the high school/middle school principal when Watts retired. This is his first year as the K-12 principal. "It's a learning process," Allison said. "I'm learning the difference between the needs of students and teachers in each building - and they are completely different."

When Allison is in the elementary school he has lunch with students. "I talk to them and ask them what their interests are and get to know them and they get to know me so they can feel like they can talk to me," he said.

O'Connor said he has a lot to learn, but the familiarity of being in a district where he knows students, teachers, staff, parents, and procedures and policies is extremely helpful. "I think it's gone very well so far. It's a big learning curve for me so far. I feel like a sponge. My goal is to stay on my toes and educate myself on what we are doing. We have such an awesome staff that does everything very well and I'm sure breaking in a rookie principal hasn't been that bad... I'm pretty lucky in that regard."

"I'm getting to know the 350 kindergarten through sixth grade students better... that has been one of the rewarding aspects of this position - to see that part of the education process up close. Here, at the high school, we see the 'end product' so to speak. The elementary school is the beginning of the process," O'Connor said. "I think having Terry and I involved in (all of the aspects of) the K-12 system is good for the school district. We will have the whole picture of a student's academic career."

Both Allison and O'Connor encourage parents and guardians to attend Family Night, which will be held each month throughout the school year. This month's event is Wednesday, Sept. 26. It will start with a free pasta dinner for parents and students in the high school cafeteria at 5 p.m. At 6 p.m. there will be a discussion on standard based learning and at 7 p.m. there will be a district parent involvement meeting. Daycare services will be available for younger children. For more information, call (989) 736-8534.

looked at alternative models to provide the same educational experiences and support," Thornton said.

Brenton Holcomb, superintendent of Alpena Public Schools echoed Thornton's assessment. "We've been talking about this for a year or two. Our main focus is on student achievement. Field trips to Sprinkler Lake ran \$250 to \$300 per day. Last year (Alpena schools) took 16 field trips to Sprinkler Lake. It also took time away from the classroom. We are being graded by legislature on things done in the classroom. I love Sprinkler Lake, but more support in math was needed inside the classroom."

Wilmot stated last year expenditures at Sprinkler Lake were just under \$54,000, and due to continued decline in utilization of the facility, that figure was the smallest annual expenditure since AMA ESD became the fiscal agent.

"At least \$1 million has been spent over the last 10 years to repair the physical facility and update dorm rooms with thousands being spent on educational materials such as microscopes," Wilmot said.

The Friends of Sprinkler Lake Education Center, a diverse group of 54 volunteers and educators, developed a nonprofit organization about three years ago to promote and support SLEC for students and the community.

"We've invested immense hours maintaining the property and have held fundraising auctions to help support transportation and youth summer camp scholarships. It is very sad and we are disappointed the facility has been suspended," said Jack Guy, a member of Friend of SLEC.

Each spring Friends of SLEC gather to dust off displays, rake leaves, pick up fallen branches, and dig out beaver dams to ready the grounds for nearly 8,000 students.

The Friends group is also instrumental in keeping Na-

ture Fest, an annual open community day of educational speakers with hands-on instruction to reach all age groups. "We no longer have access to the facility without supervision provided by the AMA ESD," Guy said. "Due to restrictions on time when the (volunteer) supervision is available we have made the decision not to have Nature Fest this year."

Wilmot said, "It is unfortunate for Friends of Sprinkler Lake to decide against holding Nature Fest this year. We did try to work with them. There is no district resources available for funding community events at the site and the district must make sure the contents are secured."

The AMA ESD is planning alternate solutions to provide students and teachers with curriculum instruction and programs similar to those held at the Sprinkler Lake site without children leaving their classroom. "We are excited the revised instructional delivery will allow Sprinkler Lake staff to travel to each of our districts to provide instruction on a more regular basis. Not only will this be more cost effective, it will preserve instructional time by eliminating lost time due to travel and increase the Sprinkler Lake faculty's ability to reach the maximum number of learners," Thornton said.

According to Wilmot, the AMA ESD's primary focus is to serve and support student achievement in districts including Alcona Community Schools, Alpena Public Schools, Atlanta Community Schools, Hillman Community Schools and the Bingham Arts Academy.

"It is our intention to maintain the integrity of the structures at the site. It is yet another unfortunate casualty of lack of educational funding. We will be evaluating the suspension annually. We would love to see the state or even find local funding to keep it open, but we must address the direct needs of our schools first," Wilmot said.

## How to save on prescription eyeglasses

Dear Savvy Senior,  
What tips or resources can you recommend to help seniors with the high cost of prescription eyeglasses? I used to have vision insurance through my work, but lost it when I retired.

Need New Specs

Dear Specs,

There's no doubt that new eyeglasses can be expensive. You can easily spend \$200 for a basic pair, and if you spring for add-ons like anti-glare lenses or designer frames the price can double. If you're like most retirees, and are paying full out-of-pocket prices every time you get a new pair of glasses, here are a few strategies that can help you save.

Depending on the amount of vision care you use in a year, one way to cut your overall costs could be to buy a standalone vision insurance policy, or a discount plan which could save you 20 to 60 percent at participating retailers. Most insur-

ance policies run around \$120 to \$190 a year for individuals, while discount plans cost between \$95 and \$155 per year and usually provide discounts on both vision and dental, and sometimes prescription drugs. You can find both plan types at ehealth-insurance.com.

Or, if you're a current or soon-to-be Medicare beneficiary, you may want to consider a Medicare Advantage plan. These are government approved, private health plans (usually HMOs and PPOs) sold by insurance companies that you can choose in place of original Medicare - which does not cover eyeglasses (unless you've just had cataract surgery) or routine eye exams. Many Advantage plans offer vision care, in addition to their health care coverage. See [www.medicare.gov/find-a-plan](http://www.medicare.gov/find-a-plan) to research this option.

Shopping and comparing prices from discount retailers and eye doctors' offices in your area that sell prescrip-

tion glasses is another key way to save.

Costco is considered by Consumer Reports as the best discount store for good eyewear and low prices, and you don't have to be a member to use them. Walmart and America's Best Contacts & Eyeglasses offer bargain prices too.

Also ask about discounts. Many retailers provide discounts to membership groups like AARP and AAA. AARP members, for example, can get 30 percent off a pair of prescription eyeglasses as well as discounts on eye exams at any LensCrafters, most participating Pearle Vision, Sears Optical, Target Optical, JC Penney Optical and thousands of private optometrist offices.

Buying glasses online is another way to save big over traditional retail stores. Some online stores like zenioptical.com, goggles4u.com and eyebuy-direct.com sell prescription eyeglasses for as little as \$7. Other good

sites that offer huge savings and selections include 39dollar-glasses.com, coastal.com, framesdirect.com, justeye-wear.com and warby-parker.com.

Most of these sites will also let you do virtual try-ons. This lets you upload a picture of yourself, and the site simulates what you'd look like in different frames.

To purchase glasses online you'll need your prescription and pupillary distance from an exam, and your frame size (check the inside of an old pair).

If your income is low, depending on where you live, there may also be some local clinics or charitable organizations that provide free or discounted eye exams and eyeglasses. Put in a call to your local Lions Club to see what's available in your area. To reach your local club, visit [directory.lionsclubs.org](http://directory.lionsclubs.org) or call your local chamber of commerce.

You may also be able to get free eyeglasses through New



Eyes for the Needy or the OneSight program. New Eyes for the Needy ([neweyesfortheneedy.org](http://neweyesfortheneedy.org), (973) 376-4903) is a nonprofit volunteer organization that provides free eyeglasses through a voucher program to people in financial need.

And OneSight ([onesight.org](http://onesight.org), (888) 935-4589), a creation of the Luxottica Foundation, provides free glasses at LensCrafters, Pearle Vision, Sears and Target to people who have a letter of sponsorship from a local nonprofit or charitable organization stating your need.



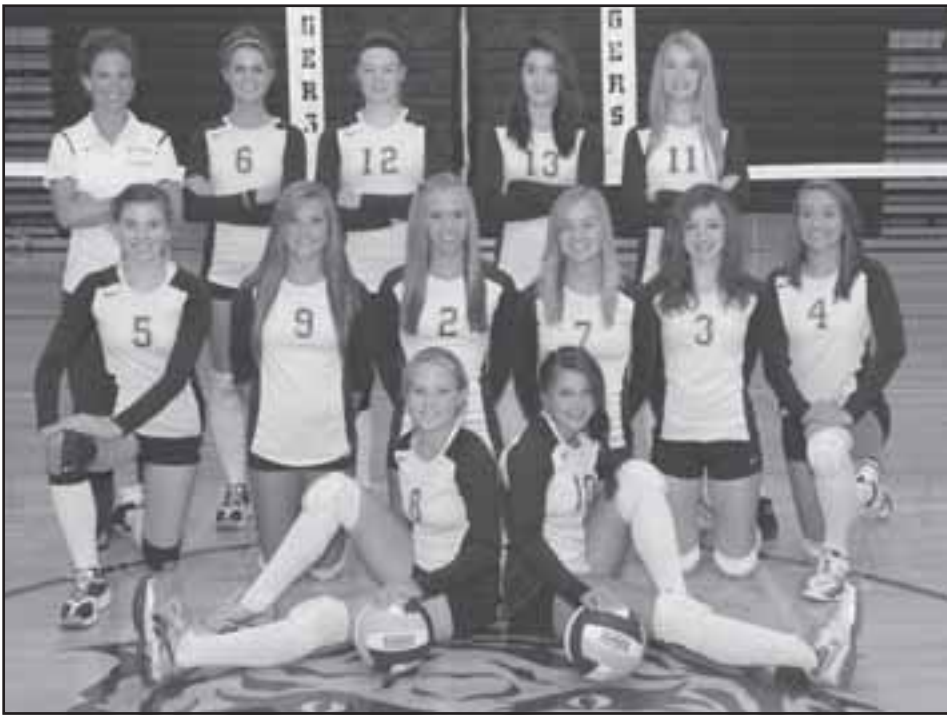

## Handicapping the chase

Attempting to pick the winner of the Chase for the Sprint Cup is a hazardous proposition. The format is designed more to create an exciting process than to produce a just winner.

No one would suggest that Tony Stewart's spectacular 2011 championship — not to mention the breathtaking competition with Carl Edwards — was undeserved, but Stewart somehow managed to step up his game in a way that few, including him, could have anticipated. After going winless in the season's first 26 races, Stewart won five of the final 10. Edwards lost by a tie-breaker after compiling the best average finish (4.9) in the history of the Chase. Edwards finished second in each of the final three races. Stewart won three of the final four and was third in the other.

"I couldn't predict it last year," Stewart said. "I wasn't good enough to predict it then. I'm not sure I'm going to be any better at predicting it now."

"All 12 guys have a shot, and a good shot, I think."

Here's one modest attempt to set the odds. Each driver has a one-in-12 shot.

—Brad Keselowski 10-1. He's poised to give Dodge its last hurrah.

Richmond with a fourth-place finish.

—Greg Biffle 12-1. He doesn't lead the points now because he has only two victories, but winning the regular season counts ... a little.

—Jeff Gordon 12-1. He made it, and now he's going to have to be reckoned with. His average finish in the past three races is 2.33.

—Clint Bowyer 15-1. The most recent winner must avoid the occasional disaster. He finished outside the top 25 four times during the first 26 races.

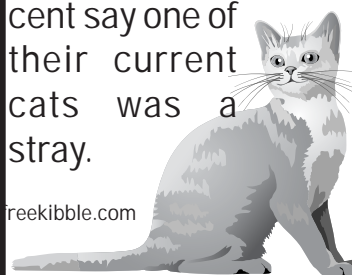

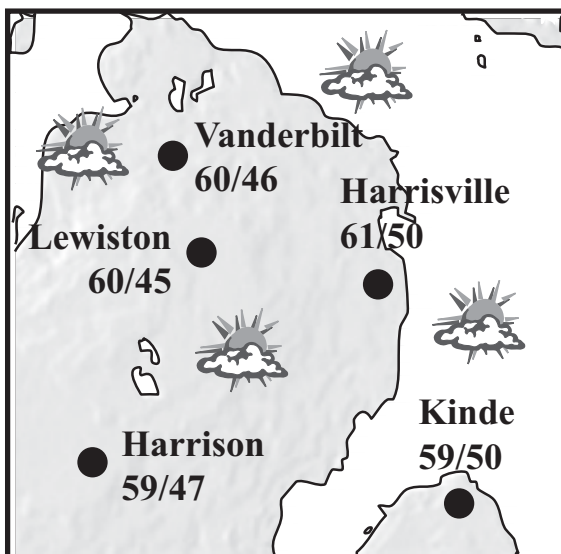

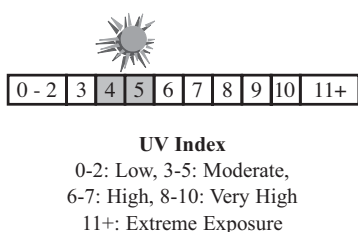

### StarWatch By Gary Becker - Goodbye Summer, Hello Fall

As much as I hate to admit it, autumn is not just around the corner, but it officially arrives on Saturday, September 22, at 10:47 a.m. Already I have seen that first big push of cooler, drier air heralding the fall season invade the mid-Atlantic. Saturated turquoise skies by day have given way to crisp, chilly evenings after sundown. Astronomically, we are in the biggest downward shift of the year with the sun headed southward at an accelerated pace causing the days to shorten and the nights to lengthen at their fastest rate. Depending upon where you live in the continental US, the amount of daytime lost since the high solstice sun of June 20 has been between two and three hours. Currently at the autumnal equinox, when the days and night are of equal length, we are in the middle of that downward spiral with another two to three hours of sun to lose before the long nights surrounding the time of the winter solstice on December 21. My Moravian College students are watching this transition right now, by climbing to the third floor rooftop observatory of the Collier Hall of Science and watching the sun set against the jagged horizon of trees visible from that vantage point. What they are noticing is a sun that is setting ever farther to the south in a relentless march towards the other extreme of winter solstice when the sun touches the zenith along the Tropic of Capricorn. In June the sun strode over the Tropic of Cancer, 23.5 degrees north of the equator. Now it is on the equator, and six months from now, Sol will be over the Tropic of Capricorn at 23.5 degrees south latitude. That is a 47 degree change in the position of the sun over the course of a year, a condition attributable to the 23.5 degree axial tilt of our planet's axis to the perpendicular of its orbital plane. So say goodbye to summer and hello to fall, and just for the record, I'm not looking forward to the winter's snows. [www.astronomy.org](http://www.astronomy.org)

### MOMENTS IN TIME The History Channel

• On Oct. 6, 1847, "Jane Eyre," a book about the struggles of an orphan girl who grows up to become a governess, is published. Charlotte Bronte, the book's author, wrote of her experiences at being sent to a boarding school at the age of 5.

• On Oct. 1, 1920, Scientific American magazine reports that the rapidly developing medium of radio soon would be used to broadcast music: "Experimental concerts are at present being conducted every Friday evening from 8:30 to 11:00 by the Radio Laboratory of the Bureau of Standards."

• On Oct. 5, 1930, a British dirigible crashes in Beauvais, France, killing all 56 people aboard. The R-101, Great Britain's biggest blimp, was flying only 250 feet above the ground, unbeknownst to the pilots because of the dark night. The blimp skimmed treetops before hitting a ridge, igniting the hydrogen supply.

• On Oct. 4, 1944, Gen. Dwight D. Eisenhower distributes to his combat units a report by the U.S. Surgeon General that reveals the hazards of prolonged exposure to combat. Based on this evaluation, American commanders judged that the average soldier could last about 200 days in combat before suffering serious psychiatric damage.

• On Oct. 2, 1968, St. Louis Cardinals pitcher Bob Gibson strikes out 17 Detroit Tigers in the first game of the World Series, breaking Sandy Koufax's record for the most strikeouts in a Series game.

An FBI investigation of Lennon had turned up no evidence of involvement in illegal activities.

• On Oct. 3, 1995, Heisman Trophy winner O.J. Simpson is acquitted of the double murder of his estranged wife, Nicole Brown Simpson, and her friend, Ronald Goldman, despite a DNA match, a wound on Simpson's hand, the recent purchase of a "Stiletto" knife and matching shoeprints at the scene.

## CITY OF HARRISVILLE MINUTES

The regular meeting of the Harrisville City Council was held on September 10 at the city office. The meeting was called to order at 7 p.m. by Mayor Dobis and the "Pledge of Allegiance" was said. Present: Mayor Dobis, clerk Pierce, council members Tartaglia, Sanderson, Kaiser, Crick, Lemere and Baird, and city attorney Cook. Absent: Treasurer Keerl.

Motion by Crick, support by Lemere, to approve the August 13 minutes. Motion carried 6-0. Motion by Lemere, support by Kaiser, to pay the bills in the amount of \$14,569.81. Motion carried 6-0. Mayor Dobis shared a letter from the Alcona girl's volleyball team thanking the city for its cooperation which helped to make the 5K run on August 18 a success. The team is looking forward to holding the 5K run again next year.

The bid selection for the mapping of the city water and sewer utilities, to meet state DEQ requirements, was presented by council members Baird and Lemere. Eight bids were reviewed by Baird, Lemere and Mayor Dobis and presented to city council. The City of Harrisville requested that all bidders submit separate bids for the mapping of the water and sewer System, separate bids for the mapping of sewer lines and storm sewers and separate bids for the evaluation work on the drainage problems, together with a single bid to perform all of the work addressed above. Bidders were also requested to evaluate the drainage issues on Adams Street as well as a suspected, existing, drainage problem on Church Street, from US-23 to Lake Street and down the adjacent southerly flow of First and Second streets.

The bids ranged in price from \$18,300 to \$48,400. Council members Baird and Lemere recommended council accept the proposal from Wilcox Engineering for \$28,000. Motion by Baird, support by Lemere, to approve

the selection of Wilcox Engineering as the contractor to do all work per the advertised bid. A roll call vote was taken. Ayes: Six. Nays: Zero. Motion carried 6-0.

The Labor Day weekend appears to have been a huge success with reports that many vendors had a very profitable weekend. "Let's Move Initiative" was introduced by KiAnn Kruttlin and Judy MacNeill. "Let's Move" is part of a nation wide initiative, proposed by First Lady Michele Obama, to raise our children to be as healthy as possible. Kruttlin and MacNeill asked that the City of Harrisville agree to accept the initiative and with support from council, become a designated "Let's Move" city. Motion by Baird, support by Lemere, to approve the City of Harrisville as a "Let's Move" city. Motion carried: 6-0. Council member Crick will be the liaison from the city. Fall cleanup and hydrant flushing schedule is as follows: Hydrant flushing: October 2-5. Fall cleanup: September 28 and October 26.

Reports: Mayor Dobis reported that five concerts were scheduled for the Summer Concert Series. Each concert cost \$500. The total cost of the series, with one weather cancellation, was \$2,000.00. With generous, private contributions and audience free will donations, the total amount collected was \$1,349.17 for the series. The city posted a loss of \$650.83. Council member Tartaglia, harbor com-

mission representative, reported that cash revenue is up and the budget of the harbor is on schedule for the loan payment to the city. Expenses are down and dockage reservations are down 70 percent.

Council member Baird reported that the planning commission will meet the first Tuesday of October and that the remaining chapters of the draft of the new zoning ordinances are scheduled to be reviewed. Airport commissioner Boucher reported that the party flying model airplanes at the airport was informed that flying model planes is not legal at the airport. Party was notified of a model airplane club in Mikado. Beautification Committee chairperson Trimmer discussed the need for repair and access to the city water fountain at Lake Street and Main Street. The city will look into future plans for the fountain.

Council last comments: Council member Kaiser expressed concerns regarding use of the city maintenance yard. A private contractor may use the yard to dispose of yard waste from a city resident who has hired the contractor, and then only if said contractor has received permission from the city to do so. Lemere moved the meeting to be adjourned. Meeting adjourned at 8 p.m.

The keynoter of the Republican convention, Governor of New Jersey, Chris Christie, recently said, "The war on drugs, while well-intentioned, has been a failure. We're warehousing addicted people everyday in state prisons in New Jersey, giving them no treatment."

In a survey by the National Association of Chiefs of Police, 82 percent of police chiefs and sheriffs said the 40 year "war on drugs" has **not** been successful in reducing drug use. (National Association of Chiefs of Police - 2005)

Tens of billions of dollars wasted on interdiction efforts. Millions of young Americans incarcerated and labeled for life, costing our economy billions more.

Despite over \$7 billion spent annually toward arresting and prosecuting nearly 800,000 people across the country for marijuana offenses in 2005 (Uniform Crime Reports), the federally-funded Monitoring the Future Survey reports about 85% of high school seniors find marijuana "easy to obtain."

That figure has remained virtually unchanged since 1975, never dropping below 82.7% in three decades of national surveys.

## THERE IS A BETTER WAY

Elected leaders and law enforcement officials around the country are recognizing that multi-jurisdictional narcotics teams have not solved the problem. This is why the Charlevoix County Sheriff's Office recently pulled out of SANE (Straits Area Narcotics Team). Undersheriff Chuck Vondra told the press, "We don't want to fill our jail with drug dealers. We want to fix the problem. That starts in the family and the community."

What does work, as we know from our economic system, is focus on the demand side. An effective war on drugs seeks to change the behavior of the consumer through education and rehabilitation. Sadly, according to the federal government, 23.5 million Americans are in need of substance abuse treatment, but only 1 in 10 receive it.

In Alcona County, the path to a better way starts with reallocating our resources to support Local Police, a Youth Outreach Officer, and our Drug Court by again defeating the HUNT tax.

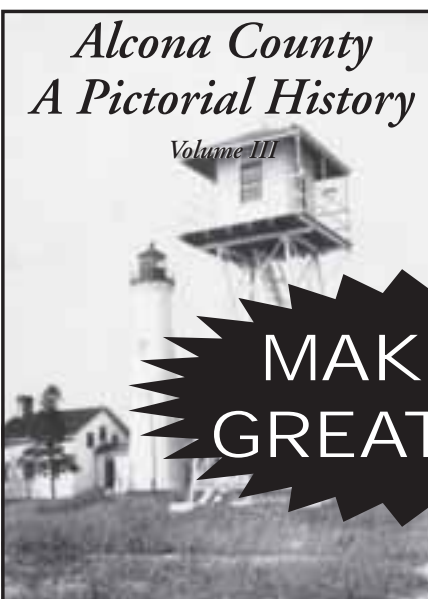

### CALEDONIA TWP. ORDINANCE

#### Caledonia Township Ordinance No. 2012-01

Ordinance Addressing Floodplain Management Provisions of the State Construction Code  
Community Name: Caledonia Township.  
County: Alcona  
Ordinance number: 2012-01  
An ordinance to affirm an enforcing agency to discharge the responsibility of the township of Caledonia located in Alcona County, and to designate regulated flood hazard areas under the provisions of the State Construction Code Act, Act No. 230 of the Public Acts of 1972, as amended.

The township of Caledonia ordains:  
Section 1. Agency designated. Pursuant to the provisions of the state construction code, in accordance with Section 8b(6) of Act 230, of the Public Acts of 1972, as amended, the building official of the county of Alcona is hereby designated as the enforcing agency to discharge the responsibility of the township of Caledonia under Act 230, of the Public Acts of 1972, as amended, state of Michigan. The county of Alcona assumes responsibility for the administration and enforcement of said act through out the corporate limits of the community adopting this ordinance.

Section 2. Code appendix enforced. Pursuant to the provisions of the state construction code, in accordance with Section 8b(6) of Act 230, of the Public Acts of 1972, as amended, Appendix G of the Michigan Building Code shall be enforced by the enforcing agency within the township of Caledonia.

Section 3. Designation of regulated Flood Prone Hazard Areas. The Federal Emergency Management Agency (FEMA) Flood Insurance Study (FIS) Entitled Alcona County, MI-All jurisdictions and dated September 28, 2012 and the Flood Insurance Rate Map (FIRMS) panel number(s) 26001C, 0050D, 0075D, 0100D, and 0125D and dated September 28, 2012 are adopted by reference for the purposes of administration of the Michigan Construction Code, and declared to be a part of Section 1612.3 of the Michigan Building Code, and to provide the content of the "Flood Hazards" section of Table R301.2(1) of Michigan Residential Code.

Section 4. Repeals. All ordinances inconsistent with the provisions of this ordinance are hereby repealed.

Section 5. Publication. This ordinance shall be effective after legal publication and in accordance with the provisions of the act governing same.

Adopted this 12<sup>th</sup> day of September, 2012. This ordinance duly adopted on September 12, 2012 at a regular meeting of the Caledonia Township Board and will become effective October 12, 2012.
