

## Missing teenager found after 12-hour, night search

Whatever plans a Glennie family had for Christmas dinner and Christmas evening – they were postponed for almost 12 hours when one of their family members – a 15-year-old male – went missing.

On Tuesday, Dec. 25, 2012 law enforcement personnel from three counties spent many hours searching for the teenager in one of the most remote locations on the southwestern boarder of Alcona and Iosco counties.

According to Sgt. Keith Myers, the call reporting the missing teenager came into the Alcona County Sheriff's Department at 5:12 p.m. on Christmas. From there several other contacts were made to call in assistance. Michigan State Police Trooper (MSP) Jamie Bullis, a canine handler from the Alpena post, Michigan Department of Natural Resources (DNR) Conservation Officer Warren MacNeill, a trooper from the MSP East Tawas post, an officer from the Oscoda Township Police Department, several Alcona County deputies and Sgt. Myers were able to aid in the search.

Myers was the first officer to talk with the teenager's family (because the person involved is a minor, his name will not be released). The teenager, who was from the Detroit, Mich. area, was with his mother and stepfather at a cabin on Camp Ten Trail in Curtis Township. They purchased the cabin on Labor Day weekend and the teenager had only been to the cabin on two occasions.

Myers learned from the family that around 2:30 p.m. the teenager left the cabin for a walk. When he didn't return, they started looking for him. "The stepdad was walking in the woods (behind the cabin) and the mom was on a 4-wheeler riding along the roads looking for him," Myers said. "The step-dad followed footprints through the woods to a narrow trail that led to Bissonette Road, then they went roughly four and a half miles along Bissonette Road to near the intersection of Forest Service Road 2002 (in Iosco County).

When Trooper Bullis and his canine partner, Marshall, arrived they began following what was believed to be the teenager's tracks, which eventually "took me south on

a two-track about a quarter of a mile (off of Bissonette Road) to a gate that was locked," Bullis said. "Because there was no disturbance in the snow, I took (Marshall) off the track."

There was some discussion among searchers about whether the tracks could be from the teenager – especially since they were such a distance from where he started.

There was also concern that he could have been abducted or had run away. "At that point we had to consider all possibilities," Myers said.

"Statistically, someone who is lost rarely travels more than a mile from where they started," Bullis said. "Usually it's a half a mile. Typically, people walk toward water because of the slope of the ground – it's the path of least resistance."

In an effort to ensure the

tracks were from the missing teenager and to make sure he wasn't still in the woods around the cabin, Bullis decided to start from the beginning. He went back to the cabin and began searching through the woods, along the trail about three quarters of a mile to Bissonette Road where the missing teenager's footprints were found.

"It took us a long time to

clear the woods behind the cabin," Bullis said. "The dad and two others, I believe, had previously been in the woods looking for him. Marshall had to work out which scent trail was the boy's. We were able to establish that he was lost, that he wasn't in the woods and he did come out to the road."

Prior to and during the time Bullis was establishing the

teenager's track, multiple actions were being taken. Myers explained he had DNR C.O. MacNeill searching the snowmobile trail and other trails in the area on a 4-wheeler. The trooper from the East Tawas Post, officer from the Oscoda Police Department and two deputies from Alcona County were searching areas that were easier to access. A Michigan State Police helicopter flew in from Lansing, Mich. to aid in the search as well.

When the helicopter arrived, according to Bullis, it conducted a grid search. It is equipped with infrared technology and can detect heat signatures from warm blooded animals. "There are a lot of small lakes in the area," Bullis said. "The helicopter was able to clear the lakes – the crew established that no one had fallen through the ice."

The area where the search was being conducted, according to MacNeill, Myers and Bullis, is sparsely populated and surrounded by national forest. Dense pine tree forest limited the helicopter's ability to search from overhead. It also made the ground search efforts difficult as well.

"We tried to cover as much ground as possible, because by that time it was dark," Myers said. And, they all hoped the teenager hadn't ventured into the thickly wooded area around the AuSable River... "When I got the call and heard where he was lost, I thought there couldn't be a worse place... Even during the day time there are places in there that are as dark as night."

"This is true wild land," MacNeill said. "If you get off that road you are in no man's land."

The search eventually expanded to M-65, roughly two miles from where the missing teenager's tracks came out near the intersection of Forest Service Road 2002. "If he'd made a right, instead of a left, he would have walked by a subdivision," Myers said, and eventually made it to M-65.

## Keeping winter outdoor recreation fun and safe

Outdoor recreation doesn't stop in the winter; for some folks, it intensifies. But because of weather conditions, going outdoors for fun in the winter can require even more attention to safety than at other times of the year.

A simple case of getting wet – or getting turned around in the woods – is much more significant when the thermometer reading is into the single digits.

Michigan Department of Natural Resources conservation officers remind snowmobilers, off-road vehicle (ORV)

riders, hikers, cross-country skiers and fishermen to pay close attention to safety as they pursue outdoor winter hobbies.

Their best advice? Make sure someone knows where you're going, what you're doing and when you'll be back.

"Always tell someone where you are going," said Cpl. John Morey, the DNR's off-road vehicle and snowmobile coordinator. "Tell them your planned travel route and expected time of arrival or return," he said. "Then, if someone is overdue,

whoever has the travel plan can contact 911 and give responders a chance to get out and look for them right away."

With nearly 6,500 miles of designated snowmobile trails – and more than 11,000 inland lakes that offer an appealing frozen surface during the winter – Michigan is one of the top destinations for snowmobile enthusiasts in the Midwest. And although ORVs are often thought of as fair-weather vehicles, they remain popular with some sportsmen who use them during all seasons to get to

backwoods hunting or fishing destinations.

The two modes of transportation are not always compatible. "Conflict arises when ORVs operate on a designated snowmobile trail," Morey said. "That is not permitted unless it's designated as an ORV trail as well. In most places, especially in the Lower Peninsula, snowmobile trails are snowmobile trails – not ORV trails."

Many – but not all – Upper Peninsula snowmobile trails are also designated ORV trails, Morey explained.

"It's the rider's responsibility to know whether where he's going is legal for his intended activity," he said. "Ensure the area in which you intend to operate your snowmobile or ORV is legally open to such activity."

Morey cautioned riders to make sure their machine is properly registered and that operators are properly licensed. "Anyone whose driver's license is suspended or revoked may not operate a snowmobile or ORV," Morey said. "Youngsters who are less than 17 must be under direct adult supervision (someone 21 years of age or older) to operate a snowmobile, unless they are in possession of a snowmobile safety certificate."

"And youngsters under 12 may not cross a road on a snowmobile."

Morey said that while most safety rules for snowmobile

## ARE YOU LOW INCOME AND NEED HELP PAYING YOUR RENT?

The Michigan State Housing Development Authority's (MSHDA) waiting list for the Housing Choice Voucher Program (previously termed Section 8), in Alcona County will be opened on January 14, 2013 at 8:00 a.m. EST for all applicants that qualify. The waiting list will remain open. Applications will be served on a first come-first served basis as funding becomes available.

MSHDA's Housing Voucher Program is a federally funded rental subsidy program that assists families in paying their rent. If you need assistance paying your rent, reside or work in Alcona County, your income falls within allowable limits, and the rental unit you choose to live in meets the Housing Quality Standards and rental limits set forth by the U.S. Department of Housing and Urban Development (HUD) you may qualify for the program. Proof of residency in Alcona County is required upon your name being drawn off the waiting list (see requirements below).

2. Social Security number
3. Date of birth

**Residency Documentation Requirements:** You must provide a **COPY** of proof of residency in Alcona County if you are placed on the waiting list and selected for rental assistance. By about 11 p.m. Myers was waiting on the MSP helicopter's arrival, Trooper Bullis was in the woods verifying tacks, MacNeill was checking remote locations on a 4-wheeler and other officers were checking cabins, houses and other buildings that were easier to access.

"At that point, I was looking at a lost kid or an abducted kid," Myers said. "I had guys looking at locations on M-65 - an old store, a cabin - he could have made it that far."

Myers also had the missing teenager's parents move to a point in Glennie where cell phone coverage was good (they had no coverage at their cabin) with all of the family's cell phones - in case anyone was trying to reach them and also to call the missing teenager's friends to see if they knew where he was - in case he'd run away.

At roughly, 2 a.m. on December 26, Myers called in Alcona County Sgt. Scott Stephenson to begin looking at the abduction angle. "My feeling was if he was abducted, I wanted to start looking at possible sex offenders in the area," Myers said.

With the helicopter having completed its search and off the search to refuel and a call to the Iosco County Search and Rescue Team to begin assembling to begin a search at daylight, officers gathered at the starting point around 2:30 p.m.

Discussion between Myers, MacNeill and Bullis kept coming back to the gate off of Bissonette Road where the teenager's footprints had "stopped." MacNeill said he would go back there.

"It was about a mile off of Bissonette Road on private property," MacNeill said of the location. The missing teenager's tracks did not appear to go beyond the locked gate. MacNeill walked in past the gate and picked up tracks - leading in several directions. "A set went off in one direction, then came back. Then went off into another direction and came back... there were several sets (of tracks) like this. I had to find footprints that went off, but that didn't have a return set," MacNeill said.

He eventually did. They led to a cabin with a utility shed nearby. As he was knocking and calling around the utility shed, MacNeill heard a voice call out.

It was the missing teenager. He had made a "sit-down nest" on the porch of

the cabin. He was very cold, MacNeill said, but uninjured. It was approximately 4 a.m. - roughly, 14 hours after he'd gone missing and approximately five miles from where he started.

"He told me he didn't (plan to) go for a walk," MacNeill said. "He was just throwing stones in the back yard and got turned around..."

After the reunion with his family, Myers interviewed the teenager. "He told me he purposely walked in snow so we could have found his footprints... He even took the tag off of his new winter jacket and left it near his footprints so we'd know it was him... We asked him why he didn't break in to the cabin. He said he didn't break in because he didn't want to get into trouble..."

Myers contacted the teenager's family downstate to see how he was doing on Sunday, Dec. 30 and the report was good. He had no physical problems following the ordeal.

Myers commended the efforts made by everyone in-

involved in the search. "It was a good team effort. I was doing the coordinating and did everything I could think of. Everyone out there - they were doing the physical work, the searching," Myers said.

Bullis, who had just returned to the area after a 14-week training program with his new canine partner, Marshall, was pleased with the two-year-old German shepherd's performance. This was his first official search as a MSP canine. He was also appreciative of the effort that went into the entire search. "Alcona County should be proud of its sheriff's department," Bullis said. "They had a lot of stick-to-it-ness."

MacNeill, who has been involved in countless missing person searches over his 22-year career with the DNR, was relieved the outcome was positive. "I may have missed my Christmas dinner, but that kid had breakfast with his parents that morning. What a cool present to give someone you've never met," MacNeill said.

and ORV riders are common sense, they bear repeating. For instance:

- Always wear a helmet.
- Slow down.
- Dress appropriately and wear proper safety equipment (gloves, boots, goggles, etc.).
- Keep your lights on.
- Stay to the right.
- Properly maintain your machine.
- Check the weather conditions.
- Only carry passengers if the machine is designed to do so.
- Carry basic safety and rescue gear – including a cell phone.
- Use the buddy system: always travel with someone else.

Although lakes are highly attractive to snowmobile and ORV users, people should never assume that ice is safe.

“Breaking through the ice is a common occurrence,” Morey said. “People go into areas where they are unfamiliar with the ice conditions, like in areas with current or under bridges where the ice is thinner. Don’t. Know what the ice conditions are and the only way to do that with certainty is to get out and check them for yourself.”

Morey said ice should be checked – on foot – as you make your way out. Avoid areas where the ice is discolored or there is vegetation or objects sticking up through it. Use a spud to punch the ice ahead of you (to make sure it is safe) as you walk and carry a rope in case someone should break through. It is also recommended that anglers carry spikes – usually encased in wood or plastic cylinders for handles – so they can grasp the ice with them should they break through.

Breaking through the ice into freezing water is an extremely serious situation. Anyone who finds himself immersed in icy water must

- Get his head above the surface immediately, get breathing under control and attempt to breathe normally, and work on getting out.

- Get to good ice – gener-

ally in the direction from which you came – and get your arms up on the ice.

- Use your arms to pull your upper body onto the ice while you kick your legs – in a swimming motion. (This is where ice spikes help greatly.)

- If you can get out, initially roll or crawl along the ice – do not get back on your feet right away – ensure you are on safe ice, and then immediately walk toward heated shelter.

- If you are unable to get out, reach out as far as you can, hold on, and yell for help.

If you see someone fall through the ice, make sure you do not put yourself at risk when attempting to assist them. “Call 911 immediately,” Morey said.

When attempting to reach someone who has fallen through the ice, distribute your body weight by lying on the ice and toss a rope or reach for them with a pole, branch stick or ladder, which works very well. Do not compound the problem by breaking through the ice yourself.

Morey said there’s no need for Michiganders to hibernate all winter. “Outdoor recreation can be enjoyable, invigorating and fun, but for it

to be any of those things,” he said, “it must also be, first and foremost, safe.”

## How to locate discounts if you're 50 or older

I just turned 50 and would like to know what resources you recommend for locating senior discounts.

Dear Love,

One of the great perks of growing older in the U.S. is the many discounts that are available to boomers and seniors. If you don't mind admitting your age, here are some tips and tools to help you find them.

The first thing to know is that not all businesses advertise them, but many give senior discounts just for asking, so don't ever be shy to ask. You also need to know that while some discounts are available as soon as you turn 50, many others may not kick in until you turn 55, 60, 62 or 65.

Because senior discounts are constantly changing and can vary greatly depending on where you live and the time of the year, the Internet

is one of your best resources for locating them.

To get started go to Senior-Discounts.com, a massive website that lists more than 250,000 discounts on a wide variety of products and services like airlines, car rentals, travel, recreation, local transportation, shopping, restaurants, hotels, state and national parks, medical services, pharmacies, museums and more.

You can search for discounts by city and state or ZIP code, or by the category you're interested in, for free. Or, for \$13 you can become a premium member and get additional, select discounts.

Another great website for locating 50-and-older discounts is Sciddy.com. Launched in 2011, this site also lets you search for free by city, state or ZIP code, as well as by business or category.

Another good avenue to senior discounts is through membership organizations

like AARP, which offers its 50 and older members a wide variety of discounts through affiliate businesses (see discounts.aarp.org). Annual AARP membership fees are \$16, or less if you join for multiple years.

If, however, you're not a fan of AARP, there are other alternative organizations you can join that also provide discounts such as The Seniors Coalition or the American Seniors Association. Or, for federal workers, there's the National Active and Retired Federal Employees Association.

Here's a brief rundown of some of the different types of discounts you can expect to find.

- **Supermarkets:** Many locally owned grocery stores offer senior discount programs, as do some chains like Kroger, Publix and Fry's which offer some discounts on certain days of the week but they vary by location. You'll need to ask.

- **Retailers:** Many thrift stores and certain retailers like Kohl's, Bealls, Dressbarn and Ross Stores offer a break to seniors on a certain day each week.

- **Travel:** Southwest Airlines provide by far the best senior fares in the U.S. to passengers 65 and older, while Amtrak offers a 15 percent discount and Greyhound offers five percent off to travelers over 62. And, most hotels in the U.S. offer senior discounts, usually ranging from 10 to 30.

- **Car Services:** If you're renting a car, most car rental companies provide discounts to customers who belong to organizations like AARP. And some Jiffy Lube and Midas service centers offer discounts to seniors for auto repair and maintenance.

- **Restaurants:** Senior savings are common at restaurants and fast food establishments, ranging from free coffee, to drinks, to discounts off your total order. Chains

known for their senior discounts include McDonalds, Wendy's, Burger King, Applebees, Arbys, Chilis and Friendly's.

- **Entertainment:** Most movie theaters, plays, ballets, symphonies, museums, zoos and aquariums provide reduced admission to seniors over 60 or 65. And seniors over 62 are eligible to get the "America the Beautiful - Senior Pass" for \$10, which provides a lifetime of free access into all national parks and federal recreational lands.

"We played like I had hoped we wouldn't play after a 13 day layoff. We got off to a slow start and Hillman kept the pressure on us all night. Our guard pressure and fast break was the key to this win," said Coach Brad Cole.

Alcona was led by junior Megan Quick with 19 points and five steals. Karina Cole added 16 points, four assists, eight steals and eight rebounds. Kendra Cole had 10 points and nine rebounds. Freshman Sydney Pierce

scored five points, Nikki Smith and Nicole Walen each added two points and Cassie Carpenter scored one point for Alcona.

Alcona's girls junior varsity team also defeated Hillman 43-26. The JV team was led by Katelyn Nelson with 12 points. Torie Harmon and Sam Schopher scored 11 points each. Both the varsity and JV girls' teams are 3-1 in the regular season.

The Tigers will travel to Alma High School on Thursday, Jan. 3 with tip off for the JV girls starting at 4:30 p.m. and varsity will take the court at 6 p.m.

Due to a snow storm that hit later in the week the games against Alpena High School on December 20 and Montabella High School on December 22 were canceled due to poor weather/traveling conditions and are expected to be rescheduled at a later date.



## State police warn residents of texting scam

The Michigan State Police, Alpena Post is warning area residents to be aware of a widespread cellular telephone texting scam. According to Lt. Mike Hahn, citizens began receiving a text message on Wednesday, Dec. 26, 2012 and that it is clearly a type of phishing scam.

The text message, "AAA CU

Notice: Your card 4235XX has been deactivated. Please call (989) 244-5373," is designed to get people to call the provided telephone number, thinking that one of their credit cards has been erroneously deactivated, Hahn explained.

"AAA Credit Union is a made up financial institution

(not affiliated with Alpena Alcona Area Credit Union) and the number 4235XX is a random number that shouldn't coincide with anyone's actual credit card," Hahn said. "Once they get a caller on the line, the persons attempting to defraud citizens will attempt to get the caller to reveal informa-

tion about their actual credit card number, expiration date and credit union. Once they have that information they can begin using the victim's card to make purchases."

Hahn said, anyone who has called the number and revealed information about their actual credit card(s), credit union and personal information numbers and/or codes should contact the credit institution(s) that issued the card(s) and cancel them immediately.
