Local writer, community leader passes away suddenly

Family, friends and members of the community are reeling from the sudden death of Kathryn F. Kniep, a Harrisville native and lifelong resident who was a popular columnist, writer and community leader.

Kathryn - "Kay" to her friends and "Katie" to everyone who grew up with her or watched her grow up - was born on November 5, 1951 to Harrisville residents Benno and Ellen (Walraven) Fritz and joined older brothers Patrick and Michael. Her parents owned the local grocery store on Main Street, where she spent quite a bit of time as a young girl and teenager. Through her parents' interaction with their customers Kay developed an appreciation for the diversity of people in the community and fostered a lifelong dedication of speaking out for and helping individuals in need.

She graduated from Harrisville High School in 1969 and attended Saginaw Valley State University. She studied English and received an associate degree from Alpena Community College.

She met Arthur H. Kniep while he was stationed at Wurtsmith Air Force Base in Oscoda. They met on a blind date which was spent at a pizzeria in Alpena. It was a whirlwind romance and after a few months, they were married on October 5, 1975 at their home on Dock Street in

Harrisville. Their daughter, Katrina, was born on October 13, 1978.

In the late 1970s and early 1980s Kay worked for the HeadStart preschool program as a teacher. She also spent several years as a staff writer for the Alpena News until the All Alcona Almanac was conceived. Kay, her husband Art, her brother Patrick "Benno" Fritz and her sister-in-law Jane Fritz started the weekly newspaper in 1981. They worked out of the building next to the then Alco Theatre on Main Street in Harrisville. She served as the editor, a writer, office girl and anything else that needed to be done until the paper folded in 1983.

Kay's weekly column, "Puttin' on the Fritz," began appearing in the Alcona County Review in the mid 1980s and included her observations, perspectives and personal experiences in a small town. Through this column Kay wrote about the people, places and events that made life unique. Her personal life was included in the column and everything was fair game - her daughter "the Princess," the antics of family pets, the trials and tribulations of married life, people she loved and the "adventures" that transpired over time.

Periodically, she also used that forum to talk about issues and events that had local, statewide or national implications. Her opinion and

views, while clearly stated, were tempered with the understanding that not everyone would agree with her and the encouragement to understand an alternative point of view. Her last column was published on May 7, 2014.

In addition to her weekly column, Kay wrote news sto-

ries for the Review, and also wrote poetry, short stories and nonfiction in a variety of venues. One of her short stories was published in the first edition of "Voices of Michigan," an annually published book that features writers and poets from around the state.

Kay's writing skills were

also put to good use in the public sector during her time at Northeast Michigan Community Service Agency (NEMCSA) from 1986 to 2000. She was a grant writer in the community service division where she worked with

Camping trip includes eagle encounter

A redirected camping trip turned into more of an adventure than a downstate couple had planned last weekend.

Roger and Christine Hayslip of Sumpter Township, Mich. (near Ypsilanti, Mich.) regularly camp at Jewell Lake and were planning to do just that last weekend. However, when they arrived at the campground it wasn't open for the season. Disappointed, they were heading home when they saw a sign for the Horseshoe Lake campground (located just northeast of Alcona Pond) in Millen Township. They decided to check it out.

After deciding that it was a good alternative, they set up camp. On Saturday morning they were hiking with their two black Labrador retrievers when the dogs noticed a large bird on the ground. "It

was an eagle and as one of the dogs ran toward it, it hoped way. It couldn't fly. It was dragging its wing," Roger Hayslip said.

They took the dogs back to their camper and returned to where the eagle was on the ground. They decided to try to get help for it. They threw a blanket over it and Roger carried it back to their camper. "They are a lot stronger than I thought... I carried it like a chicken," Hayslip said.

"This was a once in a lifetime experience," Hayslip said.

Back at their camper they put it in the bathroom and made a call to the Michigan Department of Natural Resources (DNR) Report All Poaching (RAP) line. That triggered a call to Alcona County DNR Conservation Officer Warren MacNeill who drove to the campground around noon. "When I first opened

the door it was sitting on the toilet, then it jumped up on the sink and was looking at itself in the mirror," MacNeill said.

He retrieved a wool blanket from his truck (kept there for recovering bald eagles) and put it over the eagle, "swaddled" it and put it in the passenger seat of his patrol vehicle. "When you swaddle or throw a blanket over them, they go docile," MacNeill said.

He drove to Rose City, Mich. to meet with a licensed wildlife rehabilitator from Association to Rescue Kritters (A.R.K.) which is based near Houghton Lake, Mich. "It was an uneventful trip and exchange," MacNeill said.

Ruth Fruehauf, executive director of A.R.K., met MacNeill and took the bird to meet up with a veterinarian from West Branch, Mich. that treats wild animals. After the

Kathryn F. Kniep

Kathryn Faith Kniep, 62, of Harrisville died on Sunday, May 11, 2014 at St. Mary's Hospital in Saginaw, Mich.

She was born November 5, 1951 in Harrisville to Benno and Ellen (Walraven) Fritz. She was raised in Harrisville and graduated from Harrisville High School in 1969. She attended Saginaw Valley State University and received an associate degree in the English curriculum from Alpena Community College.

She married Arthur H. Kniep on October 5, 1975 at their home on Dock Street in Harrisville.

Mrs. Kniep worked for several years with the HeadStart preschool program in the late 1970s and early 1980s. She was a staff writer for the Alpena News for several years before starting the All Alcona Almanac, a weekly newspaper in Harrisville, with her husband Arthur, brother Patrick Fritz and sister-in-law Jane Fritz. She was a writer and editor for the publication from 1981 to 1983.

In the mid-1980s she began writing the column "Puttin' on the Fritz" for the Alcona County Review. She also contributed many news stories, in addition to her weekly column, over the last 18 years writing for the Review. She was an accomplished writer who published fiction, nonfiction and poetry in several venues.

Mrs. Kniep was a grant writer for the community service division of Northeast Michigan Community Ser-

vice Agency (NEMCSA) from 1986 to 2000. She was the administrative assistant for Weiner & Burt Law Firm of Harrisville from June 2000 to 2005, when she retired.

She was a lifelong member of St. Andrew's Episcopal Church in Harrisville and was a member of the vestry, editor of the church newsletter and hostess for coffee hour for numerous years. She was the clerk for the City of Harrisville for many years. Mrs. Kniep was on the Alcona Community Schools Board of Education from 1994 to 2006 and was the president of the board for many years during her tenure.

In 2003 she became board member for the Harrisville Depot Preservation Group and published a children's book entitled "The Dragon that Lives at the Depot." She was a board member for Alcona Local Foods Association (ALFA) for several years and was a member of the local chapter of the post-polio support group. She was also the lead singer for the Sunrise Jammers, a group of local musicians who performed in the area for several years in 2000s.

She enjoyed reading, writing, gardening, crafts, singing, walking along the beach of "Lady Huron" and spending time with her family, extended family and numerous friends.

Mrs. Kniep is survived by her husband, Arthur; one daughter, Katrina (A.J.) Wouters of Harrisville; one granddaughter, Phoenix Wouters; one step grandson, Kaiden Wouters; one brother,



Michael (Virginia) Fritz of Harrisville; and one sister-in-law, Jane White of Harrisville.

She was preceded in death by her father on November 15, 1978; her mother on July 22, 1980; and one brother, Patrick Fritz, on January 19, 2002.

Visitation will be Friday, May 16 from 2 to 8 p.m. at Gillies Funeral Home, Harrisville. A memorial service will be held Saturday, May 17 at 11 a.m. at St. Andrew's-by-the-lake- Episcopal Church in Harrisville. The Rev. Ron Otto will officiate. 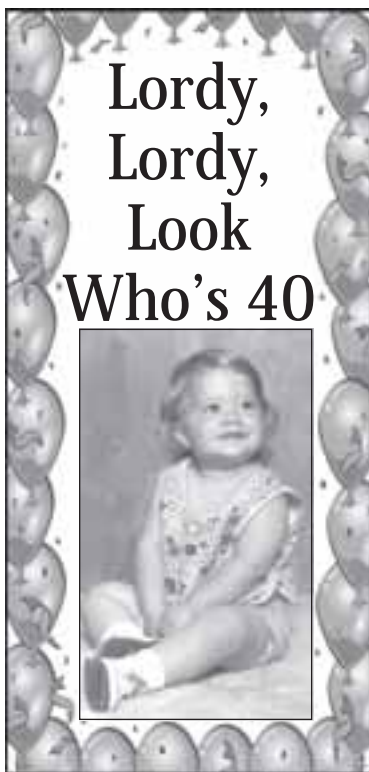

bald eagle was examined they realized it was in a very weakened state.

"The bone was jutting out... it was an old wound and there was no blood supply to the wing," Fruehauf said.

She and the veterinarian discussed the eagle's situation and the fact that its condition showed it had been without food for about a week or more and considered the guidelines from the U.S. Fish and Wildlife Department regarding the threatened species, decided to euthanize the bird.

"It was a difficult decision to make, but this was in the bird's best interest," Fruehauf said. "He was so far down (in weight)... he was starving to death and his body was so drained from the necrosis in the wing... because the bald eagle has been removed from the endangered species list to a threatened status, we no longer amputate," she said.

Fruehauf explained that wildlife rehabilitators are

bound by the rules and regulations of the U.S. Fish and Wildlife Service which oversees bald eagles. "I hate (making) those decisions but, I care enough about the birds to not put them through this (living the rest of its life in a cage if it recovered from the injury and starvation)," she said.

When asked what could have caused the bird's injury, she thought it might have been from eagle-to-eagle contact. "He had scrapes on his feet. It's odd to see that. He could have been in a fight with another eagle or it could have happened during mating," Fruehauf said.

She explained that bald eagles conduct a mating "dance" in midair by locking talons - during the course of the dance they will release and re-lock talons multiple times. "Sometimes they get dropped," Fruehauf said. It could have also happened, she said, during a territory dispute between two eagles as they fight with their tal-

ons. Either scenario could produce scrapes to their feet and cause the predator to fall out of the sky.

Despite the cause of the injury and the good intentions of the Hayslips - both MacNeill and Fruehauf cautioned against anyone trying to capture an injured bald eagle (or any other wild animal). "I don't recommend anyone doing that," MacNeill said. "An eagle has an excellent weapon system... you don't want something (a razor sharp beak or talons) stuck into you. Get a good location and call the RAP line. Let someone who has experience and the right equipment handle it."

Fruehauf agreed. "No one should go after an eagle... they have 1,500 pounds of pressure in each of their feet. They are built to go after warm-blooded mammals and are very effective in that pursuit." She encouraged individuals to look on the DNR's website for wildlife rehabilitators which are listed in alphabetical order according to county. Since Alcona County does not have a licensed wildlife rehabilitator, she also encouraged calling the DNR RAP line. "On a weekend, that is the only way to get a rehabilitator," Fruehauf said.

The DNR RAP line is (800) 292-7800.

The library staff, board of directors and patrons are conducting fundraising efforts to raise the remaining money needed to complete the project. These efforts have included donations from the community, including "Our Kids Bingo," quilt auction, hobo dinner, chocolate party and many contributions by patrons.

Township Library," said Macauley "Mike" Whiting, Jr., president and treasurer for the Herbert H. and Grace A. Dow Foundation. "Our foundation's founder, Grace A. We know the important role libraries play in providing opportunities for residents to meet, learn, and prepare for the opportunities of tomorrow."

How to help seniors with their computer issues from far away

Are there any computer software products that you know of that will let me help my parents with their computer issues from afar? They are in their seventies and frequently call me with their computer questions and problems, but I live across town and don't always have time to get in the car and drive over to help them. What's available that can help us?

Weary Son

Dear Weary,

Helping an elder loved one with their computer questions or problems over the phone can be frustrating and difficult. Fortunately, there are a number of resources available today that offer remote access software that can easily help you assist your parents with their computer issues from afar.

One of the best is TeamViewer, which is completely free to use and works with

Windows and Macintosh computers.

To get started, you and your parents will need to go to TeamViewer.com and install their free software on each of your computers. How-to videos are available on their site to help with the installation.

Once installed – and with their permission – you will be able to access your parent's computer right from your own computer wherever you are. Both machines must have broadband Internet for this to work.

This software will give you the ability to actually see what's appearing on your parent's computer screen, and will let you remotely take charge of their computer so you can show them how to do something, or you can do it for them while they watch. Almost anything can be done remotely with this software. You can even keep a live video chat open at the same time

you're helping them.

If you are interested in shopping around, some other free remote access programs worth a look include Chrome Remote Desktop (go to chrome.google.com/webstore and type in "Chrome Remote Desktop" in the "Search the store" box to find it), and SkyFex (skyfex.com), which works only with Windows.

Skype also has a screen share feature (see skype.com/en/features/screen-sharing) that lets you share your screen and video chat at the same time, but you can't actually take control of the other person's computer. You can only show them what they should be doing by demonstrating it on your own desktop.

If your parents need more tech support than you are able to manage, another option to consider is to sign them up with a tech support company like Geek Squad



Savvy Senior

(geeksquad.com, (800) 433-5778), which also offers remote access capabilities to help your parents with almost any computer issue.

Whenever they would need assistance, they could call the Geek Squad toll free number anytime, 24 hours a day, or log in to their website. A Geek Squad representative would then help them initiate a remote access session, so they could remotely show them how to do something, or make repairs or adjustments to their computer. Once the call is completed, the remote control access

would be disconnected from your parent's computer.


In addition to the remote access help, Geek Squad tech support also offers free anti-virus software, they cover up to three computers (or other devices), and provide unlimited phone and in-person tech support at any Best Buy store. Costs range from \$200 for one year, \$280 for two years or \$350 for three years, with a 15 percent discount available to AARP members.

That helpfulness and interest in people carried through to Kay's employment with Weiner & Burt Law Firm in Harrisville where she was the administrative assistant from 2000 to 2005. "She ran the place," said Pam Burt, an attorney and part-owner of the firm. "We have clients all around the world and Kay had relationships with them... They loved talking to her," Burt said.

Kay retired from the "working world" in 2005, but did not stop working in the community. She had varied interests and that showed in her community involvement. Kay was a lifelong member of St. Andrew's Episcopal Church in Harrisville and spent many years on its vestry (the governing board) and as the editor of the church newsletter. She also enjoyed her role as hostess of the coffee hour each Sunday.

The love and commitment Kay had for her community showed in the many positions she held throughout her adult life. She was the clerk for the City of Harrisville for many years. She was a member of the Alcona Community Schools Board of Education from 1994 to 2006 and was the president of the board for many years during her tenure. The fact that she was the first female board president was something in which she was very proud.

In 2003 Kay joined the Harrisville Depot Preservation Group's board of directors - an effort that was not only close to her heart, but literally close to her home - she lived next to the historic building and shared a made-up tale of a dragon that lived

there with her young god daughters when they came to visit. This story about a good dragon that ate pickles and ran with the train each night roaring when the train whistle sounded, grew over the years and was eventually published as "The Dragon that Lives at the Depot," a self-published children's book.

Kay's love of watching things grow from the soil was put into her involvement with the Alcona Local Foods Association (ALFA), an organization that promoted growing food locally. She was a board member and instrumental in obtaining a federal grant to fund the group and build hoop houses to extend the growing season. Through her participation with the Sunrise Jammers, a group of lo-

cal musicians that performed at various venues in the community, she realized a life-long dream of being a lead singer in a band.

In her "down" time Kay enjoyed reading, writing, poetry, gardening, drawing and making various "craft" projects including greeting cards, singing, walking along the beach of "Lady Huron" looking for beach glass and spending time with her family - especially the newest additions, extended family and numerous friends.

One of the newest "projects" in Kay's life was reading poetry on air at the local radio station WXTF-LP based in Harrisville. The station is "just days from being ready to go on air," according to Dave Morey, operations manager. He said Kay was "a spiritual influence on the station to expand the boundaries beyond playing great music. Her vision was to expand the arts and explore and promote the beauty of this side of the state... When Kay spoke, people really listened."

Bridget - the Celtic Goddess was Kay's radio name and she had recorded several poetry readings that will be aired once the station is officially operational. "If we can't have her in person, we have her voice (on recordings) and we can take a cue from her ideas and concepts," Morey said. One of Kay's most recent poems can be found on the station's website 979harrisville.org.

Kay is survived by her husband, Arthur; one daughter, Katrina (A.J.) Wouters of Harrisville; one granddaughter, Phoenix Wouters; one step grandson, Kaiden Wouters; one brother, Michael (Virginia) Fritz of Harrisville; and one sister-in-law, Jane White of Harrisville. Art gallery to feature primitive wilderness craftsmanship

His art evokes a story of brave, strong people equipped to survive in harsh climates with just a few hand-made tools to hunt and prosper.

It is the story of America's ancestry during its primitive beginnings as only a local artist, savvy in traditional wilderness skills and crafts, can tell it.

Through his art, Jim Miller will be sharing the story of his love of outdoors and primitive wilderness craftsmanship at the Dragon Fly Gallery in Harrisville. The gallery has chosen Miller as its feature artist for the month.

Miller's art, a display of hand carved paddles, natural fiber bags, string made of plant fibers and tree bark, stone and bone tools, arrowheads, birch bark boxes and baskets with decorative etched designs, give a sense

Miller, a Michigan native, said he loved running through forests and streams as a child near his home in Port Huron. Although Miller admits his American Indian ancestry is quite diluted, his interest in the subject is not and he spent many hours as a teenager and young adult studying traditional survival skills and crafts.

"It really began when I got interested in hunting deer. My dad worked on the railroad and never hunted, but I had a grandfather who fished and hunted a bit. Traditional wilderness skills and crafts was just something that always piqued my curiosity, these are the skills of our ancestors," Miller said.

Before long Miller began crafting a career with his knowledge, he is now known as a skilled speaker, instructor, writer, survival outdoorsman and considered an expert in primitive traditional skills and crafts.

Own." He has made television appearances on "Michigan Magazine," "Outdoor Magazine," "Michigan Out of Doors" and news stations across the state.

Featured at many museums and cultural centers around Michigan, his woodland designs add interest and depth to displays around the state and across the United States.

He spends his winter months bringing his expertise and demonstrations to school children across the state. He begins his summer season by first visiting lumbermen he has befriended in the Upper Peninsula where he gets most of his birch bark and then makes a trip to Alaska to demonstrate for the Alaska Center for the Environment in Anchorage.

In addition to traveling, he typically runs a week long Michigan Outdoors Skill School (MOSS) from his home in Mikado where students set up tents or stay in the rustic log cabin Miller built on his property with his wife, Cheryl, to learn traditional survival skills.

Miller cautioned this year's MOSS classes may be cancelled though due to an interest the History Channel has in Miller.

"The History Channel is going to produce a show on wilderness skills and survival. I've been on four interviews so far to see if they want me on the show. It's a serious commitment for at least two months, so the MOSS week may be cancelled. I should know by the end of this week if they are interested in my skills or not," Miller said.

All are invited to a reception open house to meet Miller at the Dragonfly Art Gallery, 116 E. Main Street in Harrisville on Saturday, May 17 from 4 to 7 p.m. To find out more about Miller's passion for wilderness skills, visit jmwillow-winds.com.

of what life was like for native Americans many years ago.

Miller is delighted the gallery chose him as the featured artist and is excited about sharing his passion through this type of exposure. "A few people I know said I should try this, I really don't consider myself an artist, my sister was the artist in the family, I just etch a little. I really enjoy working with bark, making baskets and other tools like snowshoes, bows and canoes. I enjoy sharing wilderness skills many people have never seen," Miller said. In addition to the Dragonfly Gallery his artistry can also be viewed and purchased at the Tawas Bay Art Gallery.

He has written a self published 40 page booklet "Brain Tan Buffalo Robes, Skins and Pelts" as well as many other articles on traditional skills which have appeared in publications such as "Wilderness Way," "Michigan Wilderness Journal," "Michigan Out of Doors," "Woods and Water News," "Whispering Winds Magazine," and the "Bulletin of Primitive Technologies."

In a professional video Miller produced, he demonstrates step by step birch bark canoe construction. His craftsmanship can also be seen in many movies including "Thunderheart," "The Indian in My Cupboard," "Last of the Dogman" and in a NBC mini series, "A Will of Their

Use a spinner bait to target bass

As water temperatures rise, both largemouth and smallmouth bass will start to hang out in shallower water and stick close to areas with cover. Want to know a great tool to target them there? Try a spinnerbait.

Seek out cover; such as logs, boulders or weed patches and cast your spinnerbait in that direction. Often times you'll entice a

bass ready to strike unsuspecting prey.

show up any day now. Target the shallows with high-lines

and cowbells or out a little deeper with spin glows and cowbells.

• Rockport: A limit of lake trout were caught around Middle Island.

• Alpena: The docks are in and the fish cleaning station is open however, the restrooms were still closed. A few anglers fishing just outside the river mouth picked up the occasional walleye day or night.

• Thunder Bay River: Walleye fishing was very good day or night for those drifting and jigging. Most were averaging three to four fish per boat but some had limit catches. Fishing up near the dam was difficult because of high water levels and dealing with suckers constantly hitting their lines.

• Harrisville: The water is up, the docks are in and the fish are in. Atlantic salmon, lake trout, steelhead and walleye are in and around the harbor. Fish are being caught day and night on spawn, body baits, small spoons or spinners in 20 to 40 feet.

• Oscoda: The pier has been productive early morning or late evening. Walleye are coming in limited numbers. They are good size and healthy. Crawlers, jigs and body baits have worked best.

• AuSable River: Steelhead are now moving into the river in good numbers. A lot of anglers are hooking up but some are having a hard time landing them. From the mouth to the dam, the river is high and the current is fast. New snags have moved into some of the areas holding fish.

• Houghton Lake: Cold, gusty winds have kept anglers off the lake. Those fishing the canals have caught a few crappie or the occasional bluegill.





StarWatch By Gary Becker - Moravian Hounds Build a Comet



It's hard to get students to read assignments, so when senior Anika Riaz came to me last month asking if we could make a comet, I asked her the origins of her wish. "Why from your book in the section on comets," she retorted. I hadn't even assigned that material, so how could I refuse her? On May 2 Anika and friends gathered in the commons area between PPHAC and Collier, and we did it. Comets were formed from the primordial leftovers of the solar system, far from the sun's heat where ices, mainly water, but including carbon dioxide, ammonia, and methane, along with silicate grit, and even complex organic compounds existed. So the basic recipe wasn't very complicated: 1/3 gallon of water, a dapple of ammonia, a fistful of sand, a handful of dirt for the organics, and about five pounds of pulverized dry ice (frozen carbon dioxide). The dry ice at -110o F. was the toughest commodity to acquire and maintain, so thank you, Dr. Carl Salter, for providing helpful suggestions and a storage container. A large bowl lined with insulating newspaper and layers of plastic from a garbage bag helped to form the general round shape of the comet. We added the water, ammonia, sand, and dirt and mixed the contents through the plastic bag. Another interesting aspect was pulverizing the pellets of dry ice. This was a task that the females of the group seemed to relish the most. In fact no guy volunteered. It just seemed to be too dangerous as mallets came smashing down on the towel covering the dry ice. Once the women were pulled away, the dry ice was slowly poured into the water, and quickly kneaded to mix all of the contents. Amid the hissing sounds and vapors spewing from the bowl, an icy, sputtering ball emerged. A little more water to form a crust, and voila, Comet Anika was born. SOCIOLOGY: Sociology, Gender and Society, and Marriage and the Family courses. Qualifications: Master's degree in Sociology or related area.

SPANISH: Spanish coursework in listening to, speaking, reading, and writing Spanish. Qualifications: Master's degree in Spanish or a related field preferred.

SPEECH: Speech courses, Interpersonal Communication, Public Speaking, and Oral Interpretation of Literature. Qualifications: Master's degree in Speech Communication or equivalent experience.

VILLAGE OF LINCOLN MINUTES

The Lincoln Village Council met on Monday, May 5 at 7 p.m. at the village hall. The meeting opened with the "Pledge of Allegiance." Those in attendance included: President Jordan, treasurer Kossa, clerk Somers and council members Gauthier, Healy, Naylor, Phillips, Somers and Stutzman. Also present were attorney Cook and several guests.

The minutes of the April meeting were approved on a motion from Gauthier with support from Healy. The treasurer's report was approved, subject to audit, on a motion from Gauthier with support from Stutzman. Somers questioned the \$7,000 that was taken in from the sale of lawn mowers. Mary provided him with documentation that shows it is in the equipment rental fund.

Jeff Allen from Team Elmer's, the winning bidder for the Main Street project, appeared before the board. He stated that since there has been a possible change in what was originally bid out, he would suggest that we consider doing the project differently. He would like to put a drain underneath the roadway and the new bid price would be \$130,050. If we wait until after Labor Day they are willing to do it for \$123,400, a savings of \$6,650. Jeff explained that since their excavators are currently tied up it would help his company and also save us quite a bit of money.

Gauthier said she believes that we should accept the three proposals as suggested by Jeff and have the work completed by September 30. A motion was made by Gauthier to amend the proposal to redo Main Street and to add the necessary storm drain and have the deadline pushed to September 30. Somers offered support. Motion carried. Jeff also turned in a bid for paving of a small section of Millen Street at a price of \$2,500 as well as a bid for Sherman Street that includes the road to the boat launch would cost \$6,700. It is possible to get a quote for slide in ramps for use at the boat launch. These issues will be addressed at a later date.

Fire chief Leroy Hall stated that the fires have been kept down with the recent rains. He stated that he received a large bill for radio programming from the state police. The Downtown Development Authority pays a portion and it appears we will be responsible for half of the bill. He will be contacting them to find out why we aren't receiving the billings in a timely manner.

Bids were opened for the lawn mowing contract that will include 2014, 2015 and 2016. A bid received from Stout's Lawn Mowing in the amount of \$885 per cut. A bid was received from Monnier's Maintenance at \$1,600 per cut. A motion was made by Stutzman, with support from Gauthier, to accept the bid from Stout's Lawn Service for the years of 2014, 2015 and 2016. Motion carried.

Two bids from the village audit were received. A motion was made by Gauthier to award the bid for audit to Stephenson and Gracik. Healy offered support. Stutzman abstained. Motion carried. A request was made by Richard Somers to go into closed session to discuss an employee issue. A motion to amend to allow the attorney, president, clerk and treasurer to stay for the meeting was made by Gauthier, with support from Healy. Carried. Closed session held in fire department area. Motion made by Gauthier, with support from Healy, to reopen the regular meeting. Motion carried. A motion was made by Gauthier, with support from Naylor, to take the HR committee recommendations to terminate Dick Somers' position with the village. Phillips abstained. Somers left the room. Motion carried. Virginia Hart read a letter regarding Dick's job performance and comments

were heard from several others.

Kathy Putsky presented a new American flag to the council from state representative Peter Pettalia. It hung at the state capital and comes complete with a certificate. Debbie Shanour said the beautification committee is out in full force. They have taken down lights from trees in the downtown area and are in the midst of preparing to plant flowers. Virginia Hart asked about having the street lights turned down late at night. President Jordan stated that it is a safety issue, although they are turned down drastically during the late night hours. Virginia commented that the Christmas lights are beautiful every year. Debbie stated that Pat and Jesse Scott, members of the beautification committee, are moving out of the area. They will be missed for all their help and contributions. Eric Monnier asked about homeowners that approached him regarding leaves that blew into the water on Brownlee Lake. He had to have his crew leave the area because of a possible confrontation. Attorney Cook advised him to talk to officer MacNeill from the DNR about what needs to be done.

The street report was given by president Jordan. Lots of potholes need to be taken care of. There is a sinkhole on Hawley Street that will need to be attended to immediately. Several roads need to have crack sealant this year due to the harsh winter. A motion was made by Gauthier, with support from Stutzman, to put crack sealant out for bids. The sewer report was turned in by Richard Gillespie of Alpena Septic Service. Things are doing very well there.

In old business, Stutzman stated that the locks on the bathrooms at the ball fields are smashed. Jordan will check into it. John has been looking into playground equipment for the little park by the hall. A cleanup of Barlow Road from the hardware corner to the village limits will be held. It will be on Tuesday, May 20 at 6 p.m. Council members are asked to help in this endeavor. He inquired about having the towers painted on the play structure. If necessary we may need to have it put out for bids.

President Jordan gave his report. A letter was received from the Barton City Improvement Association. They are requesting help with funding for fireworks. Attorney Cook stated that since the council gives money to the Harrisville fireworks and they are a 501(c)3 organization that is okay. The Barton City group is not under that classification so we can't legally donate to them. It has been requested that the water be turned on at the ball fields. Jordan will do it this week. The post office parking lot will be restriped and revamped sometime this summer.

President Jordan had a visit from one of the boys that was banned from the playground last year. He asked to be allowed to go back there and promised not to cause any more trouble. Following a brief discussion council members agreed that he would be allowed to return after the Fourth of July. He needs to be reminded that he will be prosecuted if he causes any damage in the future. President Jordan spoke with Jesse Campbell of the road commission recently regarding road salt for next winter. Currently, we have about 40 tons still available and it will be necessary to order soon for the next season.

A motion to pay the bills as presented was made by Gauthier with support from Stutzman. Carried. Motion to adjourn from Gauthier with support from Stutzman. Carried.

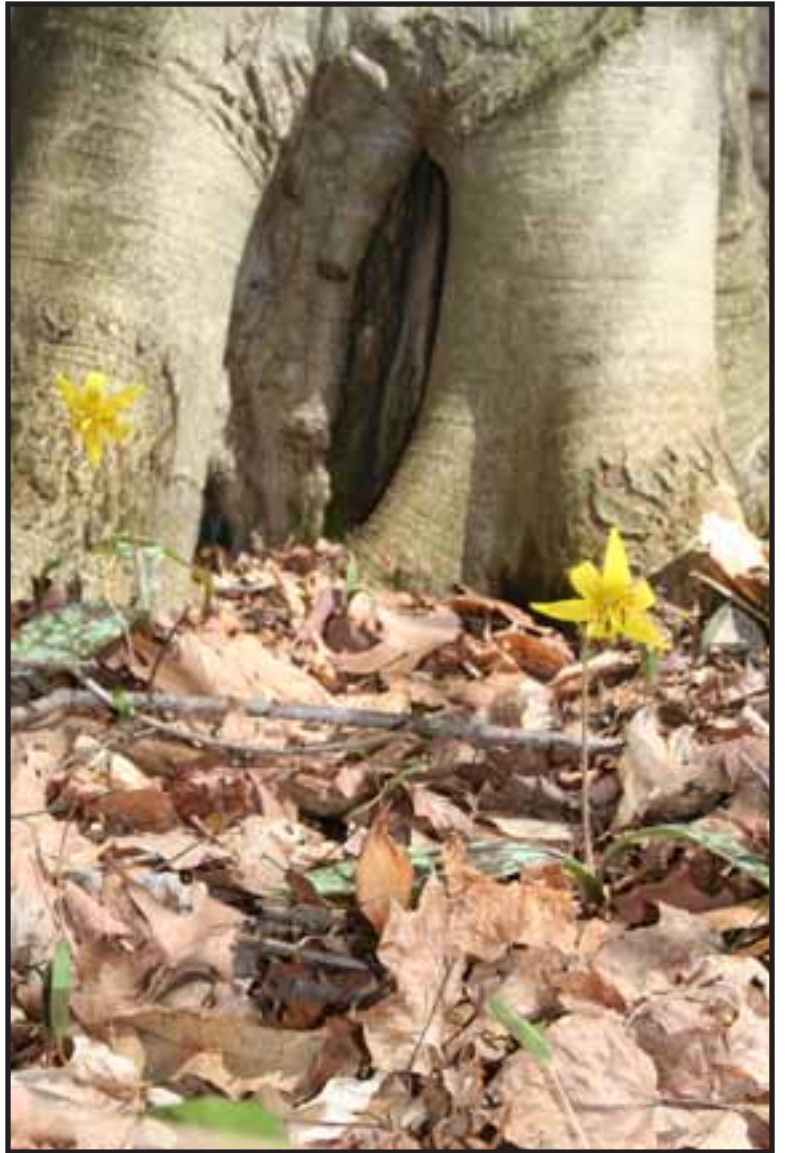
