## Angler breaks state record with catch on Hubbard Lake

The Michigan Department of Natural Resources (DNR) has confirmed a new state-record catch for smallmouth bass.

The existing state record for smallmouth bass was broken on Sunday, Oct. 18 by Greg Gasciel of Rhodes, Mich. Gasciel was bait-casting with a green grub on Hubbard Lake when he landed a smallmouth bass that weighed 9.33 pounds and was 24.50 inches long.

The record was verified by Kathrin Schrouder, a DNR fisheries biologist in Bay City.

"This is additional evidence that Michigan truly has world-class bass fisheries," said Jim Dexter, DNR fisheries chief. "Smallmouth bass is one of the most popular,

most sought-after sportfish in North America. Even though the Michigan state record stood for more than 100 years, we're excited to see the bar set even higher for those who set out to land this iconic fish."

The previous state record for smallmouth bass was set in 1906 with a 9.25-pound, 27.25-inch fish taken from Long Lake in Cheboygan County by W.F. Shoemaker.

This marks the sixth state-record fish caught so far in 2015. State records are recognized by weight only. To qualify for a state record, fish must exceed the current listed state-record weight and identification must be verified by a DNR fisheries biologist.

## Village of Lincoln receives \$300,000 grant

The Village of Lincoln recently received the opportunity to use a \$331,680 Stormwater, Asset Management and Wastewater (SAW) grant to be used in the next three years.

The grant from the Michigan Department of Environmental Quality (DEQ) is designed to help municipalities

plan for sewer and storm drain maintenance needs.

According to Phil Jordon, village president, the village applied for the grant in 2013 when it first became available and were told then they probably wouldn't get in on the first round. "This is the third round and Lincoln was picked to take part in it. The nice thing about this is it's a 100 percent grant with no

matching funds needed," Jordon said.

He explained the DEQ only gives 100 percent grants to disadvantaged communities.

The grant will not extend the area of the sewer system, but instead provide useful information to help budget for necessary repairs of existing systems.

Jordon explained it will pay for a camera to go down into every pipe, including the drain field, and evaluate the condition of the system. These findings will provide the village with recommendations to budget for repairs. It will also map every septic tank, storm drain covers, piping of the drain fields, the pump station and give exact locations of where everything is with global positioning system (GPS).

The Village of Lincoln's current sewer system has been in place for about 30 years. Jordon said it is a limited system which covers downtown Lincoln, Second Street, and goes up into the industrial park covering about 40 participants. However, some owners in the area have older systems which are grandfathered in.

"The map we have now was put together 30 years ago. A lot of it states things as 16 feet west of a certain tree or 12 foot south of a building. This (new map) will tell exactly where each opening is," Jordon said.

He explained that as part

## Dream comes true at homecoming

The only thing that might be better than watching someone's dream come true is helping to make it come true.

And a lot of people helped make Tyler Sytek's dream to play in a football game come true last Friday night.

Tyler Sytek has been on the Alcona varsity football team since he was a freshman. In the last four years he has attended 90 percent of the practices and dressed for every single game. But he had never played in a game -- until Friday's homecoming game against the Mio Thunderbolts.

Tyler was born four months premature and, as a result, has a form of cerebral palsy called lower limb dysplasia. Despite all of the physical limitations that come with this disease, Tyler is an avid football fan and a dedicated

Tiger football player. He started with the team as the manager, but his enthusiasm and drive caught the attention of Terry Franklin, his gym teacher for several years and an assistant football coach.

Tyler and his parents, Steve and Debbie Sytek, and his younger brother, Jacob, and sister, Abigail, live in Glennie where football is taken very seriously by Tyler and Jacob. They talk about football whenever they get the chance -- which is unfortunate for Abigail, who doesn't like the game.

"I've liked football for as long as I can remember," Tyler said. "Being part of the team -- it kept me motivated. The guys on the team helped too."

During his junior year Tyler started "padding up" for practices and games in which he wears a jersey with the number "1" on it that Franklin gave him.

"Just the other day, during practice, a couple of players asked me 'what is Tyler doing?' While the team was practicing blocks Tyler was running 40-yard sprints at the end of the field," said Jason Somers, varsity football coach. "He's just like that. He comes to most of the practices and all of the games... If he can't make a practice he makes it a point to tell me why. He never complains -- well, unless it's cold. He doesn't like the cold."

"It's amazing the responsibility he takes at being part of the team -- he's definitely all in... He's a really good presence on the team. He never lets things get too serious. He'll make off-the-wall comments to remind players and coaches not to be too serious," Somers said.

Last Friday's homecoming game was the last game of the regular season for the

## Deer License Structure

With Michigan's archery deer season in full swing and firearm season set to begin Sunday, Nov. 15, the Michigan Department of Natural Resources reminds hunters of changes to the state's hunting license structure that took effect in 2014.

Available deer licenses include:

- Single deer license, valid throughout archery, firearm and muzzleloader seasons. This license has replaced the separate archery and firearm licenses. Hunters who buy a single deer license may not buy a second single deer license or the deer combo license.

- Deer combo license, which includes two kill tags, one regular and one restricted. Hunters who want two deer licenses must buy the deer combo license instead of the single deer license. The deer combo license is valid for use during the archery, firearm and muzzleloader seasons. A hunter can use both kill tags in the firearm seasons, both in the archery season or one in each season.

- Antlerless deer license, available based on license

quotas set for each Deer Management Unit (DMU).  
To see how the single deer and deer combo licenses may be used in each deer season, based on which DMU a hunter wishes to hunt, see the Antler Point Restriction Regulations map and chart on pages 32 and 33 of the 2015 Hunting and Trapping Digest.

A base license now is required for all hunters. The base license provides critical funding for habitat and conservation work on both public and private land and supports the work of conservation officers and field staff to ensure safe, legal hunting practices are followed. The purchase of a base license includes small game hunting. Whether they choose to hunt small game or not, hunters' base license dollars will be used to enhance and expand hunting opportunities, which benefits hunters of all species.

## Understanding reverse mortgages: Beware of misleading ads

Dear Savvy Senior,  
Can you give us a run-down of how reverse mortgages work? I've seen actors Fred Thompson and Henry Winkler pitching them on TV, and they sound like a good deal. What can you tell me?  
Need the Money

Dear Need,  
When it comes to celebrity spokespeople pitching reverse mortgages on TV, don't believe everything you hear. Many of these ads are misleading and don't always give you the whole story. In fact, the Consumer Financial Protection Bureau recently issued a warning to seniors to watch out for these deceptive advertisements. With that said, here's the lowdown on reverse mortgages.

A reverse mortgage is a unique type of loan that allows older homeowners to borrow money against the equity in their house that doesn't have to be repaid until the homeowner dies, sells the house or moves out for at

least 12 months. At that point, you or your heirs will have to pay back the loan plus accrued interest and fees, but you will never owe more than the value of the house.

It's also important to understand that with a reverse mortgage, you, not the bank, own the house, so you're still required to pay your property taxes and homeowners insurance. Not paying them can result in foreclosure.

To be eligible, you must be at least 62 years old, own your own home (or owe only a small balance) and currently be living there.

You will also need to undergo a financial assessment to determine whether you can afford to continue paying your property taxes and insurance. Depending on your financial situation, you may be required to put part of your loan into an escrow account to pay future bills. If the financial assessment finds that you cannot pay your insurance and taxes and

have enough cash left to live on, you'll be denied.

Around 95 percent of all reverse mortgages offered today are Home Equity Conversion Mortgages (HECM), which are FHA insured and offered through private mortgage lenders and banks. HECM's also have home value limits that vary by county, but cannot exceed \$625,500.

How much you can actually get through a reverse mortgage depends on your age, your home's value and the prevailing interest rates. Generally, the older you are, the more your house is worth, and the lower the interest rates are, the more you can borrow. A 70-year-old, for example, with a home worth \$250,000 could borrow around \$136,000 with a fixed-rate HECM. To estimate how much you can borrow, use the reverse mortgage calculator at [reversmortgage.org](http://reversmortgage.org).

You also need to know that reverse mortgages are expensive with a number of fees,

including: a two percent lender origination fee for the first \$200,000 of the home's value and 1 percent of the remaining value, with a cap of \$6,000; a 0.5 percent upfront mortgage insurance premium (MIP) fee, plus an annual MIP fee that's equal to 1.25 percent of the outstanding loan balance; along with an appraisal fee, closing costs and other miscellaneous expenses. Most fees can be deducted for the loan amount to reduce your out-of-pocket cost at closing.

To receive your money, you can opt for a lump sum, a line of credit, regular monthly checks or a combination of

these. But in most cases, you cannot withdraw more than 60 percent of the loan during the first year. If you do, your upfront MIP fee will be bumped up to 2.5 percent.

Also note that because reverse mortgages are complex loans, all borrowers are required to get face-to-face or telephone counseling through a HUD approved independent counseling agency

Tigers and, the last home game for all of the seniors on the team. Tyler was selected as a team captain and represented his team for the coin toss at the start of the game, which eventually turned into a lopsided affair as the Tigers dominated the Thunderbolts.

By the fourth quarter coach Somers was pulling substitutes off of the bench to play in an attempt to hold the score down. According to Somers, it was around that time when Buddy Landerway, an official in the game, came up to him and said, "You need to put number one in the game coach."

"I explained to him that Tyler couldn't play - he couldn't be bumped or banged or anything," Somers said. "He said it to me again. 'You need to put number one

in the game.'"

It took Somers a minute or two to understand. Then he sent a player into the stands to get Tyler's father, Steve Sytek. After a conference with Sytek and Dan O'Connor, athletic director for Alcona, Somers approached Mio's coach Jim Gendernalik, who said he'd talk with his team.

While this was transpiring, the senior players approached Somers. "They wanted to be part of it and they threatened to go in if I didn't put them in," Somers said. "They care about him. No one messes with Tyler at school. These boys make sure he is well protected."

"Mio's coach was wonderful. He agreed that no one on his team would hit Tyler," Somers said.

After all approval was given, Tyler and senior team members took the field to run in a two-point conversion. Tyler carried the ball as his team blocked for him.

Needless to say, the stands erupted as Tyler took the field and ran the play. He received hugs from coaches and other supporters and gave a fist bump to Michael Doidge Jr., another avid football fan and dedicated Tiger supporter.

"The Mio kids were very supportive," said O'Connor. "I heard them in the huddle before the play saying 'this was the right thing to do.'"

"It took an entire group of people at the game to make this happen - officials, coaches, our athletic director, Tyler's parents, and all of the players," Somers said. "But, it was Buddy Landerway from Midland who knew the importance of what this would mean - boy, did he get that right."

While Tyler and his family

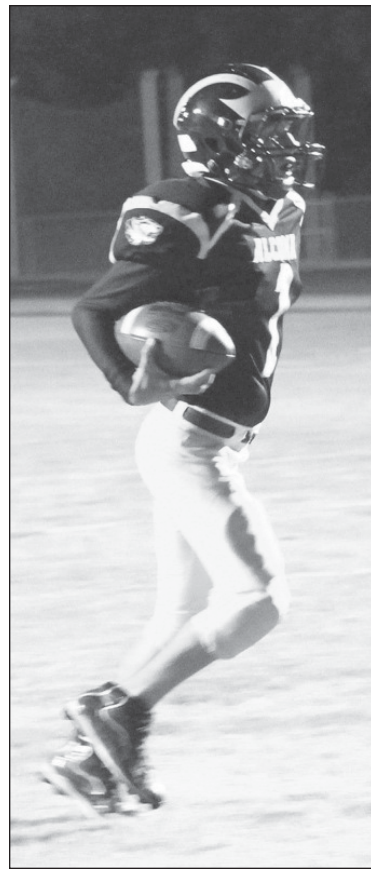
are sharing this special experience with family and friends, the story of Tyler's two-point conversion made national sports news on ESPN. It's also stayed with many of the Alcona fans who were at the game. "What a thrilling experience. It was such a touching night... every time I watch the video I cry all over again," said Patti Byce, assistant athletic director.

"Tyler has taught everyone - coaches and players - really valuable lessons about perseverance. He is so positive. He has his off days, but they are pretty few and far between. I think a lot of kids have taken a work ethic away from Tyler's example by thinking 'if he can do it then I can do it too,'" Somers said.

Tyler's positive attitude most likely comes from the example his parents present in the face of adversity. "Through all of the years of Tyler's illness - the surgeries we've been through, all of the physical therapy, all of the traveling to go to doctors and specialists - every time we go someplace we say, 'we are so lucky for what we have. It could have been a lot worse.' We got lucky. We see other kids that are way worse than Tyler. We are just thankful," Steve said.

According to his mother, Tyler doesn't see himself as disabled. "He will try anything," Debbie Sytek said. "We are very proud of all his accomplishments and the young man he has become."

Tyler will graduate from Alcona High School as a member of the Class of 2016. In addition to playing football he also works at the bus garage in a school to work program.

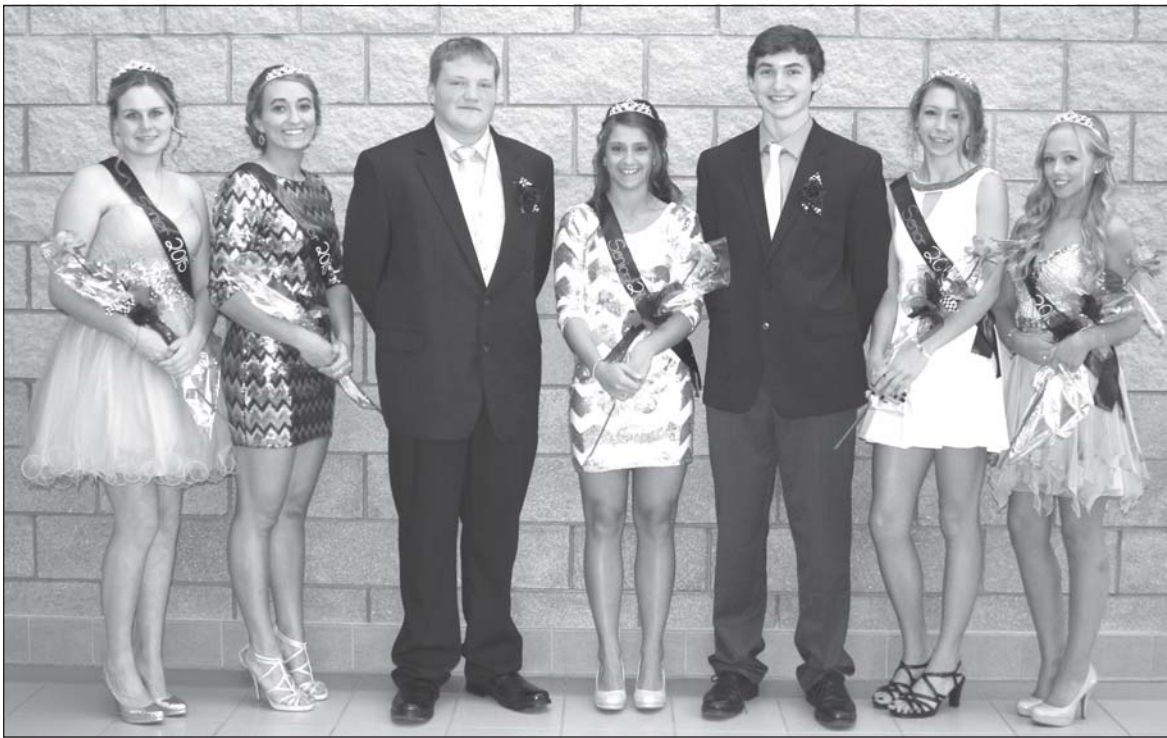

of the grant all storm drains will be cleaned annually for the next three years, so the camera can operate smoothly. The village currently rotates the cleaning to half one year and the other half the next.

"This grant is a good thing for the village. If the evaluation spot leaks, breaks or ero-

sions, we can plan to fix it. The worst thing you want in a storm drain or sewer system is an emergency, especially in the winter. This will help identify issues and help the village to have a tightened projected repair schedule," Jordon said.

According to Jordan, the funding will provide a pro-

jected \$180,784 of the \$331,680 to be used towards the storm water asset management plan and \$150,896 for the waste water assessment plan.

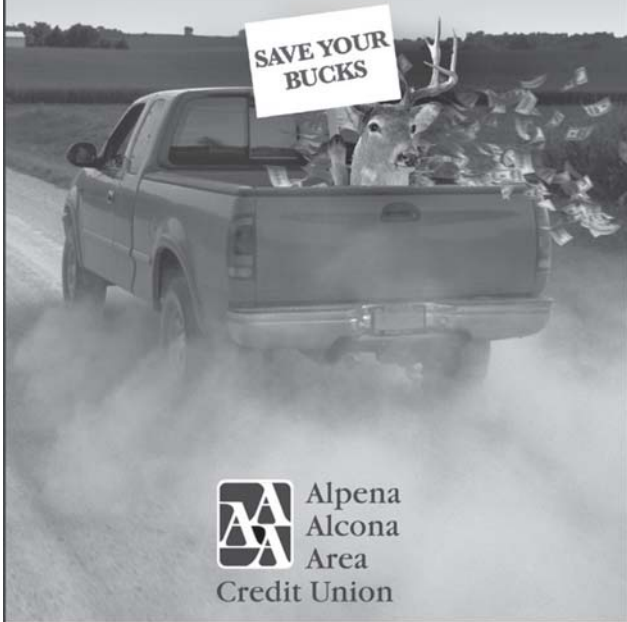

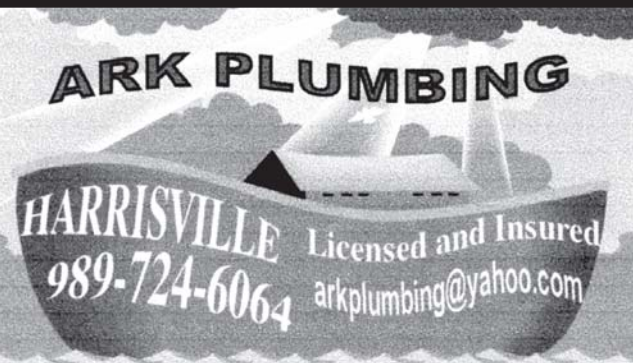

## With coffee flavor

Various Preparations That May Be Recommended

Aside From Its Use As A Beverage There Are A Number Of Ways In Which Delicious Bean May Be Employed

**October 28, 1915** - Coffee is a flavor always at the call of the cook, and one that can be relied on when: fruits fall. The medicinal qualities of coffee are due to its aromatic essential oil—and it is that, of course, which gives the flavor. As the roasting brings out the flavor of the oil, the roasting should be carefully done. When using coffee for flavoring make it by percolating boiling water through the freshly ground beans.

**Coffee Jelly**—Soak an ounce of gelatin in a cupful of cold water and dissolve to three cupfuls of boiling water; Add two cupfuls of sugar and two of strong coffee, and strain into a mold. Harden and serve with whipped cream, garnished with macaroons.

**Coffee Mousse**—Boil a cupful of coffee and two tablespoonfuls of sugar together, and slowly pour it over two egg yolks, stirring all the time. Strain when cold and add two cupfuls of whipped cream. Pour into a mold and pack in ice and salt for three or four hours. Serve in tall glasses.

**Coffee Icings**—Melt two cupfuls of sugar and boil until it forms a string from the spoon. Stand the saucepan in a dish of cold water until the sugar begins to form on the sides, and then work in a cupful of strong coffee, pressing it against the sides of the saucepan with a spoon. When the mass granulates it is ready to use as icing.

**Coffee Cake**—Cream half

a cupful of butter with two cupfuls of sugar. Add half a saltspoonful of cloves and a saltspoonful each of mace and cinnamon, with a cupful of molasses. Beat for five minutes, and add the creamy yolks of three eggs and a cupful of strong coffee. Then alternately add five cupfuls of sifted flour and the whites of three eggs beaten stiff, a teaspoonful of saleratus dis-

solved in hot water. Lastly stir in a quarter of a pound each of raisins and currants. This will make two loaves. It should be kept covered after it is baked, as it loses flavor if left uncovered.

**Coffee Pudding**—Beat four eggs thoroughly and add five tablespoonfuls of sugar and half a teaspoonful of salt. Gradually add two cupfuls of boiling milk and half a cupful

of hot coffee. Pour into a pudding dish and bake in a pan of water in a hot oven. Serve very cold.

**Coffee Creams**—Mix strong coffee with confectioners' sugar, a little vanilla, a tablespoonful or two of cream and the white of an egg. Add enough sugar to make a stiff cream, mold into balls and put a walnut meat on each side of each ball.

## Fire destroys McConnell home

Broken Pump Causes Shortage Water—Some Insurance.

**October 28, 1915**-Fire Tuesday afternoon destroyed Varnum McConnell's home in Hawes township. Only the contents of one room were saved, the clothing and bedding being among the articles destroyed.

The fire occurred about four o'clock when Mrs. McConnell was alone in the house. The fire caught in the wall behind the kitchen range. She threw a pail of water on the blaze, but could get no more water because the pump was broken. When the neighbors arrived the building was too far gone to be saved and only a small part of the contents could be brought from the house.

Mr. McConnell carried insurance in the New Grange Insurance Co.





#### StarWatch By Gary Becker - No Deal Breakers for The Martian

As of October 18, 2015, The Martian has grossed worldwide, \$319.2 million, against a budget of \$108 million (Box Office Mojo). Not bad, Andy Weir, for your first published novel which was quickly translated into a feature film. It highlighted the survival of astronaut, Mark Watney, who was left behind for dead in an emergency evacuation of the Ares III base when the fury of a Martian dust storm threatened to topple the MAV (Mars Ascent Vehicle), their only escape to the Hermes in Mars' orbit and their way back to Earth. After previewing the film on October 2, my Moravian astronomy students saw it the following week. Of course, there was a catch, a writing assignment, charging them with finding errors in the film. Our ensuing discussion showed some very astute observations. I started by revealing that any hurricane-type storm on Mars would feel like a light breeze and be incapable of blowing over the MAV. Mars' air pressure is only 1.5 percent of Earth's surface pressure. They countered with the snowflake-sized dust and its black appearance. Martian wind only blows very fine-grained (red) sand creating a pink sky, not the magenta seen in the movie. And then there was the first long traverse that Watney made to locate the site of Pathfinder (1997), buried in sand and still attached to its parachute. Watney needed Pathfinder to reestablish communications with NASA after the storm. Pathfinder is still visible from orbit, but defunct in Ares Vallis, among one of the rockiest parts of Mars, its parachute jettisoned just before touchdown. Why were there no familiar constellations visible in the Martian sky at night, and could you really grow a potato crop indoors with artificial light? ## Veterans Host By Greddy Groves

### Blue water vets and Agent Orange

The Department of Veterans Affairs decided long ago that for a Vietnam veteran to have been exposed to Agent Orange, he or she would have had to actually step foot on land. For those veterans, the VA developed a list of presumptive illnesses -- among them peripheral neuropathy, non-Hodgkin's lymphoma, Parkinson's disease, prostate cancer and more -- for which it would pay disability benefits.

"Blue water" veterans -- on ships offshore in deep-water harbors -- got nothing. Here and there an individual claim would be approved for those who had docked and set foot on land or were on patrol boats on inland waters.

The Institute of Medicine was asked to determine if blue water veterans could somehow have been exposed to Agent Orange even if they never left the ship, determine the possible method of transmission and compare them to troops on the ground.

The IOM committee held three open meetings, the last aboard the USS Midway, now a museum in San Diego. What members specifically wanted to see: the distillation plants.

Navy ships had their own drinking-water supply systems, converting seawater to drinking water. And where did that water go? Everywhere. It was used for drinking, cooking, laundry, showers and making coffee.

The IOM called it a "plausible pathway of exposure." It concurred with an Australian study that concluded the distillation plants "had the potential to enrich" the concentrations from the source water to the drinking water on the other end.

The IOM couldn't, however, determine whether blue water veterans had a higher or lower level of risk than those who served on land or traversed the inland waterways.

The VA estimates that of the 80,000 living blue water veterans, about 40,000 have been found eligible for benefits, while about 20,000 have been denied benefits.
