F-41 road resurfacing begins Monday

A project to replace the asphalt surface on F-41 between Kings Corner Road and Goddard Road is scheduled to begin the week of May 16.

Work will include milling the existing surface and putting down a new, wider asphalt surface, along with drainage improvements and new signing.

Bolen Asphalt of East Tawas will be the contractor on the job. The cost for the project was bid at \$276,718, and is supported by a combination of the Alcona County Road Commission's allocation of Surface Transporta-

tion Program and Michigan Transportation Economic Development Category D funds.

According to Jessie Campbell, managing director of the road commission, traffic will be maintained during the project, which is slated for completion by mid-June. Motorists, however, should expect to encounter lane closures and minor delays during the project.

According to Campbell, this portion of F-41 was reconstructed in 1989 and resealed in 2004, and is now being resurfaced as part of a

three-phase project that will include the remaining 3.5 miles north to F-30, anticipated to be completed by 2018.

The Alcona County Road Commission maintains over 700 miles of roads in Alcona County. Greenbush supervisor has legacy of kindness, dedication

Greenbush Township residents, friends and family are mourning the loss of a long time public official and friend.

Edward "Ed" William Roddy, Greenbush Township supervisor, died on April 30 at home with his wife, Donna, and family by his side. He was 85 years old. (See obituary on page 2).

He was a tenaciously loving and peaceful man who, filled a need when he saw one, and kept with it to the very end.

Ed lived in Greenbush for 31 years after retiring from the City of Detroit, Mich. Of those 31 years, 28 were spent as the Greenbush Township Supervisor.

He was much more than a supervisor though as many residents knew Ed as a friend first. He enjoyed bowling, card playing, baseball, football, (attending many high school football games), socializing and was always very civic minded.

He spent many years as chairman of the Oscoda Wurtsmith Airport Authority and was a member of the Alcona Economic Development Committee, Cedar Lake Association and Knights of Columbus. He was the last chairman of the Oscoda Kiwanis Club and was a parish member of Sacred Heart Catholic Church in Oscoda.

His youngest daughter, Kathleen "Kitty" Carlson, said her father always had a way of making people feel comfortable and important no matter what. "He was always a peacemaker," Kitty said.

Roddy met his wife Donna through a mutual friend at a bowling alley in Detroit, Mich.

when the two were just 19. "He claimed to like my bowling form," Donna said about her husband and best friend.

The couple were married on May 26, 1951 at St. Margaret Mary on the east side of Detroit. Ed worked as a mechanic and surveyor for the City of Detroit for 35 years. His tenacious character didn't just stop with being married to one woman for almost 65 years or working at the same job for 35 years, he was also heavily involved with the Knights of St. John, an international organization, which he joined when he was 15 and was a member for 70 years. Many of those years were spent as athletic director running two softball teams for the organization.

Donna brought Ed to the Greenbush area before they got married to show him where she intended on retiring some day. She came to the area in 1936 with her parents and fell in love with

the area.

Years later, her dream of living in northeast Michigan became a reality. Just before Ed was to retire, Donna and Kitty moved to Greenbush to put their cottage home on Lake Huron in order. The City of Detroit, however, had other plans and offered Roddy a raise and a new title of head of maps and surveys which he took, along with another three years of work before he was able to retire to Greenbush.

Once he finally made the move he truly loved living on the lake and the people of Alcona County. "We've been so fortunate to meet so many really wonderful people up here," Donna said.

She said one of Ed's

He married Donna Presley on May 26, 1951.

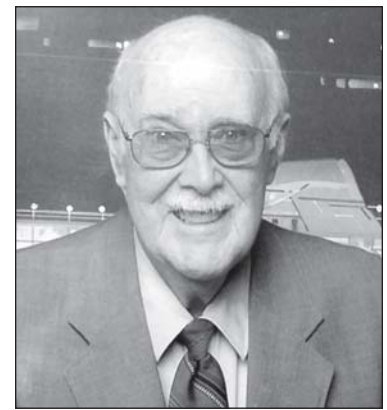
Mr. Roddy was the Greenbush Township Supervisor for 28 years and the chairman of the Oscoda Wurtsmith Airport Authority.

Letter to the Editor

To the Editor,
I urge everyone to watch "Genetic Roulette - The Gamble of Our Lives" on the Internet. It will scare you. Fifty countries in the world including the European Union countries require genetically modified organisms (GMO) foods to be labeled and as a result food companies do not sell GMO foods in those countries, although their livestock is often fed imported GMO feeds.
Monsanto (GMO seeds, Roundup, Agent Orange, PCBs) and major food companies have corrupted our government - Food and Drug Administration, U.S. Department of Agriculture, National Institute of Health and Congress - both parties.
But grass roots efforts have passed GMO labeling in Vermont, Connecticut and Maine. As a result, several food companies including General Mills, Kellogg's, Mars, Campbell's and ConAgra have announced they will begin labeling their GMO foods and/or phasing them out.

Monsanto, Dow and Coca-Cola have contributed over a half million dollars to Stabenow in five years. Is she corrupt, duped or stupid? Doesn't really make any difference.
Please call Stabenow's office - (202) 224-4822 and protest strongly - tell her to "dump the Dark Act." And don't be nice about it - think about your children, grandchildren, future generations. Also, Senator Gary Peters - (202) 224-6221. Ask your friends and use social media.

Annual Meeting

Greenbush Historical Society's annual meeting on Thursday, May 12 at 7 p.m. at the township hall will include guest speaker Lee Luck, board member and former chairman of the Wurtsmith Air Force Museum. He will share information about artifacts at the museum and the upcoming July event "Welcome Home Vietnam Veterans" featuring a fully restored, flyable Vietnam Huey Helicopter. Refreshments will be served.

Bronze Medal Award

Alcona High School has received the bronze medal award from U.S. News and World Report placing the school in the top 31 percent of schools in the country. It is the sixth time in 10 years the school has been awarded the bronze award and it is the fourth straight year in a row. "There are several other local schools on the list, but our consistency and recent frequency stands out," said Dan O'Connor, principal of Alcona High School. Accord-

ing to U.S. News Education, public schools honored among the U.S. News best high schools educate their students well, not just those who are likely to head to college. More than 28,000 schools in all 50 states and the District of Columbia were reviewed for the 2016 best high school ranking.

Top ranking schools serve a diverse group of students across a variety of communities. The types of institutions also vary. Only 15.3 percent of the schools with gold, silver or bronze medals are either charter or magnet schools. About 38 percent of medaled schools are in rural areas. Students in poverty made up at least 25 percent of the total enrollment in about three-fourths of all medaled schools.

strengths as a supervisor, and the reason people kept voting for him, was because if he didn't know the answer, he would find out the answer and always called people back. She said he was on the ballot again to run unopposed as supervisor before his death.

Ed was also an avid bird watcher and liked to tinker with cars until type II diabetes ravaged his body. Kitty said several bird feeders placed around her parent's lake side cabin had been specially outfitted with a variety of squirrel proof baffles so the birds got a chance to eat.

Donna said during the later years of Ed's life he enjoyed going to the Oscoda Yacht Club for clam chowder once a week and would often go to Kmart in Oscoda to have coffee in the morning with a group of men before 9 a.m. She said that was one of the secrets of their long marriage. He was a morning person and went to bed early; she was a night owl who slept in late. They both respected each other's time of peace and quiet.

Ed had to quit many of the things he loved doing because diabetes had taken his legs and his ability to drive. "I never knew how devastating type II diabetes could be. His body just shut down. It was hard to watch," Kitty said.

Ed is survived by his wife, Donna, and three children, Geri (George) Buchholz, Frank Roddy and Kathleen "Kitty" (Michael) Carlson; six grandchildren; and two great-grandchildren. He was preceded in death by his daughter, Marie Lamb.

A funeral Mass was held on May 6 at Sacred Heart Catholic Church. Memorial contributions can be made to the Sacred Heart Catholic Church Building Fund or to the American Diabetes Association.

Community will benefit with new library programs

The Alcona County Library will be reaching out to the community to help in more ways than one this summer. Starting next week the library will be offering a Michigan Legal Help website. Beginning in June it will be offering youth a "Meet Up, Eat Up and Read Up" program to give kids free and reduced lunches.

The Michigan Legal Help website will be introduced to the community on Wednesday, May 18 at 2 p.m. with Judge Laura Frawley at the Harrisville branch of the Alcona County Library. All are invited to attend.

The site, which will be available on computers at the library, offers a place where area residents who need to represent themselves in legal matters can get free legal information tools and forms. It is affiliated with the statewide self-help website MichiganLegalHelp.org.

A variety of information will be on the site including: Family law, protection from abuse, housing issues, consumer law problems, income taxes, setting aside a criminal conviction or juvenile adjudication, public benefits, individual rights, employment, and estates and guardianships. New information will be added regularly.

"It is a public friendly site which will offer extra service to our community and may relieve some inhibitions about going into court," library director, Denise Bearre, said.

There will be 52 different types of forms available on the site. The library staff has been educated and will offer help on how to navigate through the forms and obtain information.

The site can provide information but does not give le-

gal advice. It is not intended to be a substitute for hiring an attorney and cannot refer specific lawyers, but will have links to help find attorneys in the area. "It will also give helpful information such as when to arrive for your court time and what to dress like for your time in court," Bearre said.

The "Meet Up, Eat Up and Read Up" program is expected to start when the reading program starts on June 15, providing the library can find enough volunteers. The program, sponsored through The Salvation Army in Alpena, will offer free and reduced lunches for kids aged one to 18 three times a week through the summer at the Harrisville branch of the Alcona County Library.

Bearre explained a lot of things still need to be in place to offer the lunch program including collecting enough volunteers to drive to Alpena and bring the meals back in coolers, check in kids, set up lunches and clean up.

"Since we are in an area with a good percentage of kids receiving free and reduced lunches during school, we are eligible for this program. The Salvation Army will make the meals but I have not found volunteers to get the meals from Alpena to Harrisville," Bearre said.

She explained the program also offers a breakfast and snack but the library wanted to start this first year small and just offer the lunch.

Anyone who would like to volunteer may call Bearre at the library (989) 724-6796, ext. 221. The Harrisville branch of the Alcona County Library is located at 312 W. Main Street (M-72). Hours are Monday through Thursday, 9:30 a.m. to 7 p.m., Friday, 9:30 a.m. to 5:30 p.m. and Saturday, 10 a.m. to 3 p.m.

How to replace vital documents that are lost or stolen

Dear Savvy Senior,
Can you tell me how to go about replacing important lost documents? My wife and I recently downsized to a retirement community, and somewhere in the move we lost our Social Security and Medicare cards, birth certificates, marriage license and passports.

Worried Ron

Dear Ron,

Replacing important documents that are lost, stolen or damaged is pretty easy if you know where to turn. Here are the replacement resources for each document you mentioned, along with some tips to protect you from identity theft, which can happen if your documents end up in the wrong hands.

• **Birth certificate:** If you were born in the United States, contact the vital records office in the state where you were born (see cdc.gov/nchs/w2w.htm for contact information). This office will give you specific

instructions on what you need to do to order a certified copy and what it will cost you. Birth certificate fees range between \$9 and \$30.

• **Social Security card:** You can replace a lost or stolen Social Security card for free, and if you live in the District of Columbia, Michigan, Nebraska, Washington or Wisconsin, you can do it online at ssa.gov/ssnumber.

If, however, you live outside these areas, you'll need to fill out Form SS-5 (see ssa.gov/forms/ss-5.pdf to print a copy) and take it in or mail it to your nearby Social Security office, along with your U.S. driver's license, or a state-issued non-driver ID card or a U.S. passport (photocopies are not accepted). Any documents you mail in will be returned to you. To find the Social Security office that serves your area, call (800) 772-1213 or see ssa.gov/locator.

You also need to be aware that losing your Social Security card puts you at risk for

identity theft. If you find that someone uses your Social Security number to obtain credit, loans, telephone accounts, or other goods and services, report it immediately to the Federal Trade Commission at IdentityTheft.gov or call (877) 438-4338. This site will also give you specific steps you'll need to take to handle this problem.

• **Medicare card:** To replace your Medicare card for free, just call Social Security (800) 772-1213 or contact your local Social Security office. You can also request one online at ssa.gov/myaccount. Your card will arrive in the mail in about 30 days.

By losing your Medicare card, you also need to watch out for Medicare fraud. So check your Medicare Summary Notice for services you did not receive and, if you spot any, call the Inspector General's fraud hotline at (800) 447-8477 to report them.

• **Marriage certificate:** Con-

tact your state's vital records office to order a copy (see cdc.gov/nchs/w2w.htm). You'll need to provide your full names for you and your spouse, the date of your wedding, and the city or town where the wedding was performed. Fees range from \$10 to \$30.

Note: Divorce certificates can also be ordered from your state's vital records office (fees range from \$5 to \$30), and divorce decree documents can be obtained from the county clerk's office for the city or county in which the divorce was granted.

• **Passport:** A lost passport also puts you at risk for iden-

entity theft, so you need to report this as soon as possible to the U.S. State Department. Go to travel.state.gov/content/passports/en/passports/lost-stolen.html and fill out Form DS-64. You'll receive an e-mail acknowledging that your report was received. Within a couple of days, you'll receive another e-mail (or letter, if you request that option) confirming that your passport has been entered into the Consular Lost or Stolen Database.

You can apply for a replacement passport at a Passport Application Acceptance





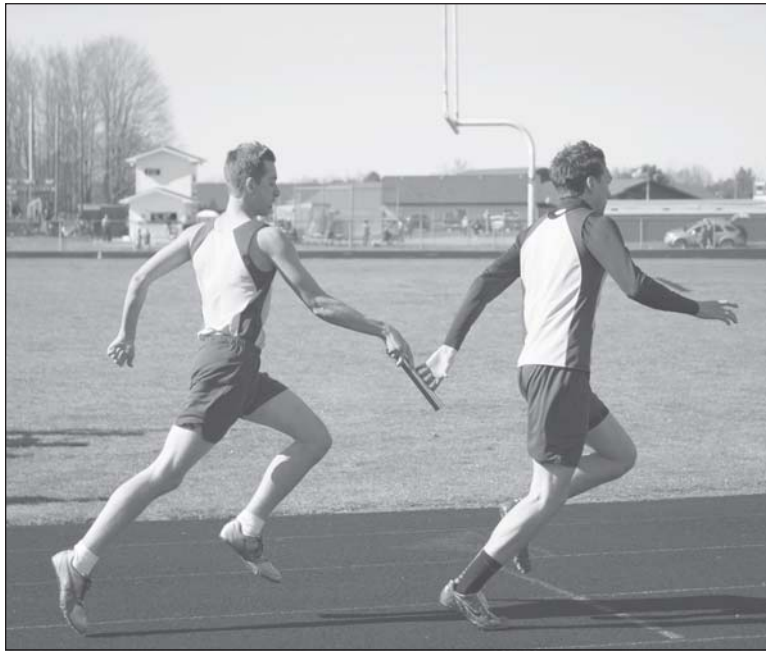

This winter's snow removal leaves divots, dents, and digs

In road commission language, they are referred to as sheepskins—those pieces of sod rolled up on the shoulder of the road by snow plows. And this year there is a flock of them throughout the county due to the weather conditions experienced over the winter.

Normally, in late fall, temperatures drop to freezing and the ground hardens before snow falls. When it snows, the frozen surface underneath provides some resistance over which snow plow blades scrape without digging into the surface.

This past season, however, temperatures stayed above freezing longer than usual, so when the snow came, it actually insulated the ground from freezing temperatures, and the surface underneath did not freeze. So when a heavy truck with a rigid, unforgiving blade that is removing snow off of the traveled portion of the road onto the soft shoulder, sheepskins are born.

"It is impossible to avoid digging into the shoulder under the conditions we experienced this winter," said Jesse Campbell, Alcona County Road Commission managing director. "Making matters worse, the weather worked against us all winter with several above freezing days, followed by wet, heavy snow events."

"The problem is widespread and is frustrating to many property owners," Campbell said. "But road crews were only attending to the job of clearing snow in an

effort to keep roads in as reasonably safe condition as possible. If property owners choose to improve the roadside within the right-of-way along their property, that's a choice the property owner makes. But the road commission does not have the time, staff, or resources to make restorations, if damage occurs there from routine road maintenance operations," Campbell said.

Campbell explained that in most areas the road right-of-way is 66 feet and is dedicated by law for public use solely as a roadway and for maintenance of that roadway. As such, the right-of-way should be used only for those purposes, and not for dumping of leaves, brush, and lawn debris, erecting fences or other structures, or for encroachments of any type.

Trout season has arrived

Trout season officially opened last weekend on Michigan's inland waters and early season fishing can be quite good.

Many anglers successfully swear by dead drifting worms this time of year due to the cold spring waters temperatures, but those heading out should not overlook spinners or small shallow diving crank baits either.

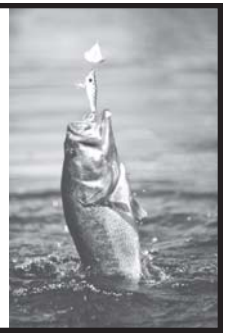
Worms are deadly in the early season but lure fishing can also be very effective at bringing up a big fish from its deepwater lair under a log or under a cut bank.

cleaning station was still closed however the docks are in and the ramps are open. Fishing activity remains very light.

• Cheboygan River: Is producing good numbers of steelhead, suckers and walleye. Steelhead were caught on spawn, jigs and worms. Walleye were hitting on jigs, crawlers and stick baits.

Suckers were caught on crawlers and spawn. Northern pike and smallmouth bass are also in the river.

• Rogers City: The marina is open and all the docks are in. When anglers can get out, a few lake trout were caught along the shoreline in shallow waters and out to waters 60 feet deep with high-lines. Out deep, fish the bottom with cowbells or dodgers with a spin-glo. Hot spots were Swan Bay or Adams Point.

Atlantic salmon should start showing up anytime so try Swan Bay, Calcite Harbor or the breakwall with bright colored spoons and body baits. Good colors to try are orange, silver, green, chartreuse or yellow.

• Presque Isle: Atlantic salmon were caught in the North Bay, directly out of the harbor and near Stoneport. Try spoons and body baits in green, silver, orange, and yellows. Lake trout were caught north of the marina between the two lighthouses in 20 to 90 feet with dodgers or cowbells and spin-glos just off the bottom.

• Alpena: Boat anglers trolling for lake trout and walleye in Thunder Bay had limited success. Bass anglers are doing well in the shallows.

• Thunder Bay River: Steelhead are still moving up the dam and have been caught while drifting spawn and trout beads or casting small spoons and spinners.

• Oscoda: Pier fishing is starting to pick up as those casting late at night have caught walleye and lake trout on spoons, body baits and stick baits. A couple of steelhead and Atlantic salmon were caught on minnows in the early morning or evening.

• Tawas: Pier anglers took a couple walleye when casting body baits. Walleye and pike were taken off the mouth of the river.

• AuGres: A couple boats did get out and caught walleye in 10 to 25 feet between Point Lookout and Pointe Au Gres. Shore anglers caught a couple of pike near the mouth of the river.

Fierce Forest Fires

Michigan All Ablaze Alcona County Not Excepted.

May 14, 1891 - The smoke which enshrouded this section last week Friday and Saturday like a funeral pall, was general throughout the northern part of the state. In almost every section of the pine, land districts fires were raging and the dense volumes of smoke arising therefrom enveloped the surface of the earth, shutting out the sun's rays and filling the minds of citizens with a dread uncertainty. The impenetrable veil of smoke rendered it impossible to locate the fire. No one could tell whether it was raging in their immediate vicinity or miles away. From Manistee to Alpena and from Cheboygan to Bay City, east and west, north and south, the same dense cloud hung upon the surface of the earth. The fires, starting in the dry dead timber that litters the stripped lands of northern Michigan found plenty of fuel, and fanned by a stiff breeze, it swept rapidly over immense areas, carrying with it everything in its path of an inflammable nature. Dwellings, saw mills, shingle mills and small hamlets have been swept away like so much chaff, entailing an immense loss of property.

In this immediate vicinity the damage has been confined principally to standing pine and timber on skids and railways, but that has been considerable. Last Friday the road north to Black River was a seething furnace in places and teams could not get through. The woods and swamps about Black River were burning fiercely. The air was filled with sparks and the citizens of the village were on the alert constantly to sup-

Those were not small potatoes.

May 14, 1891 - How many potatoes have been shipped out of the county during the past season? Jackson & Lee of Toledo have purchased and shipped 7,000 bushels, for which they paid from 65¢. to 90¢. a bushel. W. N. Vohlers of Bay City has shipped a couple of thousand. About 2,500 bushels have been shipped from West Harrisville to Black River and Au Sable. Harrisville, with what are awaiting shipment, will add 1,500 bushels more to the amount. Besides these direct shipments there have been probably as many more hauled to camp, to Black River, Alpena, Au Sable and Oscoda by teams bringing the grand total close up to 30,000 bushels. The largest single sale of potatoes reported was one of 1,100 bushels by J. Van Buskirk to Jackson & Lee.

press any incipient blaze that might start among their dwellings. At one time the danger seemed so great that Alpena was called upon for assistance, and Engine No. 1 with four men came to their relief. Fortunately the village survived the impending doom.

Richard Armstrong, a farmer living three miles north of Harrisville near the

Alcona state road, was less fortunate. His farm buildings were in close proximity to the woods and when they caught fire his house and barn were subjected to a baptism of burning sparks which ignited the buildings in a dozen places at once. The neighbors rendered such assistance as they could, but it was of little avail and soon the buildings were burned to

the ground with most of their contents, excepting a small quantity of bedding.

A barn belonging to Perley Silverthorn was also burned. Some buried their household effects in the ground expecting that everything else would be burned.

All through the country the fires raged with equal fierceness, but so far as we have learned settlers else-

where escaped serious loss. The woods west of the railroad were all afire Saturday and a vast amount of timber has undoubtedly been destroyed, the value of which it is impossible to estimate.

Sunday the fires seemed to be subdued somewhat and the heavy smoke disappeared and at this writing the fire seems to have spent its force.

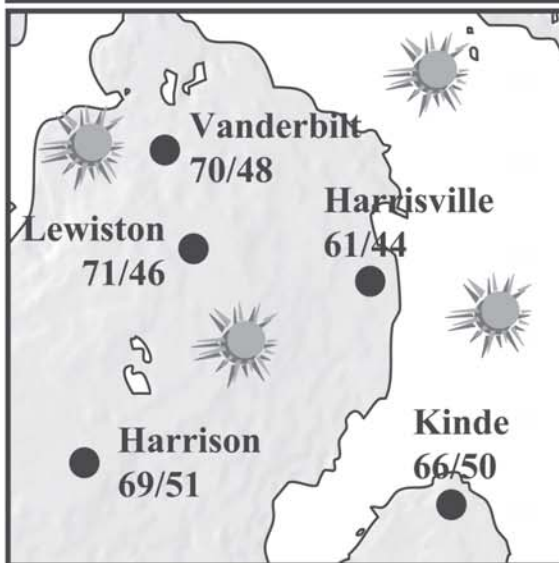

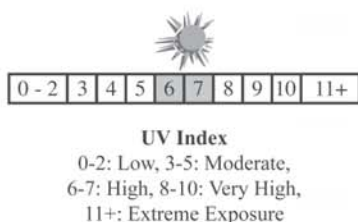

StarWatch By Gary Becker - Mercury to Transit Sun

Eclipses, transits, and occultations... They are some of the rarities of astronomical observations. An eclipse occurs when a larger object like the moon covers, or partially covers, another large object like the sun (solar eclipse) or the moon is hidden by the Earth's shadow in a lunar eclipse. Occultations happen when a larger object, like the moon, a planet, or even an asteroid hides an even smaller object, such as a star. Planets can occult asteroids; asteroids can even occult stars. Obviously, stars are gigantic compared to the moon, an asteroid, or a planet, but the great distances of the stars from the Earth make them appear merely as points of light in the night with actually no real physical size. Transits, in a sense, are the opposite of an occultation. They occur when a much smaller object like Venus or Mercury pass in front of a much larger object, in this case, the sun. The last transit of Venus was on June 6, 2012. The next Venus transit that we get to witness in North America is on December 8, 2125. Boy, am I looking forward to that one! Mercury, on the other hand, transits the sun more frequently, 14 times during the 21st century. The last transit of Mercury was on November 8, 2006, but East Coast weather was cloudy on that day. The one before that in 2003 was also on a cloudy day. Weather is not the only concern because many times these events happen on the other hemisphere of the world, when it's nighttime here so again we miss out. Will Monday, May 9, prove to be any different? Mercury again transits the sun starting at 7:12 a.m. Greatest depth across the sun's disk happens at 10:57 a.m., and it is all over by 2:42 p.m. Unfortunately, Mercury transits are not for the unprepared. They require telescopes or a good set of binoculars, but most importantly, they must be properly filtered to reduce the sun's intensity and prevent infrared radiation from heating up and burning the eye's retina. 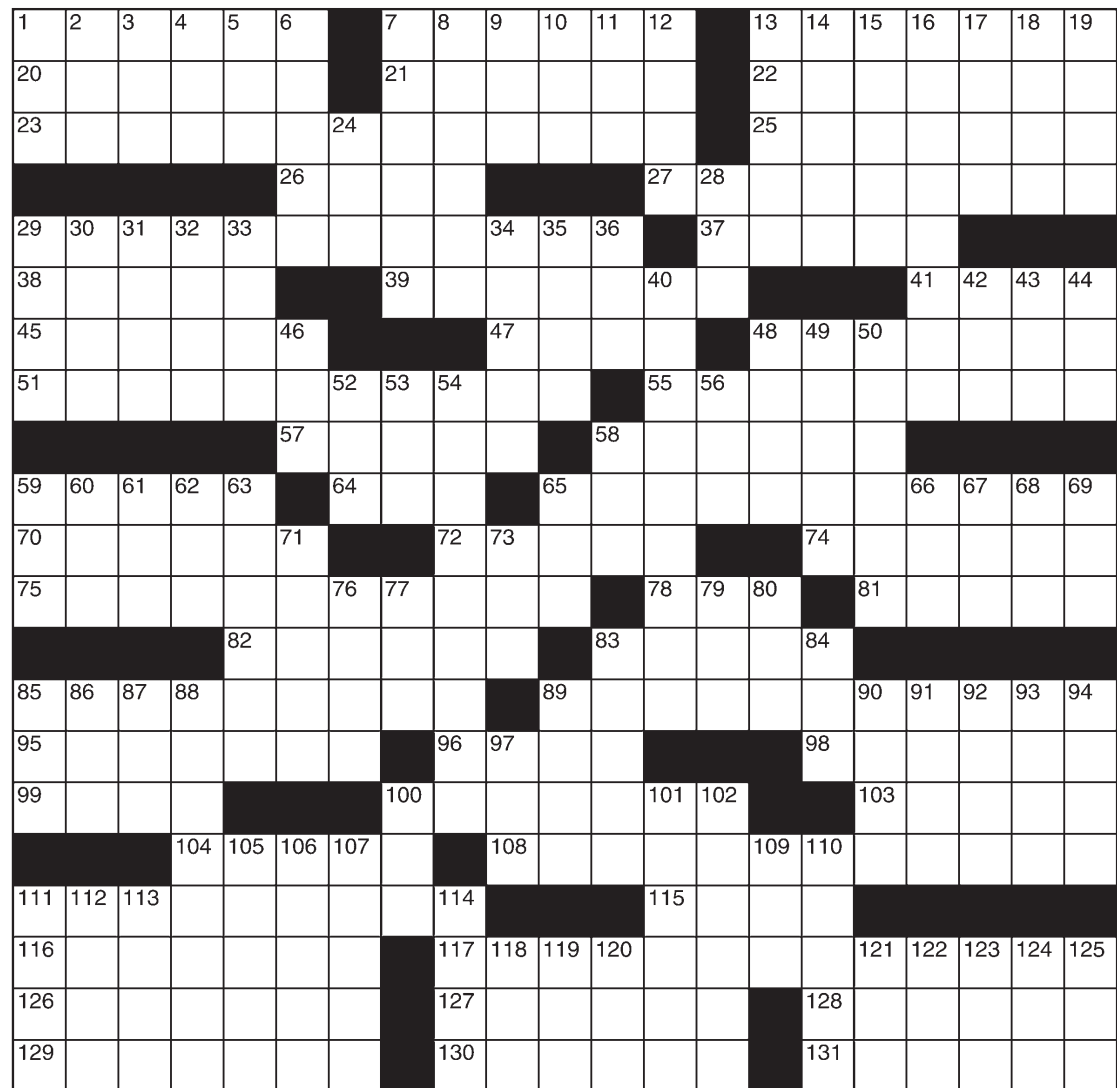
- On May 24, 1883, after 14 years and 27 deaths during construction, the Brooklyn Bridge over the East River in New York is opened, connecting Manhattan and Brooklyn. It was the largest suspension bridge ever built to that date.
- On May 26, 1897, the first copies of the classic vampire novel "Dracula," by Irish writer Bram Stoker, appear in London bookshops. Stoker published 17 novels in all, but it was "Dracula" that brought him literary fame.
- On May 23, 1900, Sgt. William Harvey Carney is awarded the Medal of Honor for his bravery on July 18, 1863, while fighting for the Union as a member of the 54th Massachusetts Colored Infantry. Carney was the first black soldier to receive the Medal of Honor.

- On May 25, 1994, the ashes of 71-year-old George Swanson are buried in the driver's seat of his 1984 Corvette in Pennsylvania. Swanson had bought 12 burial plots to ensure that his beloved white Corvette would fit in his grave with him.
