## Rep. Peter Pettalia dies in motorcycle crash

Northeast Michigan lost a son, friend and advocate in the death of Representative Peter Pettalia Monday evening.

The Michigan State Police and the Montmorency County Sheriff's Department are investigating the fatal traffic crash that killed Pettalia at 5:30 p.m. on Monday, Sept. 12 on M-33 in Loud Township in Montmorency County.

"Pettalia was southbound on M-33 near C.R. 612 on his motorcycle, when a pickup truck driven by a woman from Fairview turned left, directly into his lane. His motorcycle struck the pickup truck broadside. Pettalia was wearing a helmet at the time of the crash. The driver of the pickup truck was alone and not injured in the crash," according to a press release from the state police.

Lt. John Grimshaw, commander of the Michigan State Police post in Alpena, said

the name of the driver is not being released at this time. "Once the investigation is complete, the findings will be presented to the Montmorency County Prosecutor for review to see if any charges will be filled," Grimshaw said.

Pettalia, 61, was in the last months of his third term in the State House of Representatives. He was elected to his first term in office in 2010 and was re-elected in 2012 and 2014. He represented the residents of Alcona, Alpena, Presque Isle, and Iosco counties, as well as 13 townships in Cheboygan County. He was chairman of the House Committee on Transportation and Infrastructure and was vice chairman of the Financial Services Committee. He was also a member of the Energy Policy and Tourism and Outdoor Recreation committees.

He is survived by his wife, Karen. They were married for 34 years and have two adult children, Anna (Brian) Skowronek and Peter Pettalia II.

Pettalia had been a resident of Presque Isle Township since 1977. He operated an auto repair business for 33 years, with his business partner. He also operated a seasonal cabin rental business on Grand Lake.

He was an avid sportsman who enjoyed deer hunting, snowmobiling and fishing in northeast Michigan. In addition

to his businesses, Pettalia was involved in his community — he served as the Presque Isle Township supervisor for 16 years and was a volunteer fire fighter for East Grand Lake Fire Department for 15 years. He was the vice-chairman for the State Park Advisory Board for Negwegon, Rockport and Thompson Harbor State

Parks. He was one of the founding members of the Presque Isle County Economic Development Commission and the Community Development Commission.

Governor Rick Snyder and many officials throughout the state have made statements of sympathy to Pettalia's family, friends and constituents. Gov. Snyder has ordered flags to fly at half-mast throughout the state to reflect the loss of service to the state.

"I was shocked and deeply saddened to hear about the passing of my friend and colleague, Peter Pettalia. Pete was a common-sense public servant who loved his state, his friends and his family. He was passionate about life and about northern Michigan. Pete was truly one of the good guys who did his best to improve the lives of the people in his community. He will be greatly missed by everyone who was blessed to know him," said his colleague and friend, State Senator Jim Stamas (R-Midland).

## New academic year begins with school resource officer in place

The first day of school can be exciting, fun and a little bit intimidating for students as they begin their new academic year. The same can be true for anyone starting their new job.

One Alcona County resident did both on the same day — he went back to school for the first time in 38 years and started a new job.

The new job is school resource officer with the Alcona County Sheriff's Department and the person who experienced his "first" day of school last week is Warren MacNeill, a 1978 graduate of Alcona High School.

MacNeill, who was born and raised in Alcona County, has spent the last 23 years as a conservation officer for the Michigan Department of Natural Resources (DNR). He had been contemplating retirement for more than a year, but was undecided about what he would do once it was official.

When the part-time position was presented to him by Alcona County Sheriff Doug Atchison, MacNeill did not hesitate. While he has spent time at the school with administrators, teachers and staff members and attended training, his first official day was Tuesday, Sept. 6.

"On Sunday I was pulling

people out of Lake Huron and on Tuesday I was opening ketchup packets in the elementary school cafeteria... I have been in public service since I was 17 years old and I have found it fulfilling, but not as fulfilling as the last week," MacNeill said as he was lightly slapping hands with elementary students as they filled through the hallway to class on Friday morning.

"The children of our community and their safety are the number one reason for the return of a law enforcement officer in Alcona Community schools," said Sheriff Atchison. "During discussions with the citizens of Alcona County the most frequently asked question is 'when are we going to get an officer back in the school?'"

"This past year I have worked with the county commissioners and school administrators in an attempt to make this a reality. I am very pleased to start out the 2016-2017 school year with an officer back in the school. Recent events have made society a little more dangerous and it is our job to protect our loved ones."

"As for the individual behind the khakis and polo — a better fit could not be found. Officer Warren MacNeill brings to the school a level of professionalism that is easily

recognized, a desire to provide the absolute best care and compassion for our young ones, and enthusiasm — just take a minute to talk to Warren about his new job, you'll see the enthusiasm," Atchison said.

"Law enforcement has been painted in dark shades of grey with negative overtones in the national media. I am certain that Warren will project an image that will put

a better light on the reality of a true police officer," Atchison said.

Dan O'Connor, high school and middle school principal, is pleased with the addition of a school resource officer and, the person filling the position. "We are eternally grateful for the commissioners' support and collaboration between the sheriff's department," O'Connor said. "This is a great thing for kids

and our community.

"Officer MacNeill already attended a training this summer with our school success workers (Sue Sexton and Kari Kubik) in a program called Restorative Justice. Warren

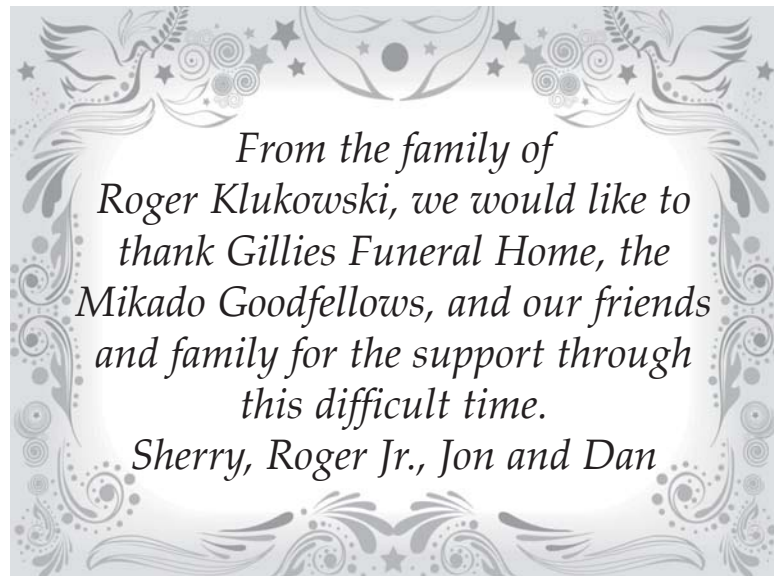

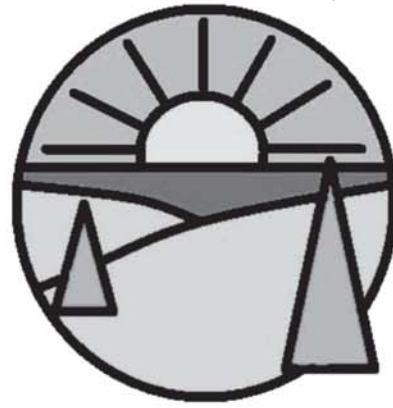

will be heavily involved in working with students, eventually, through this system to help intervene in student issues before a situation leads to suspension. (This program) is in its infant stages, but it can, and will, be a very powerful tool for our students to develop the skills to communicate when problems, or potentially volatile situations, are on the verge and deal with them in a way that promotes thoughtful discussion," O'Connor said.

Even though he is still figuring out how to execute the complexity of the position, MacNeill, who is extremely proud of the fact that six generations of his family - including his wife, Judy, and their two children - are graduates of Alcona County schools, has taken the responsibility very seriously.

"Life is the most important thing... No one gets hurt on my watch. I know this is a cliché, but that's how I feel about this (position)... I believe our school system is one of the safest, but why not keep it the safest? If you can have security, why not have security? I am the fire extinguisher on the wall..." MacNeill said.

At this point, with the position unfolding, MacNeill is taking a three-pronged approach: Safety and security of students and staff; being an advocate for the criminal justice system with students - primarily keeping them out of the criminal justice system; and being an informal counselor and friend - someone they can talk to.

"My door is always open when I'm here," MacNeill said. "They can come in and close the door and whatever they say stays confidential - unless the law dictates otherwise. It doesn't have to be school related... but, I will tell them right away if there is something that can't stay confidential. I am always going to be one hundred percent straight with students.

"The same is true for teachers, staff or parents. I am an employee of the Alcona County Sheriff's Department.

If parents wish to talk to me and they have a concern about something, they can come to me too," MacNeill said.

He has found the transition from a job that involves protecting the state's natural resources, and executing other law enforcement duties, to working within the school system with students and employees quite smooth. "It's still community policing - which is what I've done throughout my law enforcement career. This is a community - it has its own social structure, there is a restaurant (cafeteria), a store, a bank (credit union branch) and different societal groups - now it has its own police officer."

MacNeill served in the U.S. Marine Corps for three and a half years following graduation. After his military service he returned to Alcona County. He worked for Alcona Tool and Machine for roughly nine years while taking criminal justice classes and machine classes at Alpena Community College and volunteering with the Lincoln and Alcona Township fire departments. In 1990 he joined the DNR as a fire officer. On Aug. 1, 1993, after completing 18 weeks in the DNR recruit school (police academy) and four months in the officer training program, he began his career as a law enforcement officer with

the DNR.

A career that was spent in the county he loves - Alcona County. "I had the opportunity to transfer and (be) promoted, but I didn't want to move. This is where I wanted to raise my children, where I want to retire and where I want to die - hopefully, not soon," MacNeill said.

While raising his children, MacNeill got involved in the activities they were in - he was a Little League coach, a Cub Scout leader - and patterned his lifestyle after his uncle, Roger Jamieson, who spent as much time doing things with youth as he could. "There are times when my schedule could be flexible and on snow days I'd plan activities for kids - sledding, ice fishing - we had a lot of fun."

Within the DNR, in addition to being an instructor for conservation officers in a variety of aspects, MacNeill also taught safety programs for youth - hunter's safety, off road vehicle (ORV), snowmobile and boat safety classes.

Without realizing it, he has been preparing for this position most of his life.

"I have gained some skills over the years and I am looking forward to people taking advantage of that (in this position)" MacNeill said. "One of the surprises I've had so far is the level of caring that the staff has for students... It is contagious. I am looking forward to a good year."

## Cheap cell phone plans for seldom calling seniors

Dear Savvy Senior,

What are the cheapest cell phone options available to seniors today who only want one for emergency purposes or occasional calls? I have a cell phone now that cost me \$30 per month, but I hate paying for something I hardly ever use.

Infrequent Caller

Dear Infrequent,

For seniors who don't use their cell phone very often but still want one for emergencies or occasional use, there are a many super-cheap plans available, or depending on your income level you may qualify for a free cell phone.

For seniors who are light/infrequent cell phone users, "prepaid" or "pay as you go" plans are the way to go if you want to save money. With these services, you buy a certain amount of minutes (for talk or text) that must be used within a specified period of time.

While many cell phone providers still offer these lower cost plans, the very best/cheapest deal available today is through T-Mobile's pay as you go plan (T-Mobile.com, 800-501-0952).

For just \$3 per month, this plans provides any combination of 30 minutes of talk or 30 text messages. If you want more, you can pay an additional 10 cents per minute/message when you sign up, or you can make adjustments later. You also don't have to worry about overage charges with this plan, because once you reach your talk/text limit for the month, the phone stops working. And, if you have a compatible device, you won't need to purchase a new cell phone.

If you're looking for a little more talk time or text messages, another low-cost option is Pure Talk USA (PureTalkUSA.com, 877-820-7873), which offers a Senior AddVantage 80 Plan. This plan provides any combination of 80 minutes of talk or 240 text messages for only \$5 per month. Pure Talk also accepts unlocked phones and they don't have overage fees.

If you would rather have a senior-friendly phone with a large keypad and simplified features, and an "SOS" emergency alert button, the Doro PhoneEasy 626 sold through Consumer Cellular (ConsumerCellular.com, 888-532-5366) is the best, low-cost option. It runs \$50 for the phone, with calling plans that start at \$10 per month.

If your income is low enough, you may qualify for a free cell phone through the Lifeline Assistance Program. This is a government-sponsored program that subsidizes wireless (and landline) companies who in turn provide free cell phones and usually between 250 and 1,000 minutes of free monthly talk time and texts to low-income Americans. (Some programs in some states charge a small monthly fee.)



Savvy Senior

The free phones and minutes are provided by a number of big prepaid wireless companies like Safelink, Assurance Wireless and Budget Mobile, along with a host of other regional carriers throughout the country.

Most states have several wireless companies that provide the free phones and minutes. If you are eligible, the free cell phone you'll receive is a basic phone that also offers text messaging, voice mail, call waiting and caller ID.

To qualify, you'll need to show that you're receiving certain types of government

benefits, such as Medicaid, Food Stamps, SSI, home energy assistance or public housing assistance. Or, that your household income is at or below 135 or 150 percent of the Federal Poverty Guidelines - it varies by state. To find out if you're eligible, or to locate the wireless companies that provide Lifeline government cell phones in your state, visit LifelineSupport.org.

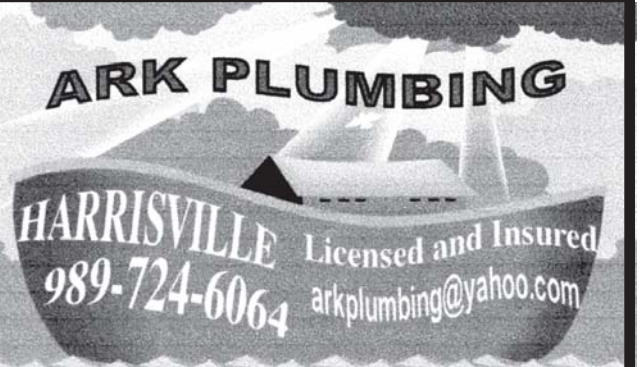

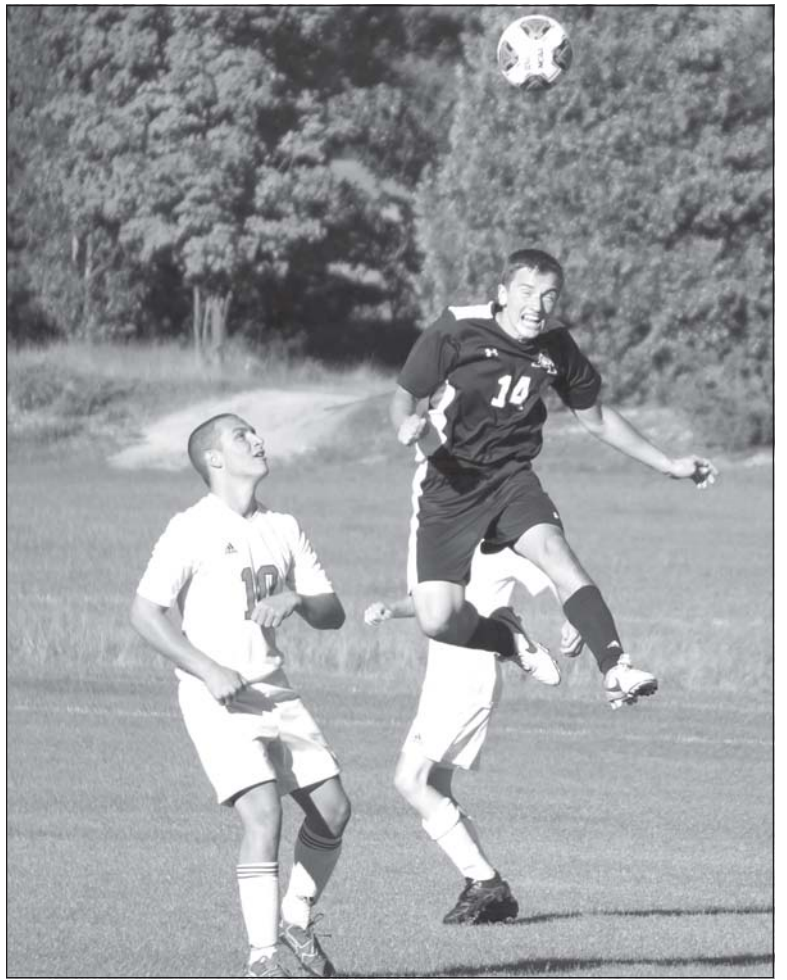

Brock Franklin was the catalyst on offense, as he ran for 182 yards and made three touchdowns on 19 attempts.

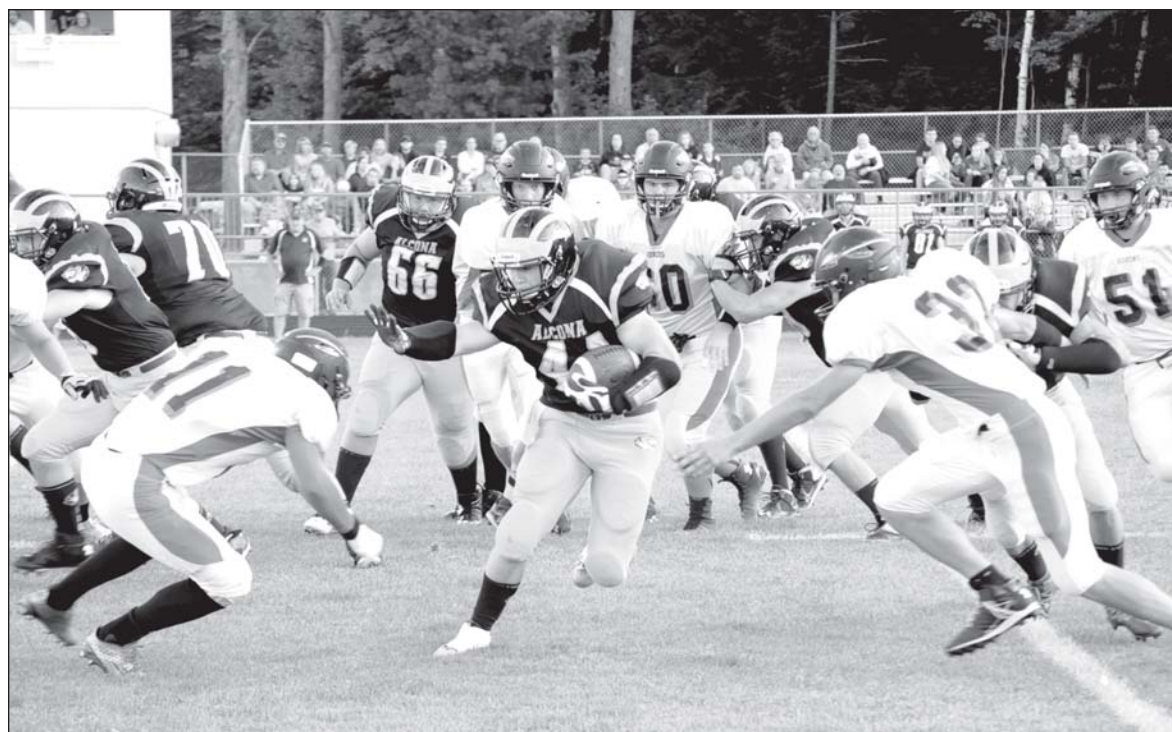

# Fall crappie fishing... difficult, but not impossible

Although plentiful and easy to fish for in the summer, crappie can be difficult to target as the weather cools off. Difficult...but not impossible.

One thing anglers should do is look for good water as crappie can be found in areas with higher oxygen content. For instance, target spots where streams dump into the lake or areas where the lake has yet to turn over. You could also head towards locations where the wind and waves are strongest.

Another thing for anglers to remember is to pay attention to the weather. When it's

very sunny out crappie will stick close to the bottom, but when it's cloudy they're likely to be within a few feet of the surface.

And lastly, try a variety of baits when you're out crappie fishing. These should include bright, flashy lures during poor visibility and live bait during periods of lake turnover. It's hard for crappie to turn down a jig tipped with a minnow.

### Northeast Lower Peninsula September 8

• Mackinaw City: Fishing slowed as most of the large Chinook were moving past

Mackinac Island to their staging areas. A few smaller Chinook and pink salmon were taken spoons. Lake trout fishing was still good for those using dodgers and spin-glo's in the area.

• Cheboygan: A few boat anglers had some good catches of Chinook salmon caught when trolling from the Cheboygan River to a half mile out near the shipping channel. A lot of boats got zero to three fish and many struggled. Most were taken in 40 to 90 feet with J-plugs, flashers and flies or the occasional spoon.

A few lake trout and pink

salmon were caught by those traveling further out to Spectacle Reef and Cordwood Point. A good number of bigger pike were caught by those bass fishing or trolling for salmon between the mouth of the river and the Coast Guard Station.

• Cheboygan River: Still has only a few Chinook salmon present. A couple of fish were taken on body baits but the majority were taken by those drifting skein. Some caught a few walleye, rock bass, smallmouth bass, bullhead, longnose gar and catfish. Smallmouth bass numbers are lower than most ex-

pect this time of year and the fish were smaller 14 to 16 inches.

• Mullett Lake: Walleye fishing picked up and those targeting the "humps" area did well when trolling when trolling a crawler harness and body baits on the bottom. Hot colors were green, chartreuse, pink and silver crawler harnesses. Perch fishing picked up as well with some getting 10 to 20 keepers per trip when using minnows and worms in Pigeon River Bay. Steelhead fishing was slow with one or two fish per trip.

• Rogers City: Boat anglers should have a great week for fishing as south, southwest and southeast winds will push the thermocline up higher in the water column. Chinook are staging off Swan Bay but still out in deeper water. Try 50 to 90 feet with lines run throughout the water column an hour before sunrise and after dark. Calcite, Swan Bay and Adams Point were good places to use spoons, J-plugs, flashers with squid, flies and cut bait or spoons. Hot colors were green, blue, orange, black and white, purple and glow for a mixed bag of trout, salmon and walleye.

• Presque Isle: Cold water arrived and anglers were getting a mixed bag of salmon, steelhead, lake trout, and walleye. The salmon are coming very early before daylight or late in the evening. Lakers and everything else were caught throughout the water column with spoons, J-plugs, flashers with squid, flies and cut bait in the same colors as Rogers City. Try 50 to 120 feet north of the harbor between the lighthouses and south towards Stoneport and False Presque Isle.

• Higgins Lake: Lake trout were caught in 85 to 100 feet. Fish were marked along the bottom and about 20 feet up. Try meat rigs with live bait, cowbells and dodgers. Lots of rock bass are still being caught.

• Houghton Lake: Walleye were caught along the weed beds in 12 feet when trolling a harness with crawlers or leeches. Good bluegill action along the weeds in nine feet with leaf worms, leeches or wax worms. Some nice crappie were caught on pink and purple jigs with minnows. Bass fishing continues throughout the lake.

• Tawas: Had very good walleye and steelhead fishing with spoons and crank baits in 50 to 60 feet off the Crib at Alabaster and lakeward of Buoy No. 2. Fishing was slow for both pier and river anglers.

• AuGres: Those trolling for walleye found a few fish north of Big Charity Island. Perch fishing has taken center stage with some good catches in 31 feet around the Steeples, 40 to 59 feet near the NOAA Weather Buoy and 40 to 50 feet south and southeast of the hotel on Point AuGres.

• AuGres River: Some perch were caught in the lower river however anglers were doing a lot of sorting.

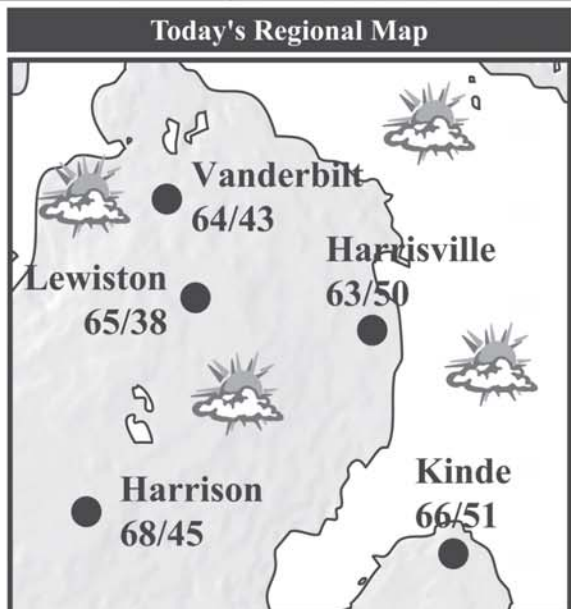

### StarWatch By Gary Becker - Wedding Crasher

It was the Perseid meteor shower that made me do it, crash a wedding in NW Montana this past August. It was just too good a "thing" to let pass—a beautiful lodge by Flathead Lake, incredibly dark skies, a cooperating moon, and a meteor shower that was predicted to be much stronger than average because Jupiter's gravity had perturbed several strands of dross from previous passages of its parent comet, P109/Swift-Tuttle, into Earth's path. Pete, my friend with whom I was traveling, also happened to be best man, and I did know the groom as a teenager. So maybe it wasn't a crash as much as an awkward landing, but it was fun. Pete said that he had never seen anyone "crash" a wedding so gracefully. I'll take that as a compliment. My hosts were also gracious. I got plenty of free meals, plenty of free drinks, and saw plenty of fine Perseids on two nights of consecutive observing. Montana weather can be a little tricky. While dry and partly cloudy to mostly clear on the majority of summer evenings, it can also be responsible for three to four consecutive days of cloudy, rainy weather, and that's what we thought we were going to experience over the best Perseid mornings of August 12 and 13. However, it cleared just after midnight on the 12th and did those Perseids fly! They were brighter during the first several hours of watching with uncorrected visual rates of 30 to 45 meteors per hour. The most impressive part of the shower was the way the Perseids bunched. This may be due to a single larger particle breaking up and its daughter particles separating very slowly over the intervening centuries. The result creates bursts of meteors occurring within a 10 to 30 second interval. We witnessed several bunching episodes where five meteors singled the air in a 30 second period, and one where I saw six Perseids in about 15 seconds. WOW, the adrenaline was really pumping! I saw 184 meteors on the first night and 99 on the second (August 13), my best two consecutive nights that I have ever experienced. [www.astronomy.org](http://www.astronomy.org)

## VILLAGE OF LINCOLN MINUTES

The Lincoln Village Council met on Wednesday, Sept. 7 at 7 p.m. at the village hall. The meeting opened with the "Pledge of Allegiance." Those present included, president Jordan, treasurer Hussain, clerk Somers, and council members Gauthier, P. Somers and Stutzman. Absent were council members Richard Somers, Sara Healy and Amanda Zielinski. Healy and Zielinski joined the meeting a little later.

The minutes of the August meeting were approved on a motion from Gauthier with support from Stutzman. The treasurer's report was approved, subject to audit, on a motion from Gauthier with support from Stutzman.

Fire chief Serafin gave his report. He said there were three fire runs for the past month and six medical runs. There was a training exercise with other neighboring departments and the staff at Lincoln Haven. The turnout was very good. Four fire fighters are attending the MFR training in Alpena. Department members attended and helped at the bump and run and also the mud run. A new side door was installed at the fire hall. President Jordan asked Mike to find out how to repair the siren that is outside of the hall. He also asked about having a sign put out front of the hall designating the fire department/hall.

In old business, Stutzman said he put edging around the memorial tree at the

playground. He advised that the same thing should be done around the other memorial tree at the boat launch. Gauthier asked about the status of the Christmas lights for decorating the village. The Beautification Committee will take care of the white lights for the small trees and we are responsible for the colored lights. Sara will look into it as we need to purchase about 20 sets.

In new business, Gauthier asked about having a bench engraved in memory of a previous village president. The cost is approximately \$600. President Jordan suggested talking to the people who are interested about doing fund raising. We need someone from the council to take over the duties of webmaster for the village website. Amanda Zielinski offered to take on the task. She will be working with Karen Godi and a rep from Accnet to get things up to speed.

President Jordan gave his report. The Trick or Trunk and Soup and Chili Cook off will be held on Saturday, Oct. 29 from 11 a.m. until 1 p.m. There are several street lights that are out and will be turned in for repairs through Consumers Energy. We've had one tree cut down and hope to get more taken care of before winter. Steve has been busy trimming trees around village streets and will be finished soon. Repairs are being made to the loader.

All the wooden street signs have been

stained and are looking great. An offer has been made on the old pontoon that we had used for the beach as a dock. A motion was made to sell the pontoon for \$500 from Stutzman with support from Zielinski. Motion carried. The parking lot by the post office has had electrical issues. It has been fixed by Morgan Electric. The parking lot at the hall has been re-done including the striping. The roadway on Sleeper Drive has been repaired by Goodrich Asphalt Paving. Storm drains will be cleaned out with funds through the SAW grant. He would like to purchase a live trap and a new shop vac for use at the shop. Viking Energy repaired our loader bucket. The sidewalks will be re-sealed soon. The dug outs have been repainted and are looking very good. President Jordan stated that he would like to have more office hours for the village hall and Holly will be doing much of the work. He will be asking for raises when the time comes.

Becky Rivard from Huron Engineering gave a report about the Barlow Road project. She stated that the plan is to do an overlay on a portion of the road which will give a few more years of life to the road. Part of the plan also includes extending the turn lane at Kris Mart. She suggests adding a storm drain at the corner of Main and Barlow roads. Applications are out there for safety grants that are an 80/20 percent match. If we do want to apply for a grant, she stated that she would be happy to write the grant

application for us.

Currently, we are right on track in our plan for the \$130,000 Barlow Road Project through the Region 9 Task Force. A motion was made by Gauthier, with support from Healy, to accept the engineering study and to have Huron Engineering put together a safety grant application to include a left turn lane and storm drains at the intersection of Barlow and Main. This grant could be awarded in 2018. Motion carried.

A motion to amend the general fund budget revenue in the amount of \$3,000 was made by Gauthier with support from Healy. We are adding a line item to accept funds toward the Brownlee Lake Beach/Swimming Dock Project. The funds will be held there until all necessary funds are raised. Motion carried.

Street report: Several trees were taken down, more to be done. Sewer report everything looking good. A motion to pay the bills as presented plus, additional bills from NEMCOG \$605.00; Northeastern Window and Door \$22.90; Auto Value \$175.30; and Huron Engineering \$2,400 was made by Healy with support from Zielinski. Carried. A motion to adjourn was made by Healy with support from Gauthier. Carried.
