# Recall petition determined sufficient for circulation

Approval of wording on a recall petition for a township supervisor was given last week by the Alcona County Election Commission.

The commission, comprised of Judge Laura A. Frawley, Alcona County Treasurer Cheryl Franks and Alcona County Clerk Stephany Eller, read the petition filed by Christopher Clouse which is seeking the recall of Darrell Kenyon, Curtis Township Supervisor, during a public session held at the Alcona County courthouse on Wednesday, Nov. 28.

The election commission gave both Kenyon and Clouse ample time to ask questions, make comments or arguments on the clarity and factual nature of the petition language which states: "Supervisor Darrell E. Kenyon misrepresented the Curtis Township Hall's operating expenses to justify his decision to decline permanently obtaining the building from the Oscoda School District. Supervisor Kenyon continues to misrepresent his intentions regarding township facilities and exclude the public from the decision process. Subsequently depriving residents of a taxpayer maintained facility adequately sized for community functions."

Kenyon spoke several times at length during the session arguing the petition was neither factual or the truth. Commission members explained to him each time they were not there to determine whether it was the truth or

The commission is charged with determining whether each reason stated on the petition is based upon conduct occurring during the official's current term of office and whether each reason is factual and of sufficient clarity to enable the officer's whose recall is sought and the electors to identify the course of conduct that is the basis for the recall.

"It is not our (election com-

# Landmark lost in early morning fire

Fire swept through a landmark business in Harrisville during the early morning of Friday, Nov. 30 reducing it to ashes and rubble.

Fire fighters from four local departments responded to the blaze at Ki Cuyler's Sports Bar and Grill on US-23 in Harrisville at 2:50 a.m. and spent the next seven hours on the scene. The fire spread through the entire building and it is considered a total loss.

According to Harrisville Fire Chief Dan Klukowski, when he and other fire fighters arrived flames were already through the roof and the structure was engulfed in smoke. In addition to Harrisville, Greenbush, Lincoln and Mikado departments responded, along with the Alcona County Sheriff's Department, Michigan State Police and Harrisville Shell. and Alcona County EMS.

Klukowski said the building was not occupied at the time of the fire and no one was injured during the course of fighting the fire. "Due to the complexity of the building it was a challenging fire," Klukowski said. The building had been remodeled several times over the last 60 years. Fortunately, Klukowski said, water was readily available with the hydrant system in the community.

"It was a good mutual aid effort between the fire departments, the sheriff's department and the state police. Of course, none of it could have been done without central dispatch. Without them our job would be impossible," Klukowski said. He was also appreciative of the coffee and snacks supplied by KrisMart, Harrisville BP and Subway

The cause of the fire is undetermined and is being investigated by the Alcona County Sheriff's Department fire investigator, which according to Klukowski, is "pretty much standard procedure." The business has been under the ownership of Tom and Janet Belill of Oscoda since June 2006.

## Distinguished History

The bar, which was originally owned by Max Carvo, became Ki Cuyler's Dugout in 1954 when it was purchased by Harold S. "Ki" Cuyler Sr. He and his wife, Jacqueline (Scheuler) bought it from Carvo with cash after he retired from his management position with the New York Giants. "He got tired of the travel," said Harold S. "Ki" Cuyler Jr., who was nine vears old at the time. "It was

an old, dingy bar then... he cleaned it up and made a lot of renovations and named it Ki Cuyler's Dugout - which is a place where baseball players hang out during a game."

The bar, however, was not named after Harold Sr.'s father, Hazen Shirley "Ki Ki" Cuyler, a Baseball Hall of Fame player born at Sturgeon Point Lighthouse (located north of Harrisville) and died in 1950. "My grandfather did not drink or smoke," Harold Jr. said.

Hazen, who played for baseball teams in Pittsburgh (1921-1927), Chicago (1928-1935), Cincinnati (1935-1937), and Brooklyn (1938) spent his "off seasons" in and retired to Harrisville at the end of his career. His baseball career is well documented, as was his dedication to his community. He was a charter member of several service organizations and an avid outdoorsman.

Harold Jr., who was called "Butch" during his youth in Harrisville, remembered the shock of leaving New York City and returning to Harrisville to live. "I remember saying to my dad, 'what are we doing here we just left New York..."

No one realized it at the time, but Harold Sr. would turn that "dingy bar" into a destination for patrons from around the state and homeaway-from-home for residents for its storytelling, great music, dancing and the feel-

To the Editor,

What on earth is going on? Is anyone in Harrisville Township familiar with the Zoning Enabling Act? Why isn't the zoning ordinance for the township publicly available? Other nearby townships are!

The availability of the ordinance will answer a lot of questions not only regarding the Brew Haus, but will also answer the question of who in the township has what authority.

Seems odd that the planning commission would be hearing a zoning board of appeals issue? The Lister variance request regarding their side yard is not a planning commission issue, it belongs in the zoning board of appeals 125.3604(1). Second, the Arens/Brew Haus site plan review, falls under 125.3501(5); "the Site Plan shall be approved if it contains the information required in the ordinance and is in compliance with the conditions imposed under the ordinance, other statutorily authorized and...."

Furthermore, the Brew Haus, since it is already zoned commercial does not require a noticed public hearing!

Having followed this issue from the early stages, my first question is -- did the applicant, Mr. Arens, have access to the zoning ordinance in the preparation of the site plan? Whoever Mr. Arens hired to develop the site plan

would need to have access to the latest edition of the Harrisville Township Zoning Ordinance. The site plan needs to be developed in accordance with that ordinance.

If it is properly prepared in accordance with the ordinance, and the micro-brewery is a "Use by right or Permitted Use" in the Commercial Zone, the site plan and project shall be approved. Why this project is developing a life of its own is beyond my comprehension.

Stupid mistakes are easily corrected. First, with an apology and second, approve the site plan and move on.



# Ooes Medicare cover dental care?

Dear Savvy Senior,

I will turn 65 in a few months and will be enrolling in Medicare, but I am concerned about Medicare's coverage of dental care. Does Medicare cover dental procedures? And if not, where can I get dental coverage?

Almost 65

Dear Almost,

Medicare's coverage of dental care is extremely limited. It will not cover routine dental care including checkups, cleanings, or fillings, and it won't pay for dentures either.

Medicare will, however, cover some dental services if they are required to protect your general health, or if you need dental care in order for another health service that Medicare covers to be successful.

For example, if you have cancer and need dental services that are necessary for radiation treatment, or if you need surgery to treat fractures of the jaw or face, Mediservices.

Although Medicare's coverage of dental services is limited, there are other ways you can get coverage and care affordably. Here are several to check into.

- Consider a Medicare Advantage plan: While dental services are mostly excluded under original Medicare, some Medicare Advantage plans do provide coverage for routine dental care. If you are considering joining a Medicare Advantage plan, find out what dental services, if any, it covers. Also, remember to make sure any Medicare Advantage plan you're considering covers the doctors and hospitals you prefer to use and the medications you take at a cost you can afford. See Medicare.gov/find-a-plan or call 800-633-4227 to research plans in your area.
- Purchase dental insurance: If you have frequent If you're a veteran enrolled in gum problems and need extensive dental care, a dental

care will pay for these dental insurance plan may be worth the costs versus paying for care yourself. Expect to pay monthly premiums of \$15 to \$40 or more for insurance. To find dental plans in your state, go to NADP.org and use the "find a dental plan" tool. Then review a specific plan's web-





ing of community. Early on, according to Harold Jr., his father wore white shirts and bow ties and his mother, Jacqueline, was "Miss Personality." Storytelling - baseball, hunting, fishing – anything really, was legendary as were the hamburgers. "They were amazing," he said.

According to Harold Jr., his parents were very particular about the type of meat they used, how long they were cooked in a special broiler that Harold Sr. had installed and the type of cheese-which was Velveta. "People used to drive from down below on a nice day to get a hamburger at Ki Cuyler's. In the summer we would sell 200 burgers a day. Even more on a holiday."

"The place was jammed all the time," Harold Jr. said. "It was standing room only on New Years Eve, Memorial Day, Labor Day... Gehres was the sheriff back then and he knew how many people were supposed to be in there, so we patrons and some of the 'characters' who spent a lot of time there and the personality of my mom and dad who were very active in the bar.

"I learned a lot about life there – it was unbelievable. A lot of crazy stuff went on there nothing bad, just crazy," Harold Jr. said. He used to earn money by giving pony rides to kids who were in the the Vietnam War. He was injured and "never played baseball again."

However, he went on to own six companies and retired to Sarasota, Fla. at age 40 and continues to enjoy an active life, especially enjoying water sports, in his retirement. "That time made me understand that if you work hard, are honest and don't

"Oh, so many memories." Harold Jr. said via a telephone interview Monday from his home in Sarasota, Fla. "One of the things that made Ki Cuyler's famous – at a time when no one locked their doors - was the camaraderie, the story telling, the regular like going to church... Harrisville was a wonderful place to grow up. It really made me what I am today," Harold Jr. said. He left Harrisville at age 17 with a baseball scholarship to Western Michigan University. During summer breaks he played in the Amateur Baseball League and named All-American. "It was almost an extension of my house," she said. The Cuylers lived directly behind the bar and "there was a sliding door that opened to the back door of the bar - eventually, it became a window where we passed (cash register) drawers through. It had a big back yard where locals were always tying up animals - cows, horses, goats. I loved animals, so I really enjoyed it... we would clean the bar every Sunday. Mom would clean the bathrooms, I would sweep, my brother would stock the cooler... Hank Stone was the bar tender. I would catch the bus from the bar every morning. If I missed the bus, someone would take me to school.

"The people made the bar. It was a happy place - all of the generations (of people) were comfortable there. It was a place where you met old friends and shared stories. My dad was a great conversationalist - there was a lot of laughter, and an awful lot of love in that town. I felt very connected," Candace said.

She explained there were "beautiful" photographs hung in the back of the bar-photos of Hazen's life. "I wish I had paid more attention back then... they were photos of baseball, of course, but he loved to sing, and dance and he enjoyed hunting.'

# Tis the season for Christmas tree safety

As this holiday season gets underway, Harrisville Fire Chief Dan Klukowski urges residents to be fire smart. He explained that a small fire that spreads to a Christmas tree can grow large very quickly.

He explained that one quarter of home Christmas tree fires are caused by electrical problems. Although Christmas tree fires are not common, when they do occur, they are more likely to be serious. Additionally, a heat source too close to the tree causes roughly one in every four of the fires.

Klukowski offers the following tips to have a fire safe

- Choose a tree with fresh, green needles that do not fall off when touched.
- Before placing the tree in the stand, cut two inches from the base of the trunk.
- Make sure the tree is at least three feet away from any heat source, like fireplaces, radiators, candles, heat vents or lights.
- Make sure the tree is not blocking an exit.
- Add water to the tree stand daily.
- Use lights that are listed by a qualified testing laboratory. Some lights are only for indoor or outdoor use.

Replace any string of lights with worn or broken cords or loose bulb connections.

- Read manufacturer's instructions for number of light strands to connect.
- Never use lit candles to decorate the tree.
- Always turn off Christmas tree lights before leaving home or going to bed.

After Christmas

- Get rid of the tree after Christmas or when it is dry. Dried-out trees are a fire danger and should not be left in the home or garage, or placed outside against the home.
- Check with your local community to find a recycling program.
- lights inside after the holidays to prevent hazards and make them last longer.

in our society."

Candace, who lives in Bingham Farms, Mich. helped manage Ki Cuyler's Dugout from approximately 1974 to 1978 when Harold Sr. was suffering from poor health and Jacqueline lived in Florida while tending to her mother. "It used to have a long bar and there were times when I tended bar in my fluffy blue bath robe and no one seemed to care," she said. "By then it was a different generation... still good people, but a different kind, and still good music..."

Eventually, it was sold in 1980 to Linda and Ed Bartley of Oscoda. During their ownership the Bartleys completely remodeled the business, according to Candace. They raised the roof and put the bar across the south wall. They also added an ice cream stand and a put-put golf course where the Modern Craft Winery tasting room is

At some point before 1994, Jacqueline got Ki Cuyler's back and sold it to Geneva Pelton and Gaye Davis in late 1994. It was closed for several months during the transfer of the liquor license and

some remodeling and reopened under their ownership on May 1, 1995. Because of a health issue, Davis opted out of the partnership, which was picked up by Shelda Petit in 1996. They owned it until the Belills took over in June of 2006.

Geneva, a Harrisville native and resident, had been a patron of Ki Cuyler's long before she was an owner. The loss is "really sad, that's for sure. I feel bad about it. We had a lot of good customers it was a good crowd that came in. I miss being there (as an owner).'

She explained that her father, George Collins, owned the State Park Market in Harrisville from 1959 to 1968 and Harold Sr. used to buy ground burger for Ki Cuyler's famous hamburgers. "(Robert) and I used to come up every weekend (from Grand Blanc, Mich.) and always went to Cuyler's. We had some good times there. We put the baseball memorabilia back up -Jacki sent us copies of the photographs of (Hazen) that we had framed. It was important to keep the memory of Ki Ki and Ki Cuyler's Dugout alive," Geneva said.

# New state fund aids veterans programs

Capital News Service An additional \$2 million in state funds will be awarded in \$25,000 grants to counties

that fund veteran service programs in the fiscal year that started on October 1.

The new County Veteran Service Fund will be operated by the Michigan Veterans Affairs Agency. After all of the base grants are sent out, the remaining funds will be distributed per capita based on the number of veterans in each county.

"I think the bill is a great thing that the Michigan Veterans Affairs Agency fought for and we are going to take things above and beyond with this new money," said Lee Lull, director of Berrien County Veteran Services.

The counties that already have a veterans program must maintain their current funding for services. For the 11 counties that have no program, to qualify for the funds they must hire an accredited service worker for at least 20 hours per week and establish remote access to VA computing systems.

Funds from the grant could be used in Berrien County to improve training for staff members, radio advertising to local businesses and financial management training for veterans, Lull said.

We want to educate local employers to try to incentivize them into hiring veterans," Lull said.

Employers that hire veterans can receive a reimbursement of up to 50 percent of a veteran's salary during the first six months of employment as a part of the Special Employer Incentive program. The new funds will be used to make people aware of that and other veterans services, Lull said.

Michigan is home to over 650,000 veterans, according to a 2015 report by the U.S. Census Bureau.

Wayne and Oakland counties have the most veterans, each with more than 60,000 former service members. More than 15 percent of residents of Keweenaw, Alcona, Ontonagon, Iosco, Montmorency and Iron counties are veterans, which ranks them among the highest percentages in the state.

In 2016, Michigan ranked 44th in per veteran uptake of federal benefits, according to the National Center for Veterans Analysis and Statistics. Michigan also ranks eleventh in veteran population.

If a county accepts the grant money, it must submit quarterly reports to the state documenting the number of claims that have been made and the nature of those claims, Lull said.

Some counties are undecided if they will apply for the grant, said Rick Wiles, director of Cheboygan County Veteran Services. "This bill was designed to help start up or improve veteran service programs in counties that are hurting."

The program does not allow counties to reduce their operating budget. At the moment Cheboygan has sufficient funding, Wiles said.



# James Hamilton dies after long illness

Popular fix-Sheriff Came to Alcona County in 1864

December 5, 1918 ~ Ex-Sheriff James Hamilton, aged 64, died Friday evening, November 29, at his farm home in Harrisville township. He had been bedridden and helpless for eight weeks, due to injuries to his spine received in a fall from the mow of his barn during threshing time.

Mr. Hamilton was born in Canada March 4, 1854, and came to Harrisville ten years later with his parents.

With the exception of a few vears spent in the west, he resided here continuously thereafter. He was one of the best known citizens of the county and was universally estemed. As sheriff of the county for four years (1913-1916) he was a popular official and his cheerful, happy disposition made him friends everywhere.

He is survived by his widow and three daughters-Miss Blanch living at home, Mrs. Max Carriveau of Greenbush and Mrs. Earl Crandall of Harrisville. There are also two brothers, Alexander of Flint and Geo. of California, and two sisters, Mrs. James Thornton of Harrisville and Mrs. Flora Buchanan living in the west.

Funeral services were held in the M. E. church Monday afternoon, the Rev. Fred A. Andrews officiating. The burial service was held at the West cemetery under the auspices of Alcona Lodge No. 292 F. & A. M., of which the deceased was a member.

# Gustin Stock Farm barn burned to ground

**December 5, 1918** ~ The large barn on the Gustin Stock Farm burned to the ground last midnight. A big silo attached to the building was also destroyed.

The fire was discovered about 12 o'clock in the granary part of the barn. The horses and cattle and a small amount of grain were saved, the balance of the contents, including the season's hay and straw, being a total loss with the building.

The property was insured in the Grange.

# Harrisville soldier killed in action

#### Delbert Atchison Falls October 10th On Battle Front in France

December 5, 1918 ~ Official word was received Thursday, Nov. 28, by Mrs. Delbert Atchison that her husband was killed in action on October 10th.

Delbert Atchison entrained from Harrisville April 1, 1918, going to Camp Custer. From there he went to Camp Gordon, Ga., and to Camp McClellen, Ala. He went overseas in June.

He was the son of Andrew Atchison of the Dean District and was one of our best known young men. His death brings the total of Alcona county boys who gave up their lives for their country since the beginning of the war to thirteen.

# **StarWatch By Gary Becker - Ready for Comet Wirtanen?**

\* Last Friday, November 30, I saw Orion the Hunter, probably for the first time in several weeks. It got me to thinking about the actual chances of seeing Comet 46P/Wirtanen because December is the cloudiest time of the year for the East Coast, averaging about three clear-to-mostly-clear evenings per month. What I have gleaned from a lifetime of interest in astronomy and making observations is that when an important event occurs, you prepare for it regardless of the meteorological expectations. So make sure you've got the binoculars or camera and tripod ready and that you know how to operate them in the dark. I am going to concentrate on the two best evenings to make an observation, the 14th and 15th of December when Wirtanen will be passing the Pleiades or Seven Sisters. An online map, produced by Cometwatch.co.uk, can be found at astronomy.org/StarWatch/December/index-12-18.html#12-2-18. The map has been changed to show Wirtanen's location for 7 p.m.

EST. On both evenings the comet will be in the same binocular field of view as the Pleiades, which if it is clear, should make it relatively easy to spot if 46P/Wirtanen continues to brighten as expected. If you are outside around 10 p.m., Orion will be in the southeastern sky, its three bright belt stars pointing upward towards a V-shaped grouping of stars, the head of Taurus the Bull. In suburbia the "V" should be observable without optical aid on a clear night, but if not, use those trusty binoculars to spot it. Continue upward just a little farther, following the line of sight of Orion's belt stars, and you will come across a gossamer clump of haze and dim luminaries. That will be the Pleiades, bright enough even to be visible from mid-sized towns. Check them out with binoculars, and you'll see a tight grouping of dozens of blue stars, an indication that the Pleiades are relatively young, about 115 million years of age. Wirtanen will be on the Aldebaran side of the Pleiades on the nights of December 14 and 15. More about Wirtanen in next week's StarWatch. www.astronomy.org
