Local churches unite to bring tent revival to Harrisville

A collaboration of nine local churches will host the first old-fashioned tent revival of its kind in Alcona County.

The three evening event, sponsored by the Alcona County Clergy Association, will be held under the big tent at the Harrisville Harbor from Sunday, July 15 to Tuesday, July 17. It will include upbeat music, testimony and gospel inspiration from 7 to 9 p.m.

The Alcona County Clergy Association is made up of representatives from local churches and include Pastor Char McGuire of Community Christ Church in Mikado; Pastor Claire Duncan of Haynes Community Church in Harrisville; Dick Nelson,

membership elder of Spruce Presbyterian Church; Charles Sheldon, evangelist, representing Lincoln and Harrisville United Methodist Church; Jane Meyer, member elder of Westminster Presbyterian Church in Harrisville; Pastor Ken Krause of Westminster Presbyterian and Spruce Presbyterian churches; Pastor Edward Morrison of Solid Rock Church of God in Harrisville; Pastor Dr. Aire VanBrenk of First Baptist Church of Lincoln; and Sue Wander, evangelist, representing St. Andrew's Episcopal Church in Harrisville.

The clergy explained a revival is an evangelistic style service or meeting which reaches out primarily to people in the community who need to hear the gospel of

Jesus Christ. It's geared toward people who may not attend church at all or folks who once belonged to a church, but no longer go. People who worship God regularly are also welcome.

They feel the revival is for anyone in need of spiritual renewal or healing, anyone who is feeling discouraged or perhaps felt something was missing from their life. The revival is meant to offer those in need, encouragement and hope.

The clergy is hoping everyone enjoys the event, no matter what their age or background and said even crying babies are welcome to join in song and praise.

"People should go because God loves them, and he wants to tell them how much he loves them. He cares about them and wants to help them with their everyday situa-

tions. This is just an event to reach out to the people in our community with the gospel," Sheldon said.

Sheldon, who has over 44 years of preaching experience, will be the featured evangelist speaker during the event.

Dick Nelson said the event is being offered collaboratively as a way for all the churches to come together to bring the Kingdom of God to those who don't know it and no certain denomination will be featured or mentioned during the event.

"It's an impressive undertaking because we have so many churches of different denominations coming together. The coming together of these churches is one of the reasons I'm so enthusiastic to be involved in the event. It's a totally new experience for the community that

could really be profound," Nelson said.

McGuire said it showed her there was a unity, "We all believe in the trinity, Christ, death, resurrection and salvation. There is a unity no matter what a particular denomination might think. This event breaks down (denominational) barriers that I think Christ never intended to be put there.

"Hopefully this will help people understand that Christian denominations basically believe the same thing. There are basic truths through Christianity, even though we all have a few different things we believe, which are not essential to salvation, we agree on the essentials," Duncan said.

The clergy group is looking forward to people hearing and

Two candidates running for District 4 county commission seat

Alcona County voters in District 4, which includes Gustin, Hawes and Haynes townships, have a choice this August between two Republican candidates, Adam Brege and David Bielusiak vying for one two-year seat on the Alcona County Board of Commissioners.

Incumbent Adam Brege has been the commissioner representing District 4 since he was elected two years ago.

He was three years old when his parents moved to Alcona County. He grew up attending Alcona Community Schools and graduated in 1993. He then attended Alpena Community College. However, most of his education has been on-the-job training. Brege has worked mainly in automotive manufacturing, engineering, project management and design for about 22 years.

He said his career has given him a lot of experience handling multi-million-dollar projects from beginning to end. He has many years of experience handling sales, estimating the project price, pricing and purchasing components and managing labor aspects. He explained that running the county as a business requires similar skills. His experience in budgeting, labor practice and managing employee skills effectively to the commissioner table

makes him effective as a county commissioner.

Brege's experience as a Gustin Township trustee and zoning administrator prior to becoming supervisor for the township in 2015 has also helped to him to be a successful in his duties as county commissioner. He gave up his supervisor role when he took the commissioner seat, but still acts as the township's zoning administrator.

"I really wasn't sure I wanted to make the move from township supervisor, but I thought it was a logical next step. I wanted to be involved. I figured if I could move up a level I could apply some of what I know to a

broader base of people.

"Being a township supervisor is a good introduction for what is involved, but honestly, even with the prior experience, I didn't feel my feet were hitting the ground until six to eight months in (the commissioner seat). There is a lot of nuances and little things that happen which is not in a book," Brege said.

Brege said the sales experience he has had working with people over the last 15

Mr. LeClair built and remodeled residential homes throughout Alcona and Alpena counties.

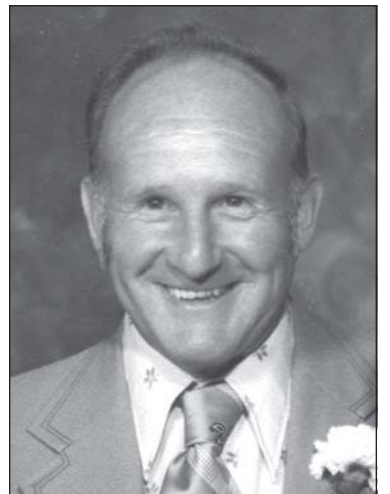
He was devoted to his family and his church and was active in the community. He had a beautiful singing voice and often sang in wedding celebrations for his friends and relatives.

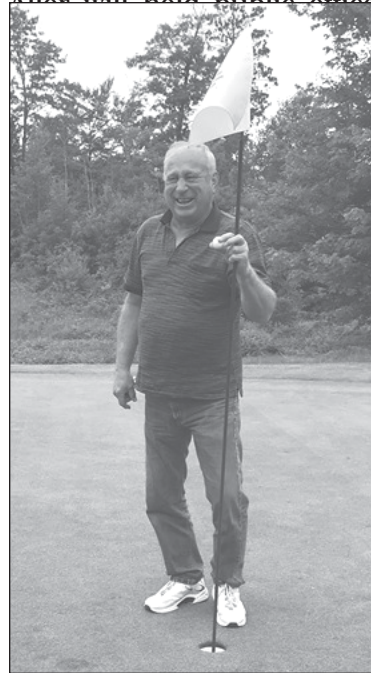

Can a debt collector take my Social Security benefits?

Dear Savvy Senior,
Can my Social Security benefits be garnished if I have some outstanding debts? I just turned 62 and would like to start collecting my retirement benefits, but want to find this out before I apply.
Worried Retiree

what you owe. Supplemental Security Income (SSI), veterans benefits, federal employee and civil service retirement benefits, and benefits administered by the Railroad Retirement Board Administration can't be touched either.

cannot be garnished under any circumstance.)

How much can actually be taken depends on the type of debt you owe. In most situations, the government can pull 15 percent of your benefits to cover your debt, but under the Debt Collection Improvement Act of 1996, it must leave you at least \$750 each month. That is, unless the levy is for federal income taxes. In that case, the government isn't required to leave \$750 behind.

The other exception is for child support or alimony payments. Depending on your state laws, the court may be able to take half of your benefits or more to pay your obligations to your children or ex-spouse.

If you think your Social Security benefits might be raided to pay overdue bills, you need to address the problem - don't ignore it. Most government agencies are happy to work with you so long as you're willing to work with them.

But be aware that your creditors can still take legal action against you to recover what you owe them, and depending on your state's law, they may be able to garnish your wages and tap into other allowable assets, if you have any.

If, however, you owe money to Uncle Sam, it's a very different story. The federal government can garnish a portion of your Social Security benefits for repayment of several types of debts, including federal income taxes, federal student loans, state-ordered child support and alimony, nontax debt owed to other federal agencies, defaulted federal home loans and certain civil penalties. (If you receive SSI, those benefits

Dear Worried,
Whether your Social Security benefits are garnishable or not depends on whom you owe. Banks and other financial creditors, for example, can't touch your Social Security checks. But if Uncle Sam is collecting on a debt, some of your benefits are fair game.

If you have credit card debts, medical bills, unpaid personal loans or pay day loans, you'll be happy to know that your Social Security benefits are safe from your creditors. Section 207 of the Social Security Act prohibits debt collectors or a bankruptcy court from dipping into your bank account to take Social Security money for purposes of paying off



Savvy Senior

The government typically sends several letters about a debt before it takes action. The final letter will inform you of the intent to levy Social Security payments, and after that, you have 30 days to contact the agency and work out a payment plan.

To get a handle on your debt problems, consider contacting a nonprofit financial counseling agency, which offers free and low-cost services on managing financial problems. To locate a credible agency in your area, use the National Foundation for Credit Counseling website at NFCC.org or call (800) 388-2227.

You also need to make sure you're not missing out on any financial assistance programs. The National Council on Aging's website (Benefits-Checkup.org) contains a database of more than 2,500 federal, state and local programs that can help seniors with prescription drug costs, health care, food, utilities, and other basic needs. The site will help you locate programs that you may be eligible for and will show you how to apply.

to 20 years has helped him to work as a team and that making compromises is part of team building. "Being married for 21 years tells people a lot about my ability to compromise," Brege said.

Brege and his wife, Elizabeth (Bruske), married in 1997 and have five children ranging in age from seven to 17, all attending Alcona Community Schools.

In his spare time, which is sparse, Brege enjoys hunting and fishing, but his chief focus and hobby is volunteering for the community he loves and spending time with his family. He especially enjoys combining his volunteerism with interests his children enjoy.

Brege is a 4-H soccer coach and a volunteer with Alcona High School's robotic team, the Alcona Tool Cats. He teaches high school catechism through St. Anne Catholic Church, is on the parish council at St. Anne and is a leader for their youth group.

Annually, Brege forms a band of volunteers to clean up around Twin Lakes Cemetery and assists with the county fair each August.

"I feel it's responsible to give back to the community by volunteering. My kids get involved in things and I support that by getting involved with what interests them. It's a good to spend time with them and it helps the community," Brege said.

As a county commissioner, Brege has worked on budgeting, personnel and numerous other issues. In the first few months of taking his seat, he was asked by the board, (which, prior to his installment, decided to withhold payment in lieu of tax money)

from townships, to come up with a financial report on why the county would do this.

"There are townships that have state lands which don't pay a regular tax rate a normal property owner pays. What they pay instead is payment in lieu of taxes (PILT) which is a certain dollar amount per acre. It wasn't that I supported the decision (to keep PILT on the county level), but I did put together a financial report based on the numbers I could pull from the county to create why someone would make this decision.

"Within a few months of taking office, I was asked to analyze all the county's assets and try to sell it to the people. I think I did a good job, I got Gary Wnuk involved and we put together the report. In the end, I voted to give the money back to the townships," Brege said. He felt it was a good introduction to the commission seat and taught him a lot on how the finances at the county level work.

During Brege's first year as commissioner he was on the finance committee. He felt his many years working with budgets and spreadsheets helped streamline county business.

Last year Brege was on the personnel committee. He didn't have a lot of prior experience working with unions and said it was an eye opener on how the process works and what an employer can and can't do under a union contract.

Brege sits on the following committees: Fair board, personnel, Soil Conservation District, Emergency Medical Service, and budget. He is also a substitute for the Thun-

der Bay National Marine Sanctuary and the Thunderbay Transit Authority committees.

Over the next few years, Brege would like to see a project he is working on for a local government program in the schools to flourish and become part of Alcona Community Schools curriculum. "There are probably a good number of adults in our community who don't understand how the county process works, let alone if you were to ask a teenager, 'what does their county do for them?' Even if I am not reelected, I would still like to be a part of this program," Brege said.

Beginning this month and over the course of the next year, the county will be doing a lot of hard work on budgeting. Brege said he has the business experience to give helpful insight with budgeting. He said the county is not in a good position and is currently dipping into the fund balance too much. He would like to help the county succeed financially.

"Ever since I became involved in government I've heard the comment 'That's the way we've always done it' -- I don't like that comment. I've been fighting that comment since 2010. Just because that's the way it's always been done, doesn't mean there isn't a better way and I will push for a better way. Comfort does not equal efficiency.

"This is my home county, my home town. I had opportunities to go other places and always came back. This is where I want to be, where I want to retire and where I want my kids to live. Alcona

County may not have the youngest population, we may not have a ton of industry here, but we are a great place to live within a very short distance of a lot of job opportunities such as Kalitta Air and Standard Automotive. Alcona County is within 30 minutes of many places to work and has a variety of settings to live in including village, rural, lake front or woods. If I was to sell our county to someone that's what I would say, come here to live, come here to enjoy," Brege said.

Brege is excited about the possibility of being reelected and said he enjoys the position and if it was available, he'd make it his full-time job.

David Bielusiak was born in Flint, Mich., and attended Flint Southwestern High School. During high school he found interest in skilled trades and attended Torrey Road Skill Center taking after-school courses in mechanics.

He moved to Alcona County in his junior year of high school and graduated from Alcona High School in 1979. In the early 1980s he became a licensed master mechanic.

Bielusiak lived and working in Minnesota and Texas for a few years, but returned to attend Alpena Community College to study in a physics engineering program. He did not get a degree, but instead opted for a position at the Alcona County Building in 1985.

He became the department head for the building and grounds department, which he held for almost 31 years before retiring three years ago.

Bielusiak said that as a department head, he performed budgeting and worked directly with the sheriff and other departments in the county. "I think I have a good background for the position. I know the county process," Bielusiak said.

He is a member of the Fraternal Order of Police in Alpena and belongs to the Hub-

bard Lake Sportsman's Association.

Bielusiak is running for the commissioner seat in order to get the county pointed in a direction which will make things easier for the next generation. "Basically, that's getting some ground work set. Things are only going to get more expensive in the future. We need to get things lined up for the next generation," he said.

Issues he would like to work on involve having a conversation with the court administrator to hold an awareness meeting for the public to provide information on the opioid crisis and how costly it is for law enforcement. "If we can turn a few people into a better direction and keep them out of the legal system it will save the county a lot of money," Bielusiak said.

Bielusiak enjoys spending time outdoors fishing and feels the area would benefit by having some enhanced fisheries. The harbor, according to Bielusiak, could and should be a huge resource of revenue, but it seems to be very depleted of fish. If the fisheries were back, a lot more income could be generated in the area. He would like to coordinate this with the City of Harrisville and perhaps on a state level to make it happen.

He would like to get the county pointed in the right direction in battling invasive species such as cormorants and Asian carp. He said possibly a deep-water reef or structure may help the fish by giving them a reproductive area.

He also would like to talk with the sheriff on upgrading to a larger boat for Hubbard Lake. "Currently, the county boat being used is a Boston whaler which is antiquated and too light of weight for Hubbard Lake. It's possible we could get some grant money from Homeland Security or perhaps through the DNR (Department of Natural Resources). I'd like to have that discussion, if it could

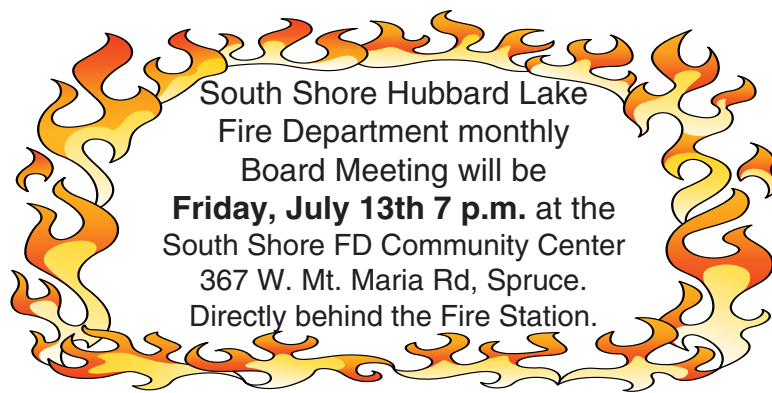
save someone's life, it would be worth it," Bielusiak said.

Another thing high on his list is getting the PILT money issue straightened out. He said there is "a lot of back paddling going on right now because of the election year." He doesn't think the county should be siphoning any money out of the PILT funds. He feels the money is for townships who don't have a lot of residents living there because of all the forest land.

"There is a calculation where payment comes in and should go directly to those townships. The county should not siphon any of that money at all. That's why it is set up like it is. Get the calculator out, there is another way to do it," Bielusiak said.

He said there are a lot of great things about Alcona County and that the road commission is one of the county's best assets and they should be commended for how well they handled the late winter storms which passed through last April.

If elected, Bielusiak said he will try to perform his duties to the best of his abilities. He feels confident he can lead the county in the right direction for the future.

What is the Headlee Amendment?

In 1978, Michigan voters approved an amendment to the Michigan Constitution known as the Headlee Amendment. This amendment included a number of provisions related to state and local taxes. These became Sections 25 through 33 of Article IX of the state constitution. This article is about section 31 concerning local government taxes. Section 31 created several new laws related to local government taxation, including:

Requiring voter approval for any local tax increases or new taxes established after Headlee was approved

Limiting property tax revenue resulting from property tax assessment increasing
 Limiting revenue collected to the amount the millage originally was to generate (with factor for inflation)

The property tax revenue limitation requires that if the assessed value of a local tax unit's total taxable property increases by more than the inflation rate, the maximum property tax millage must be reduced so that the local unit's total taxable property yields the same gross revenue, adjusted for inflation. This is done looking at the total state equalized value (SEV) change from one year to the next. It does so looking at the entire tax unit's jurisdiction, not based in each parcel. The change of SEV from one year to the next does not include any change that resulted from new construction.

Headlee limited the overall growth of state equalized value for a jurisdiction, not for an individual parcel. So, an individual parcel of property, whose SEV equals one half of the property's true cash value could, under Headlee, have an increase in taxable value greater than inflation. This would later change under Proposal A.

The millage revenue limitation means that, for example, if a tax base for a local unit increased from \$1 million to \$1.1 million and the tax rate was one mill, the millage would have to be reduced from 1.0 mills to 0.909 mills, so that total revenue would be the same, \$1,000, as originally generated. This was known as a Headlee rollback.

The millage is the amount per \$1,000 of taxable property value that must be paid. So, if a home has a value of \$100,000, and is assessed a 1 mill tax rate, \$100 in taxes are owed. The formula is $\$100,000 \text{ SEV} \times 1 \text{ mill} \times 0.001 = \100 .

Headlee protected property owners from increases in taxes by rolling back the tax rate (millage), but it has had another effect too. It has, along with Proposal A, which was approved in 1994 and will be discussed in a follow-up piece, limited local government revenue, in some cases, to the point where it contributes to budget constraints. With revenue growth limited, even local units that have been fiscally conservative are finding themselves facing uncertain budget situations. Part of this is due to lower revenue from property taxes. The recent recession caused a reduction in property values, which lead to lower property tax revenue for local units. Now, as property values have recovered, the Headlee Amendment and Proposal A have prevented property tax revenues from catching up. While Headlee and Proposal A are far from entirely to blame for many of the fiscal crises Michigan municipalities are facing, they certainly have not made it easier for local governments to deal with these challenges.

This is the first in a series of MSU Extension articles on local property taxes. This first article will review the Headlee Amendment, the second will review Proposal A of 1994 and the third will discuss some of their impacts and a ballot proposal called a Headlee Override.

A forgotten fishery

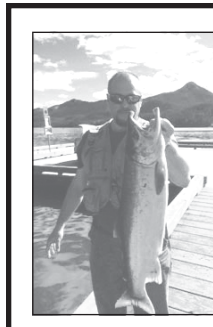
Fishing out of Harrisville has certainly changed since the late 1970s and 1980s. When I first started fishing there, we targeted lake trout.

At the time we fished tight to the bottom using flashers. Either cowbells or dodgers were used to attract the lakers and Wobble-glos were pulled behind them to close the deal. During the summer months it was nothing to fish seven miles off shore in 100 to 120 feet of water. To fish this deep we needed downriggers and cannonballs.

Downriggers are rigged with steel cable on which a lead weight is attached that weighs six to 12 pounds. A line release is fastened to the cannonball; this is where the monofilament line from a fishing rod is clipped. Once the fishing line is attached to the release; the drags loosened on a reel, the downrigger lowers the weight to the desired depth with the line, flasher, and lure attached.

When a fish grabs the lure, the line releases from the cannonball, and the fish goes back behind the boat to allow the angler to fight and bring it in. When setting a downrigger, the fishing rod is tightened down so that when a fish releases it, the rod springs skyward.

In addition to lakers, anglers targeted steelhead, Chinook, coho, and pink salmon.

A lot has changed since then. The biggest changes were a result of the crash of alewives and smelt due to over predation by salmon, trout, and walleye. This crash left the salmon struggling to find bait fish to sustain themselves. Simply put, there was no bait fish left suspended where they traditionally hunted for smelt and alewives. Steelhead fared better because they'd feed on the surface on insect hatches.

An exotic fish called the goby came into the picture just after the crash of the smelt and alewives. As a result of the void caused by the loss of alewives and smelt, the goby population exploded. At the same time the salmon population plummeted because they didn't forage on the bottom, which is where gobies reside.

Because they foraged on the lake bottom both lake trout and walleye started feeding on the gobies and as a result are flourishing. Present day anglers are enjoying tremendous success and are consistently catching limit catches of lake trout. Anglers I've talked to have told me it doesn't take long to limit out on lakers.

The walleye fishery on the Great Lakes off the shores of northeastern Michigan is also very healthy. Of course, at times anglers wouldn't know it because they can be very tight lipped. In this area there is a local population of walleye that stay all year.

In addition to the local population, every spring we have schools of walleye that migrate north out of Saginaw Bay. These fish spawn down south and as the water warms, they head north. Every spring anglers can follow this migration by listening to the fishing reports. Starting out of Au Gres, they move north to Tawas bay, then off the AuSable River out of Oscoda, before showing up off Harrisville, Thunder Bay out of Alpena, and beyond. Prior to their arrival you'll hear anglers are catching a few, this is followed by good catches, which will taper off as they move north.

Walleye anglers generally use crank baits and crawler harnesses. Walleye can be caught day or night, but traditionally the best fishing occurs early morning, late evening, and after dark. It's easy to recognize a walleye fisherman on the water by the inline planer boards being pulled on either side of their boat.

Walleye are shy of the boat's shadow; inline planer boards allow anglers to move their tackle away from the

boat. Because walleye naturally move away from boats, sometimes the inner boards can produce the most fish. However, as a result of the zebra mussel, the water is much clearer, and at times to be successful, planer boards must be run a considerable distance away from the boat.

In the last several years, the state has introduced Atlantic salmon which, like steelhead, goes to the surface when hooked, fights hard, and is delicious. In addition to the Atlantic, Chinook have been making a comeback. Granted there aren't as many, nor are they running as big as they once did, but anglers are once again catching a few.

Today there are a few anglers who are still using downriggers. Others are using lead line or dipsy divers to get down to fish. Lead line is color coded for depth and the line itself is impregnated with lead which allows anglers to fish deeper without downriggers. Dipsy divers are set to run on either side of the boat and dive getting tackle down to suspended fish.

Hard core trout and salmon fishermen will have their boats rigged with all of the above. Since they traditionally fish deeper water than walleye fishermen they have bigger boats and are rigged with downriggers, dipsy divers, sliders, and lead core line. With this combination they can cover the entire water column. Using the downriggers they can get lures right down just off the bottom for lakers. Sliders are lures that are attached to the line of down rigger rods and slide down part way in the water column.

Visualize for a minute the water between the boat and the bottom. With the downrigger slider combo anglers have lures on and just above the bottom. Using both dipsy divers and lead core line, anglers are able to get lures off to the sides of the boat and down just below the surface to suspended steelhead and salmon. Combining these methods allows anglers to get more lines out and target different species of fish.

Deep water fishermen using these methods can catch a mixed bag. In addition to trout and salmon, deep water anglers will even pull up an occasional walleye.

So, while we no longer see both tiers of the parking lot at the Harrisville launch filled with trucks and empty boat trailers, there are still a few anglers fishing and plenty of opportunities for good fishing all along the shoreline of Lake Huron. Good luck.

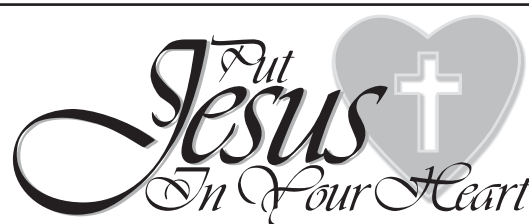
