## Harrisville dancer performs locally Sunday

Twelve-year-old Harrisville dancer Rilee Tracy will be one of the stars of Sunday's special 2 p.m. performance by students of the Northeast Academy of Dance at the Alcona High School auditorium. She will be featured as The Beast in Scott Heinrich's original ballet, "The Creation."

"It's fun to be, like, the main character instead of one of the background characters," said the sixth-grader of her role. She is the daughter of Lexi and Luke Tracy of Harrisville.

Rilee also had a ballet solo in last June's show in Oscoda. She takes both ballet and jazz dance at the academy, going four to five times a week, which, she reported, makes

her feet "sore at the end of the week."

The performance is part of the Oscoda academy's 22<sup>nd</sup> year of productions. Co-owner Giuseppe Canale, a former international ballet dancer, will direct the first half of the show. Co-owner Scott Heinrich, who has also performed internationally and still dances with Dafmark Dance Theatre in Erie, Pa., will direct the second half.

Canale choreographed the light, cheerful "Dance of the Northern Lights," based on music from 19<sup>th</sup> Century French composer Charles Gounod's Symphony No. 1.

Even if his name is unfamiliar, Gounod's music may be familiar to many -- his "Ave Maria" is frequently sung in churches and his "Funeral March for a Marionette" was the theme song of the "Alfred Hitchcock Presents" TV show.)

The 12 tutu-clad dancers in Sunday's presentation will be evoking the flickering lights of the Aurora Borealis, the Northern Lights that are occasionally visible locally.

After a 10-minute intermission, Heinrich's "The Creation," which he calls an original take on the Biblical creation story, will complete the program. Beginning with the traditional seven days, the work moves on to consider humankind's own creations, their consequences and what might be learned from them.

The music for this half comes from a wide variety of sources, from Bach to James Brown to David Bowie. Spoken word, inspired by modern poets from Virginia Woolf

## Voters decide on supervisor in recall election

Curtis Township voters will decide at a recall election on Tuesday, May 7 whether to keep the current supervisor or put a new candidate in the seat.

Voters will cast their ballot to either keep Darrell E. Kenyon (Democrat) as their supervisor until the end his term in about two years or put Gary Griffith (no party affiliation) in the seat to replace Kenyon. The recall election date was set after a petition filed by Christopher Clouse garnered enough signatures.

**Darrell E. Kenyon** has served as Curtis Township Supervisor for the last six years and was the township's planning commission chairperson prior to that for five years.

Kenyon said he works very hard at what he does for the township. "In the last six years, we have faced every difficult decision that was being put off in the past. We tore down the old township hall, which was condemned, we've renewed the road millage twice, and we've purchased, through a millage, a fire tanker truck. We've provided dust control for six to

eight miles of the township's earth roads every year for the past six years. We have had major road projects every year for the past six years and we've done this (all) on a very financially sound basis for the township," Kenyon said.

Some of the projects he looks forward to seeing through by remaining as the supervisor is to resolve the difficulties the township has had with its cemeteries and make improvements for its sustainable future. He would like to see the expansion of the new emergency warning system in Curtisville and better phone and Internet service through the addition of a new AT&T tower which is going in this spring.

He is excited to see the opening of the new factory, the new Dollar General store and potentially another new restaurant in the township. "These improvements and new businesses in the community didn't happen just by me. It took a lot of people to accomplish (this) and the township is grateful for their efforts. All this expands our employment base which really has to happen," Kenyon said.

According to Kenyon addressing the job needs so younger people will not have to leave the community is the greatest challenge. "We need to bring stability and growth, to bring the full force of the township to bear and encourage commercial development in the township."

Kenyon said his education, organization involvement with Optimist Club, his brother's service in Vietnam

and being raised by parents who were actively involved in politics helped to focus his life on serving the public.

"We have a tradition in our family of public service. That's really why I am in office. My father's experience as the treasurer of Ypsilanti Township in the 1950s coupled with my brother serving Vietnam humbled me, creating a desire to serve," Kenyon said.

Kenyon was raised in Ypsilanti, Mich. and graduated from Ypsilanti High School in 1968. He earned a bachelor's degree from Albion College where he majored in American history and geology education. He received a master's degree from Eastern Michigan University in urban planning.

While working on his master's degree, Kenyon did an internship with the Ypsilanti Area Industrial Development Corporation as a site analyst marketing industrial sites throughout the unit. He was employed by Ypsilanti Township as its community development director and was responsible for administrating the building department, building inspectors, zoning and planning commissions and ordinance and fire enforcement.

He retired as a teacher after working 32 years with Romulus Community Schools as a ninth-grade physical science teacher. He was also a football and track coach at the school district for over 30 years.

He and his wife, Judy, have lived in Glennie for 16 years in a home they built them-

## Stolen gas reveals larger left

What started out as a pump and run turned into a stolen property investigation for the Alcona County Sheriff's Department last weekend.

Last Saturday around 9 a.m. the sheriff's department received a call regarding the larceny of gas, where the driver fled the Barton City Store without paying for gas. The owner of the store followed the alleged vehicle -- a white SUV pulling a trailer and backhoe -- to the gate of Lost Lake Woods Club, on F-41, north of Lincoln, where he was unable to proceed.

Officers from the sheriff's department searched the subdivision and located the vehicle and trailered backhoe hidden behind a residence. They spoke with Justin Wesley Cummings, 31,

from Taylor, Mich. and during the conversation, noticed that the trailer and backhoe had been freshly painted and the ignition switch on the back hoe was damaged.

Upon further investigation, officers found they had allegedly been stolen from Chet's Rental-All in Clinton Township, Mich.

Cummings was arrested and lodged in the Alcona County Jail. He was arraigned in 81<sup>st</sup> District Court on Monday and charged with stolen property -- receiving and concealing \$20,000 or more, stolen property -- receiving and concealing \$1,000 or more, but less than \$20,000 and larceny less than \$200. He has been released on a \$15,000 personal recognizance bond.





**Road Construction**

The Michigan Department of Transportation (MDOT) will invest \$1.7 million to chip seal a little more than 26 miles of US-23 and M-65 this summer including five miles of M-65 in Alcona County from McCollum Road to south of VanWagoner Road. This project includes new pavement markings and rumble strips. Estimated start date is May 1 and estimated completion is August 20. This work will require single lane closure with flag control to manage traffic.

I'm happy to oblige, and I agree. This once-a-decade job opportunity is a great fit for retirees that have some free time on their hands who wouldn't mind earning some extra income while helping the community.

The United States Census Bureau is currently in the process of recruiting over 500,000 temporary workers to help carry out the upcoming 2020 Census national head count of every person living in the U.S.

The U.S. Census determines each state's representation in Congress, how funds are spent for schools, hospi-

tals, roads, and provides information to guide many decisions made by government agencies, private businesses and institutions.

Jobs within the census vary from working in the field canvassing, updating maps, doing follow up interviews with citizens in your community, or working in the office as a clerk doing administrative tasks or office operation supervisor, who oversees the field staff.

Some jobs will begin this summer, but the majority of positions will begin in late April 2020 and last a month or two.

These temporary part-time positions are located in every county throughout the United States and Puerto Rico. Some positions require evening and/or weekend shifts because you must be available to interview members of the public when they're at home.

In addition, most census jobs require employees to have access to a vehicle and a valid driver's license, unless public transportation is readily available. And have access to a computer with Internet and an email account to complete training.

If you're a veteran who would like to claim veterans' preference, which provides preference over nonveteran

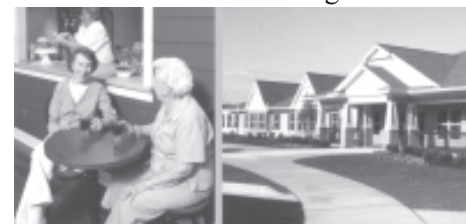

## Frank Dorr back in America and glad of it

### Sees No Comparison Between "Bonny" France And The U. S. A.

**May 1, 1919** ~ Camp Mills, April 19, 1919

Dear Friend:

Back again in the U. S. A. and there is no use attempting to tell you what a relief it is to be here after 8 months in the most disagreeable of all disagreeable places, France.

I suppose you think I am voicing a prejudice due to a case of blues or because of some conditions as found in two or three places in Bonny France, but let me try to convince you that such is not the case.

In the course of 8 months I have not had to live the life as found in the trenches, dug-outs and in fact none of the conditions as found in the Verdun offensive or like offensive but have had an even more varied experience, spending some time in two French ports, in one artillery training camp and some large cities; also several small towns and covering a wide territory in France.

Did not get to Paris but did see some of the few large cities, Nancy, Tule, Tours, LeMana, Chaumom, Calais and Brest and numerous

smaller places scattered from the Western to the Eastern borders of France.

Of course if one were to judge the country by its metropolis, there would be a different story to tell but we don't judge the U. S. by New York City and no country can be judged by its large cities but one must also consider the towns of average size and the rural and industrial centers. It is after gaining a knowledge of all this that I say that France is all of two centuries behind the U. S. and I am not alone in the statement for I note that several great newspaper men have published the same opinion.

Of course, the atmospheric conditions are the cause of a great portion of the bad showing made by France when compared with our great prosperous Republic but the people must come in for a part of the censure. They are not capable of such super human efforts as the stronger, race which we represent, can, make, but all things considered, we have nothing to fear from the aggressions or ambitions of European nations.

Never before has this great resourceful nation been called to demonstrate her power as in the World War and no other nation could have ex-

hibited such power for no other, nation has such resources as we are so fortunate as to possess.

"If the American Republic were leagued together, as European nations have been, there would be no need of a Monroe Doctrine.

Germany was the only really progressive country in Europe and her false "kulture" gave her a black record which it will require centuries to redeem if redemption is at all possible.

I have spent 4 days on pass in N.Y. City and have done the best I could, under the existing circumstances, to see what I could of the great Metropolis and it is a wonderful experience, one I would not have missed for anything, but everything just helps to make the contrast between France and the U. S. greater.

The traffic regulations are not so good as in Chicago but because of the addition of subways and the convenience of water transportation the excess of traffic is better taken care of. I don't know which of the two greatest depots to admire most, the Pennsylvania or Grand Central, both are wonderful examples of the progress of the Western civilization and one can procure all of life's necessities in either; both besides having every convenience as depots,

contain clothing stores, book-stores, drugstores restaurants and, as the expression goes, "everything".

Of course the tall buildings are not equaled either in size of number, anywhere else in the world. Electric power is put to more varied uses here than elsewhere and there is no place in the world that contains as many things of interest.

The latest thing in the line of hotels, cafes and places of amusement are here and a trip up the great White-Way or down town where the sky scrapers are or to the piers or beaches only serves to make one realize the magnitude of New York City.

As a residential city N. Y. is less attractive but as a business centre it can not be equaled.

Often have I wished that I could see a varied collection of people taken from all parts of France and from all walks of life there, taken all over the city and be in position to observe their surprise and wonder, on beholding our great Metropolis.

An Englishman will never express surprise at what he sees in America for he will never even give the devil his dues. England, first, last and always for him. Well he may have it and welcome.

All the Brigade has left Mills

but the 330th and we are due to leave Tuesday morning for Custer and we still have hopes of being home by May 1st.

Great changes in Mills since we were here last summer and more improvements are being made daily. The fleet is in the harbor and provides one of the sights of New York.

New styles in clothing are in vogue here and it seems in that, history is prone to repeat itself, especially in regard to women.

We were 12 days crossing the Atlantic from Brest, in the old tramp steamer "Pamonia". Some difference to the one we sailed to Europe in, the "Mauretania" and there were plenty of cases of sea sickness and I was no exception.

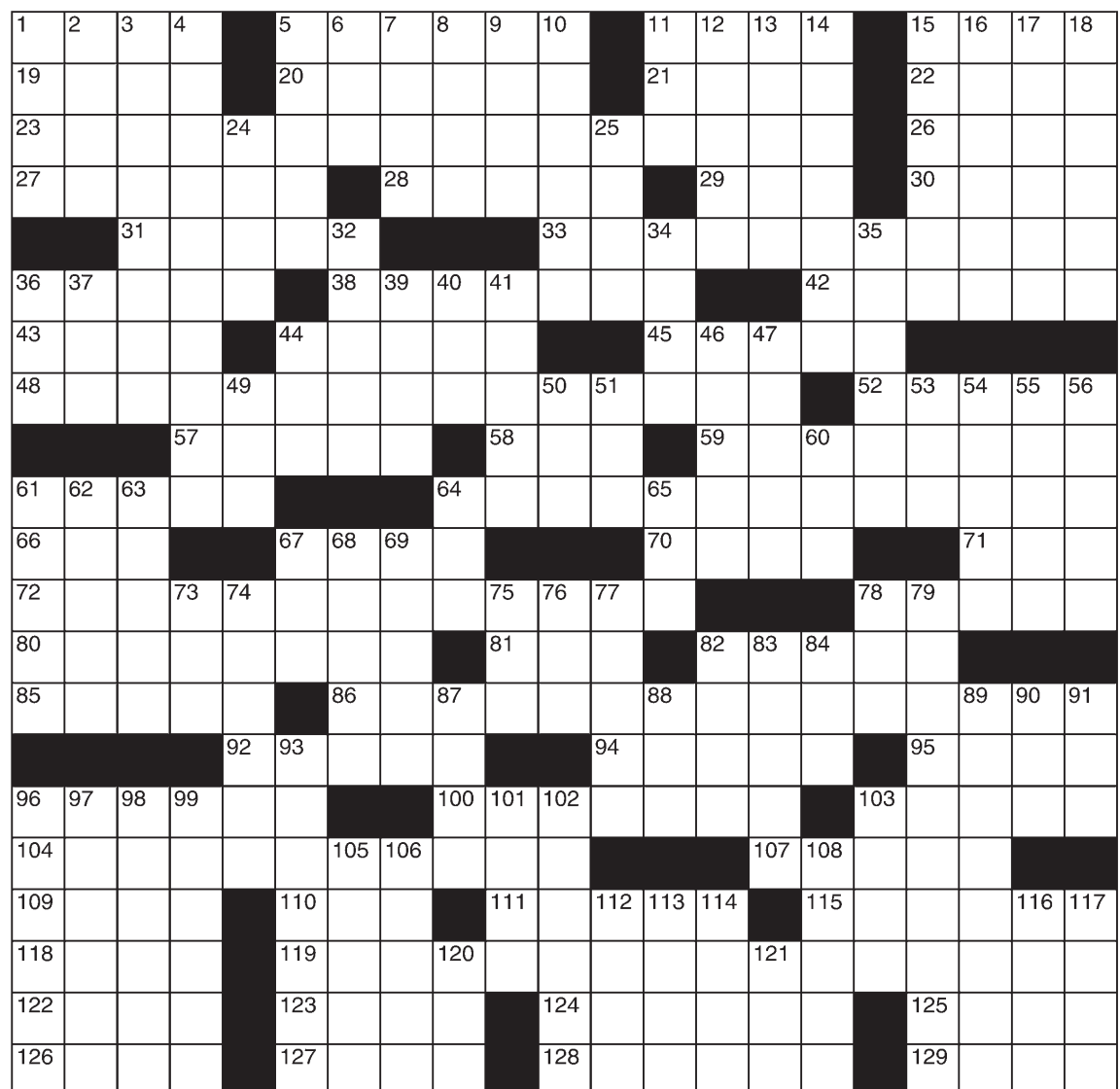

- On May 10, 1877, President Rutherford B. Hayes has the White House's first telephone installed, although he rarely received phone calls. In fact, the Treasury Department possessed the only other direct phone line to the White House at that time. The White House phone number was "1."
  - On May 9, 1926, according to their claims, American polar explorer Richard E. Byrd and pilot Floyd Bennett fly over the North Pole in a triple-engine Fokker monoplane. However, the discovery in 1996 of Byrd's diary suggests they may have turned back short of the pole because of an oil leak.
  - On May 12, 1949, an early crisis of the Cold War comes to an end when the Soviet Union lifts its 11-month blockade of West Berlin. The blockade had been broken by a massive U.S.-British airlift of supplies to West Berlin's 2 million citizens.
  - On May 6, 1954, in Oxford, England, 25-year-old medical student Roger Bannister cracks track and field's most notorious barrier: the four-minute mile. Bannister won the mile race with a time of 3:59.4.
  - On May 8, 1973, in South Dakota, armed members of the American Indian Movement surrender to federal authorities, ending their 71-day siege of Wounded Knee, site of the infamous massacre of 300 Sioux by the U.S. 7th Cavalry in 1890.
  - On May 11, 1988, Kim Philby, a former British intelligence officer and double agent for the Soviet Union, dies in Moscow. Philby was perhaps the most famous of a group of British government officials who spied for Russia from the 1930s to the 1950s.
  - On May 7, 1994, Norway's most famous painting, "The Scream" by Edvard Munch, is recovered almost three months after it was stolen from a museum in Oslo. It was recovered undamaged from a hotel about 40 miles away.
