Community Paramedicine strives to help residents be safer, recover at home

For almost six months the Alcona County Community Paramedicine (CP) program has been helping residents to become safer and healthier.

Since September, the initial CP team of Chris Wilson and Joe Maher, have completed their instructor coordinator certification, which the State of Michigan paid for, so they can teach others how to become community paramedics.

They have also increased the Alcona County CP team by one, adding David Kammerer. They hope to add two more, Lori Schwartz and Charles Herbst by the end of this month.

"By becoming CP instructor coordinators, we can teach others in Michigan and our county to build this revolutionary program. Currently, the closest CP program to us and they just got approval through the state," Wilson said.

Alcona County Emergency Medical Service Director Scott Rice explained since the program is so new, often people are skeptical and not sure of what the program offers. "The CP program is designed to prevent and/or reduce unnecessary emergency medical transports to the hospital," Rice said. The CP program will send

trained medics into people's homes for an assessment on how the resident can best care for themselves by keeping fall injuries in and around the home from happening such as suggesting area rugs be removed, alerting the resident of walkways which may contain trip hazards, or where grab bars should be installed, according to Rice.

They also assist in explaining hospital release instructions such as when to take medication and how to capably self-administer medications such as an inhaler, once the patient is home.

"They make full assessments and offer recommendations on ways to resolve issues that could compromise a person's health," Rice said.

While the CP team won't do household renovations, such as install grab bars, they will assist in putting up a high visibility emergency address number sign on CP assessed properties, should the resident need one, providing there is something to attach the sign to. High visibility address signs are available free through the Alcona County Commission on Aging (AC-COA).

While the program may be

is in Kalkaska (County, Mich.) ing about the program and reassured their mother it was a good thing for her to have the assessment done.

Wilson explained the program is just starting to work with Mid-Michigan Hospital's released chronic-illness patients with diabetes or congestive heart failure. "We go over their medications in their home and educate them.

"When talking to doctors, patients don't always walk away with a clear understanding of everything they should be doing to care for themselves. We're here to help with that," Wilson said.

In addition to home assessments, the CP team has helped get necessary paperwork to assist veterans going into nursing homes, has assisted in finding transportation for patients, and has worked with District Health Department No. 2 (DHD2) at mass COVID-19 vaccination clinics.

So far, the CP team has helped with two DHD2 mass clinics, two of which were at Alcona High School and one in Hale, Mich. They are scheduled to go back to Hale and help with another clinic soon.

The mass clinics are set up through DHD2 with prioritized participants from all points of the DHD2 district. Residents who comply with prioritization guidelines, mostly those 65 and older and a select group of essential workers, may register for the vaccination through the DHD2.org website.

"Between just Joe and I we have given about 500 COVID-19 vaccinations. During a recent mass vaccination clinic, a gentleman came up to me for his shot and I saw he was having a hard time breathing. We had to do a more thorough assessment of him. "The man had COPD (chronic obstructive pulmonary disease). We had him show us how he was using his inhaler and noticed he wasn't getting the full dose of medication from it. We showed him how to use it properly and asked him to try it again. He was feeling much better before he got his vaccination and left. The nurse there said if it hadn't been for our skill set, which is differ-

Cardboard sledding helps heal broken year

There isn't a family in the nation who hasn't suffered

through the past year in one form or another, but one Hubbard Lake family suffered a harder blow than just avoiding COVID-19.

That's why when Kim Sharrard saw a Facebook post about a cardboard sled race taking place in Nashville, Mich., she knew it was just the ticket to get her brokenhearted blended family together for some well-deserved and memorable fun.

She explained their year -her husband's first wife, who remained close friends after

a bour

their divorce, died of cancer last July. "My husband and his ex-wife were friends and knew each other from childhood. We were all good friends. My stepdaughter was supposed to get married last May but had to postpone the wedding due to COVID-19.

"The wedding got moved to July, she was hoping her mom could be there. Her mom never made it to the wedding, instead, she went into the hospital on the day of the wedding and died two weeks later. It was a terrible year, but as a family, we all grew closer," Sharrard said.

Sharrard tagged her stepdaughter on the Facebook

post she saw and from there the race was on.

Sharrard's family cottage is just down the road from Hickey Hill and her family used to go sledding there, so she knew it would be the perfect spot to hold the event.

Within a month the event grew to 45 family and friends participating with 15 sled teams. The youngest participant was five the oldest was 62.

"I first thought all they would bring was cardboard with duct tape on it and call it a day, but everyone went

extremely helpful, some residents are still very skeptical about using it. "There have been people who think maybe it is a scam. They don't exactly understand what we are trying to do," Wilson said.

He explained one elderly lady had her whole family present when the CP team arrived thinking the appointment to enter her home was suspicious. However, when they saw the team pull up to the home in an ambulance and step out in full uniform, family members recalled read-

The Michigan Department of Natural Resources reminds anglers that ice shanty removal dates are quickly approaching and to always use extreme caution when on the ice.

Lower Peninsula

Shanties in the northern Lower Peninsula must be removed by midnight Monday, March 15. Those counties include Alcona, Alpena, Antrim, Arenac, Bay, Benzie, Charlevoix, Cheboygan, Clare, Crawford, Emmet,

Mason, Mecosta, Midland, Missaukee, Montmorency, Newaygo, Oceana, Ogemaw, Osceola, Oscoda, Otsego, Presque Isle, Roscommon and Wexford.

Ice shanties in the remaining counties of the Lower Peninsula must be removed by midnight Monday, March 1.

Daily use of ice shanties is permitted anywhere in Michigan if ice conditions permit and if the shanties are removed from the ice at the end of each day. Regardless of the set removal dates, changing ice conditions could require the removal of fishing shanties before those dates. Shanty owners whose structures fall through the ice are subject to penalties of up to 30 days in jail, fines up to \$500, or both. Learn more at Michigan.gov/IceSafety.

ent than a nurse, the man would have probably continued to have difficulty breathing," Wilson said.

Soon the CP team will be partnering with DHD2 and the ACCOA to furnish inhome COVID-19 vaccinations to select individuals who have great difficulty in getting to a mass clinic site.

Currently, the CP program in Alcona County is only able to operate a few days a week on Monday, Thursday and some Friday, but it is the hope for Rice and the CP crew to expand making the service available five to seven days a week.

"We are trying to grow the program, collaborating with more partners hoping to obtain more grants to fund the program. We want to assist more residents in the area and possibly become a training center for Community Paramedics in Michigan," Wilson said.

Maher explained he has lived in Alcona County for 24 years and is enjoying bringing the CP program to residents. "This is my community and I'm excited to be able to go out and help with not just 911 ambulance calls, but help the elderly and others in

the community who may not understand how to maintain good health. The biggest challenge for us right now is access to the people. Funding to sustain the program is also a big challenge, which is why we are collaborating," Maher said.

"This is a way for us to give back to our community and educate people so they don't end up going to the hospital when fixing something at home could prevent that trip," Wilson said.

pretty extravagant with it." Originally, Sharrard's idea was to only have participants build the sled using cardboard, tape, glue, markers, paint and fabric. "A week before I had so many people calling asking if they could add a foam steering wheel, a light or a flag. Since we didn't want to snuff out anyone's imagination and there was no cash prize for the entries, I told them they could go ahead and decorate however

A FRANCHISE, granting to PRESQUE ISLE ELECTRIC & GAS CO-OP, its successors and assigns, the right, power and authority to lay, maintain and operate electric and fiber lines, poles and services on, along, across and under the highways, streets, alleys, bridges and other public places, and to conduct a local electric, broadband, and communication business in the Township of Caledonia, Alcona County, Michigan for a period of thirty years.

The Township of Caledonia ORDAINS:

Section 1. Grant of Franchise. The Township of Caledonia, located in Alcona County, Michigan (the "Township") hereby grants to Presque Isle Electric & Gas CO-OP, its subsidiaries, successors, and assigns (the "Company") consent, permission, right and authority is hereby given to construct, lay, operate, maintain, use, and replace electric, fiber, and other communication lines, poles, cables, conduits, appliances, buildings and other necessary works, in the highways, streets, alleys and other public places in the Township and a non-exclusive franchise is hereby granted to the Company, its subsidiaries, successors, and assigns, to transact local business in the Township for the purposes of producing, storing, transmitting, selling, and distributing electricity and broadband communication services into and through the Township and all other matters incidental thereto.

Section 2. Consideration. In consideration of the rights, power and authority hereby granted, the Company shall faithfully perform all things required by the terms hereof.

Section 3. Use of Streets and Other Public Places. The Company, its successors and assigns, shall not unnecessarily obstruct the passage of any of the highways, streets, alleys, or other public places within the Township and shall within a reasonable time after making an opening or excavations, repair the same and leave it in as good condition as before the opening or excavation was made. The Company, its successors and assigns shall use due care in exercising the privileges herein contained and shall be liable to the Township and to every owner of property abutting the Company's lines or other facilities, for all damages and costs from the negligence of the Company or its officers, agents, and servants.

Section 4. Force Majeure. The Company shall not be liable for failure to furnish service as herein provided, or for any breach of the Company's obligations hereunder, if such failure or breach is caused by acts of God, labor troubles, riot, or any other causes or contingencies not reasonably within the control of the Company.

Section 5. Hold Harmless. The Company shall at all times keep and save the Township free and harmless from all loss, costs and expense to which it may be subject by reason of the Company's negligent construction and negligent maintenance of the structures and equipment hereby authorized. If any action is commenced against the Township resulting from Company's negligent construction and maintenance, the Company shall, upon notice, defend the Township and save it free and harmless from all loss, cost and damage arising out of such negligent construction and maintenance.

Section 6. Effective Date; Term of Franchise; Acceptance by the Company. This Franchise shall take effect the day following the date of publication thereof, which publication shall be made within thirty (30) days after the date of its adoption, and shall continue in effect for a period of thirty (30) years thereafter ; provided , however , that when this Franchise shall become effective the Township Clerk shall deliver to the Company a certified copy of the Franchise accompanied by written evidence of publication thereof as required by law, and the Company shall, within sixty (60) days after receipt of the above documents , file with the Township Clerk its written acceptance of the conditions and provisions hereof.

Section 7. Franchise Not Exclusive. The rights, power and authority granted by this Franchise are not exclusive, and nothing contained herein shall prevent the Township from granting other non-exclusive electric or broadband franchises.

Section 8. Franchise Revocable. The franchise granted by this ordinance is subject to revocation upon sixty (60) days written notice by the party desiring such revocation.

Section 9. Effect and Interpretation of Franchise. All other franchises, ordinances and resolutions, and parts thereof, which conflict with any of the terms of this Franchise are hereby rescinded, to the extent of such conflict. The catch line headings which precede each section of this Franchise are for convenience in reference only and shall not be taken into consideration in the construction or interpretation of any of the provisions of this Franchise.

Section 10. Successors and Assigns. The words "Presque Isle Electric & Gas Co-op" and the "Company," wherever used herein, are intended and shall be held and construed to mean and include both Presque Isle Electric & Gas Co-op and its subsidiaries, successors, and assigns, whether so expressed or not.


