School buses getting Wi-Fi connectivity

It may have taken a little longer than expected, but by September, almost all Alcona Community School busses will be outfitted with a Wi-Fi connection.

The delay was because of the intricate way the units had to be installed, according to state standards, and the district's inexperience in working with the equipment, according to transportation supervisor Don Neuenfeldt.

He explained the school district has 13 buses and 11 of the buses will be outfitted with Wi-Fi. The remaining two buses are older and being transitioned out for new buses at a cost of around \$120,000 each. The district was awarded the funds for one of the buses to be delivered in September thanks to a Clean Air Act Grant. The district has applied for another Clean Air Act Grant for an additional bus but has not heard if the funds had been awarded yet.

"It's a lot of work to put the Wi-Fi in and it isn't worth

putting them in a bus that won't be on the road in another year. Once they are in it isn't easy getting them out.

"State standards are very strict when it comes to school buses and they are inspected regularly. If something is installed wrong, they won't pass inspection and that's on us. We couldn't just throw this in. Nothing can be in front of the driver's vision and all the wires must be tucked in and run up out of sight. You can't

Veterans to build new office site

A major step forward for veterans of Alcona County began last week when the Village of Lincoln formally agreed to donate land for a new Veterans Affairs office.

The land, an irregularshaped lot measuring 94 by 22 feet in the front and 132 by 132 feet in the back, is near the northwest corner of 2nd Street close to Traverse Bay State Road. It has been vacant land since the 1990s, according to Lincoln Village President Sheila Phillips.

Alcona County veteran counselor Tony Atkinson and veteran board president Patrick Smylie explained it was a huge step in the right direction to bring veteran counseling to a more central location in the county in order to improve veteran's access to services.

The building the veterans hope to put on the property is approximately 30x40 feet, with an estimated cost of \$130,000. "We have \$55,092 that will be coming from the Michigan Veterans Affairs Agency through a County Veterans Service Fund grant," Atkinson said.

The building will offer a secure office for private conversations between the counselor and the veteran, a meeting room, space for a secretary desk and file storage on one floor.

"The land is big enough for a parking lot too," Dennis Kruttlin said. Kruttlin is president of the Village of Lincoln Downtown Development Authority (DDA).

Kruttlin and Phillips were excited to make the offer of free land to house the veterans. "That land has sat vacant for a long time. It used to be the site of Twin Lakes Bar in 1988 when I moved here. but that was torn down a long time ago.

"This is a great move for everyone. Veterans won't have to travel so far to get services and they won't have to try and meet in a closet at the county building which is where they are currently located. It makes sense to donate the land for veteran use and it's the right thing to do. We are very proud to have the veteran's here," Phillips said.

The veterans haven't always had their fair shake in the county according to Smylie, who attended numerous county commissioners' meetings to discuss the situation of where they placed the counselor in the county building.

"The county has moved Tony's office several times, none of the locations were

To the Editor,


My husband and I are avid stargazers and find that the dark nights in Alcona County with little or no light pollution allows us to see many celestial objects.

ideal. Currently, they have him in a storage closet with barely enough room for a desk chair and filing cabinet. Tony has been doing an admirable job for a few years now all by himself, but he could do more if he was centrally located in the county, had the help of a secretary, and had an office large enough to meet with veterans and their family. The people voted for a millage to make sure the veterans of this county get the services they need. It's time for a move," Smylie said.

Commissioner Adam Brege was excited about the donation of land which will be deeded to Alcona County with a clause that it be solely used for veteran's purposes and if a decision to move from this location, the land will revert back to the village.

Some thought the commissioners were holding things up and causing headaches for the veterans, but Brege said they had no intention to cause issues. "There is a process that has to happen, steps to be taken. We have to have deeds transferred, engineered blueprints, inspections in place and quotes written. We can't just accept word-given promises on estimates for materials and labor. It all needs to be documented. This is what all counties go through with their entities, it isn't just to cause the veterans a delay. We have rules to follow to make sure it is done correctly," Brege said.

The move to the Village of Lincoln offers a lot more for veterans than just being centrally located according to

Phillips.

Kruttlin felt it was a winwin for both the village and the veterans. "This will be great to have the veterans here. It will draw people here and help the veterans. They can kill a lot of birds with one stone. It should be a great

Scam alert: Paying with gift cards

Scams can take many different forms. The Michigan State Police continues to see people being victimized and often they do not believe they

are being preyed upon until it's too late.

An off-duty trooper was recently in a local business when an elderly gentleman came in trying to buy \$2,500 in Sephora gift cards. He was instructed to send the gift card numbers to someone he met on Facebook Marketplace who was selling a horse he wanted to purchase.

The trooper recognized this to be a scam. The trooper, cashier and business manager tried to talk the man out of purchasing the gift cards. He refused.

The manager finally told him they would not sell him the gift cards. The man was furious and stormed out of the business. He was sure this was a legitimate online purchase.

To avoid becoming a vic-

- Do not give personal information to unknown call-
- Do not respond to unsolicited e-mails from unknown senders.
- Confirm the identity of a contact by independently speaking with the identified source (your bank, credit card company, government agency, etc.).
- Do not make payments using gift cards.
- Be immediately suspicious if the caller has a sense of urgency to act.
- Use a reliable source, such as the phone book, to confirm the contact's phone number or e-mail.
- · Report any suspicious location for them. contacts to police.

After the lumbermen left

An important part of history was playing out as the lumbering era in northeast Michigan ground to a halt in the early 1900s. Large portions of land were offered for sale by the AuSable and Northwestern Railroad (ANWRR), which owned over 125,000 acres in Alcona, Iosco and Oscoda counties.

The ANWRR owned rightof-way and land that extended southeast from Comins in Oscoda County and eventually ending in AuSable in Iosco County. Long forgotten crossings included: Doan, Bissonnette and Bryant in Iosco County; Lott, Glennie, Bamfield, Flat Rock Lodge, and Russell in Alcona County and Dew in Oscoda County.

In 1909, the ANWRR published a sales booklet, "The Gateway to a Home," and it described land for sale in the Sunnyside, Fairview, Glennie, Cloverdale and Mikado

Districts. They offered 80 acres of land for \$1,440, certainly a pittance compared to today's land values.

They also offered attractive financing terms, "\$50 at the time of selecting the land and \$250 within a reasonable time thereafter and the balance in nine equal payments with the low rate of 6 percent interest on the deferred payments," and with every 80 acres purchased the buyer could get a free house.

The booklet also touted many of the things still valued today; things like climate, water, soil and good farming opportunities. The booklet suggests that the land could be cleared of stumps for about \$7 per acre; ... "however, a hard working man could clear and Hardy McCollum, Millen his own land, while farming in between the stumps."

Coal was very expensive and any land owner that had excess wood could sell it to the railroad by stacking it

The Wreck of the Daniel J. Morrell

At last, the tale we can tell of the SS Morrell, lost in a gale of November. There's been 55 years and a river of tears, waiting for us to remember.

Morrell was constructed in 1906 in a shipyard in Michigan state. For six decades long on the Lakes she went strong, until she then met her grim fate.

The Daniel departed she had barely got started from the mouth of the River St. Clair. In the ink-colored dark off the Lighthouse Aux Barques, a furious storm slammed her there.

The sea-state was heavy, the wind blowing 70, when the good Daniel started to suffer. Her brittle steel hull could be heard to call "I'm breakin' up! It's time to leave her!"

The men had to chooseeither way they would loseto wait in a raft or go swimmin'. The crewmen who chose to take a leap soon were froze, while four in a raft kept on livin'.

Those four of *Morrell*, in a living hell, watched their ship break in 2 pieces. The prop kept on turnin', proud Daniel kept burnin', and came straight at the men in their crisis!

The stern went on past them beyond the horizon and sank fully five miles away. They tried to survive, but three of them died. The last waited for light of day.

There was a single Ishmael the story to tell. The survivor was named Dennis Hale. But every shipmate (there were 28), to a man, was lost in the gale.

The lost 28 met a sad fate, made sadder by the lack of a ballad. The tale has been told of the Ed Fitzgerald, and now Daniel Morrell has been added.

near the tracks for use in the locomotives.


The book also contains numerous testimonials from settlers who already purchased property and it provides significant insight about the early settlers in Alcona and Oscoda counties. A typical excerpt is from Samuel P. Hertzler of the Glennie district who wrote on September 20, 1910, "We came here from Wayne County, Ohio in April of 1909. We like the country. Have now cleared and under cultivation, 21 acres; 10 acres seeded to clover with a good stand; 1 ½ acres in orchard. We are getting along nicely for living in a new country. The climate is more healthful than in Ohio. The winter was fine; snow all winter. The water cannot not be beat anywhere. Last summer we organized a new school district with twenty-four scholars. Now have thirty-nine, where two years ago there was but one family. We also have a post office with daily mail and country store."

The booklet also mentions the possibility of employment - building the new dams on the AuSable River - while the settlers cleared and prepared their land for cultivation.

This is an interesting bit of history about how parts of the three counties were first settled. The rails were eventually sold to the Detroit & Mackinaw Railroad and abandoned in the twenties; closing another chapter in the history of northeast Michi-



even tell the bus has Wi-Fi except for a small antenna on the bus roof. Our mechanic, Jesse Smith, is doing a phenomenal job with the installations," Neuenfeldt said.

Superintendent Dan O'Connor said four of the busses had Wi-Fi connections before school ended in June and that it was working well for the students.

"The Wi-Fi will capitalize

last spring and the signals were fairly strong, even in places where cell phone coverage is spotty. "It ran a little slower a few times making the run to Glennie, but the students were still able to access it and get their work done," he said.

A benefit bus drivers noticed with having the Wi-Fi was in the behavior of some students who normally didn't

Chromebook assignments done on the bus they must complete them at home before bedtime making it an even longer day.

Neuenfeldt explained safety measures are still in place with the Chromebooks used on the bus just as they would in school and the same rules and consequences apply. Students can't go on sites they are not allowed to go on and if

on the time students spend on the bus each day which is less than ideal, but necessary due to the square mileage of the district. We are excited to support student homework and time studying while riding to and from school or while going on a field trip or athletic event," O'Connor said.

It cost \$19,000 to equip the 11 buses with Wi-Fi, however none of the funds came from the school district's budget. Instead, the funds came from a \$70,000 grant acquired in 2021 through the Emergency Collective Fund. The remaining sum of \$51,000 was used to purchase some new Chromebook/tablets for students and other infrastructure to improve technology and connectivity in the school district.

Neuenfeldt said the trial runs with the Wi-Fi-connected school buses went well

have the patience to sit still on the long bus rides. But with Wi-Fi became actively engaged on their Chromebooks.

"We are lucky in this county and have very good kids. They know the rules of riding a bus. Still, our drivers do have a lot of responsibility, and we don't have the personnel to place a driver along with an additional adult to watch the students. This will assist in making fewer disciplinary stops," he said.

It may also help with behavior issues after school as well since it will help students complete their homework before getting home. Neuenfeldt explained some Alcona County students ranging from kindergarten through 12th grade are picked up at 6 a.m. and are not dropped off until 4:30 p.m., making it a very long day.

Other students may be traveling for an away game or event and those trips could take three or more hours on the bus. If they can't get their

somehow that does happen, the school is notified immediately.

"Having Wi-Fi connectivity on the bus is a huge benefit. There are so many ways a student can learn on their Chromebooks. There are a lot of math games for them to play and they enjoy the games. Having Wi-Fi on the buses allows our students to stay connected for school success," Neuenfeldt said.

He is hoping the addition of Wi-Fi and keeping the students happier may entice more people to want to work as bus drivers. He explained the district is always looking for substitute drivers. Neuenfeldt said substitute positions could turn into full-time positions, which is how he got his start working for Alcona Community Schools.

Formerly known as the Cottage Hotel, the interior has been completely rebuilt with a spacious dining room, kitchen and front entrance

The second floor bedrooms have been rebuilt, insulated and rewired, with new lighting fixtures, floor coverings and other new equipment added. Living quarters have been made on the first floor at the rear of the building. The old plumbing has been replaced by new. The interior of the new addition has been

Thousands attend Lincoln celebration

July 6, 1947 ~ A very successful Independence Day was celebrated in Lincoln on Sunday, July 2 under the supervision of the Lincoln Lions Club, with Bill Ackerman as general chairman. An estimated eight to ten thousand people viewed the parade, which started off the day's events at one p.m.

The parade, consisting of fifty-four units, which included entries of organizations, businesses and individuals, horses and riders, the Shrine Motors Corps band from Flint, the Alpena City Band, and "The Saginaires," a 70-piece American Legion drum and bugle corps from Saginaw, was led by the Alcona High School Band.

First and second places trophies in three categories, were awarded as follows: Commercial - D.& B. Building Supplies and Alcona Motors, Inc. both of Lincoln; Organizations - Green Thumb Garden Club of Lincoln, and the Child Development Center of Barton City; and the Judges' Trophy - Happy Icers 4-H Club and Gillies' Funeral Home of Lincoln.

There was a midway at the elementary school grounds with all sorts of booths, horseback riding, games for the youngsters, a greased pole to climb, and a "sand box" of "saw dust and money." Beginning immediately after the parade a chicken barbecue dinner was served at Memorial Hall where between eight and ten hundred individuals were served.

There were several ball games in the afternoon, including a Peewee All Star Game. The fireworks display at dusk and a dance at Memorial Hall climaxed the day.

July 6, 1970 ~ The 1970 Census of Housing counted 6.267 housing units in Alcona County, and 2,096 households had at least one television set (696 UHFequipped), the Bureau of the Census, U.S. Department of Commerce, announced recently. The figures are from the first report for Michigan which presents detailed statistics on housing for each county.

The report shows that in the county: There were 53 housing units with air conditioning (40 with room units and 13 with central system), 1,738 units with a clothes washing machine, 1,002 with a clothes dryer, and 229 with a dishwasher.

The 1970 population was 7,113, with an average of 3.0 persons per housing unit.

A total of 1.679 housing units were built before 1949. 857 during the 1950s, 436 during 1960-64. and 618 within the five years preceding the April 1970 census.

Utility gas was used to cook the meals in 126 households, electricity in another 1,471, and bottled, tank, or LP gas in an other 523.

There were 3,190 housing units with complete kitchen facilities and 2,797 with complete bath rooms, both for the exclusive use of the households. The number of bedrooms in all housing units ranged from none (in 39 units) and one (in 488 units) to four or more (in 555 units).

Owners occupied 2,143 units, renters 251 units, and a total of 1,196 units were vacant year round with 73 for sale and 33 for rent.



Step up to help your fellow vets

What are you doing this summer? If you have spare hours or days, consider stepping up to help your fellow veterans. Stand Downs are a good place to start.

Stand Downs were started in California in 1988 by two veterans who saw the great need for services to homeless veterans. Over the years, the number of events and the veterans served has grown to include help from government agencies, veteran service organizations, groups and individual volunteers all across the county. The need is so great that many locations see hundreds of veterans lined up outside the door before they even open on the first

The list of help provided at each Stand Down can de-

pend on the location and the length of the event (usually one to three days), but typically includes health screenings, clothing, showers and haircuts, food, legal advice, dental and eye-care services, mental health counseling, substance treatment referral, employment help, benefits counseling (both Department of Veterans Affairs and others, such as Social Security), housing referral and more.

The schedule of Stand Downs in 2022, whether you need services or want to help, can be seen at www.va.gov/ homeless/events.asp. Keep an eye on that page because new events can be added at any time. Another page to watch is the National Coalition for Homeless Veterans (nchv.org/current-stand-

Or you can call your local VA medical facility and ask what's scheduled for your area. Best bet is to call them anyway and ask if the event is still planned due to COVID playing havoc with schedul-

Ask about transportation, if you need it or can offer it. Sometimes an event will send a vehicle around to pick up veterans who have no other way to get to their local Stand Down.




