## Family residency program comes to local health care provider

Alcona Health Center (AHC) is entering a new collaboration with MyMichigan Medical Center Midland to bring a rural track, family medicine residency program to Alpena County.

This residency program allows licensed, recently graduated doctors, to continue their training in a hands-on environment.

These residents receive mentorship and supervision from a faculty healthcare provider while gaining real world experience and a better understanding of what it means to practice medicine in a rural setting.

MyMichigan Midland Family Medicine Residency - Alcona Health Center Campus will be located within the AHC location in Ossineke (11745 US-23 South).

Joining the AHC team will be faculty provider Dr. Michelle LaFave and second year family medicine residents, Dr. Christian Grant and Dr. David Westphal.

Grant earned his medical degree from American University of the Caribbean School of Medicine, St. Maarten, Netherlands-Antilles. Westphal earned his medical degree from Michigan State University College of Human Medicine.

Both healthcare providers have chosen to further their training through the residency program at the Alcona Health Center Campus for the next two years. Under the guidance and supervision of LaFave.

LaFave has experience practicing family medicine in rural northeast Michigan and brings a passion for teaching to the role. As the faculty provider, she will directly oversee the residents, mentoring them during appointments and reviewing patient charts. "I am excited to bring my experience in family medicine in a rural setting to this venture," LaFave said. "Mentoring the family doctors in this setting achieves community health-care needs now and is the way forward in adjusting to future needs."

Patients who establish care with Dr. Grant or Dr. Westphal will benefit from the care of two healthcare providers reviewing their chart and attending to their healthcare needs - a licensed, recent

Those interested in establishing care with either Dr. Grant or Dr. Westphal are encouraged to phone the health center at (989) 471-2156. While they do not start seeing patients until July, appointments for both providers are currently being sched-

In 2023, two additional family medicine residents will join the program. Residents participating in the MyMichigan Family Medicine Residency program who choose the rural track at the Alcona Health Center Campus will be seeing patients at the Ossineke office for two years. There will be up to four residents in the program at a

'We are excited to collaborate with MyMichigan Medical Center Midland to bring this rural track family medicine residency to Alpena County," said Alcona Health Center CEO Nancy Spencer. "Not only do we have the opportunity to expand access to healthcare in our community through the residency program, we also hope that the experience the residents have in northeast Michigan encourage them to stay in the area to practice."

"The residency program is so excited to partner with the Alpena community and Alcona Health Center to train residents in a rural setting. We know that physicians tend to stay in or near the community where they train and hope that this endeavor will continue to grow primary care in northern Michigan," said Dr. Kelly Hill, MyMichigan Midland family medicine program director.

## Educators bid farewell to Alcona Community Schools

In addition to saying goodbye to students for the 2021-2022 school year last week, Alcona Community Schools said good-bye to three educators.

Retiring teachers, Dorene Schick and Jeanette Klein were both special education teachers for the school system for many years. Patti Byce was a paraprofessional for many years as well.

Schick and Byce were both working at the high school level upon retirement. Klein worked at the elementary school.

Superintendent O'Connor said Klein worked for the district in many roles serving students from kindergarten through 12th grade while also supporting the district as a special education director. "Jeanette had tremendous relationships with students. We will miss her caring heart and smile," he

Schick had been a teacher with the school district for her entire career, giving 31 years to Alcona County students. She moved from a small community near Central Michigan University and came north to teach in 1991 and never wanted to leave. "I found my home here. I never liked big cities, so this was perfect. I tell a lot of people I just stayed to aggravate them," Schick chided.

Schick first worked for the district as an elementary special education teacher and then taught fourth grade for 14 years before moving to the high school. She said it was nice being able to see her fourth graders grow up and many of the last fourth-graders she taught were seniors.

She felt the best part of being a teacher for Alcona Community Schools was the good people and students she has worked with over the years. "I've loved the huge variety of kids, families and staff I've worked with. All in all, it worked out well. I've enjoyed my career here," Schick said.

She said teaching changed a lot over the last three decades but the thing that changed it the most was going through COVID-19 and

the hurdles of school closures and teaching students remotely caused. "Education is always swinging back and forth, but when Covid hit, it changed a lot. It was hard on the kids and hard on the staff. It is one of the reasons I thought now would be a good time to retire," Schick said.

Schick dedicated herself totally to teaching and she will miss it. "This is my life; my whole life revolves around school. It will be nice, however, to have my own schedule. I plan on coming back and helping the new (special) education teachers at the school, but I won't have to do that every day.

"The one thing I won't miss is all the paperwork. There is a lot of paperwork in special


## Grandma Beever's babies

Sarah Beever came to America in the 1850s with her husband Robert and daughter Emma. They found their way to the newly named settlement of Harrisville, Michigan, and bought land from the town's eponymous founders, the Harris brothers. They cleared the densely wooded land, planted crops, and raised a family.

Sarah, a straw-weight woman, very slight of frame, gave birth to 14 children, nine of whom survived to adulthood. A nurturer by nature, she apprenticed herself to the only physician in Alcona County, Dr. David Mitchell, to assist on his childbirth calls.



Having lost five of her own offspring, she may have been motivated to help other women go through an experience that is typically painfully joyous, but which could go horribly, dangerously wrong. Overcoming her physical frailty, Sarah logged many, many arduous miles and hours to guide mothers through childbirth.

As Sarah Beever gained the knowledge and skills of a mother and midwife, she also gained the confidence to treat patients on her own, whenever Dr. Mitchell was away. Over time, the family members of women in labor, or anyone who was sick or hurt, sent directly for "Grandma Beever," as she eventually became known.


The number of babies she brought forth into the sweet air of Alcona County over her decades of practice is unknown, but it must have been a small multitude. She worked into her 70s, ultimately establishing a visiting nurses program to aid her neighbors.


In the meantime, her daughter Emma, who was born in England in 1850 and came to Harrisville with her parents as a small child, married George Emerson at the new Methodist Church in Harrisville at the age of 19.

George, a carpenter, hewed out a homestead on the edge of the wetlands west of town, and built a house for them there in 1870. The couple reared four of Grandma Beever's grandchildren there, all of them sons.

Emma Beever Emerson lived to be 102 years old. Her solidly constructed house still stands on  $5^{th}$  Street.



Jo-burg, on the other hand. looked like a team on a mission. "They played well. They were ready to play. They came



### Pewabic lost in collission

#### Carried Down 125 People and 267 Tons of Copper

**June 17, 1897** ~ The recent discovery of the hull of the lost steamer Pewabic after years of searching, and th e expenditure of thousands of dollars, recalls the incident of her sinking on aclear moonlight night 32 years ago next August.

The Pewabic was sunk by collision with the Meteor, a sister ship of the same line, on the evening of August 9th, 1865. She was on her way from Duluth to Buffalo, and the two vessels were run close to each other in order to exchange papers. In some manner they collided. The Pewabic went down in less than 20 minutes, and the Meteor was badly damaged. Just how the accident occurred was never

Some said the Meteor took sheer into the Pewabic, caused by the suction of the water, while others claimed the Pewabic tried to cross the Meteor's bow, miscalculated the distance, and was run down

The Pewabic had about 150 passengers and a crew of about 30, and about 125 persons were drowned.

Several expeditions have tried to recover the valuable cargo, and at least two divers have lost their lives, while large sums have been expended in the search.

The cargo consisted of 267 tons of ingot copper which was in barrels on the main deck, and can probably be recovered. This copper is worth at present prices about \$160,000. There was also about a hundred tons of iron ore in the hold, and some miscellaneous cargo.

It has always been claimed that there was a large amount of gold in the safes, the amount being reported at from \$40,000 to \$80,000. The Pewabic carried express, and it is said merchants were sending money east, and the passengers undoubtedly deposited large amounts with the purser.

This is an exaggeration for the purser of the boat who is now living says that he is positive there was not over \$50 in the safe at the time of

the collision.

One passenger offered a reward of \$1,000 for his trunk, which contained money, and a steerage passenger who was saved claimed there were several thousand dollars and some diamonds in a belt which his wife wore.

The Pewabic carried steerage passengers, and the bodies arc probably still in the hull, and the wreckers will look for the woman with the

## Moments In Time By The History Channel



- On June 13, 1381, a large mob of English peasants marches into London and begins burning and looting the city. The revolt began with the bubonic plague in the late 1340s, which killed nearly a third of the population of England and led to higher wages due to scarcity of labor. Parliament, however, passed laws to hold down wages.
