Toddler's mother receives 15 to 40 years in prison

The mother of the twoyear-old toddler who was killed in Curtis Township in July 2022 was sentenced in 23rd Circuit Court on February 13.

Adrienne Pavelka, 23, appeared in court for her sentencing and gave an emotional statement to Judge Laura A. Frawley before she was taken into custody to be remanded to the Michigan Department of Corrections.

Pavelka was arrested on July 23, 2022, one day after she took her daughter, Jayde McConnell, to the emergency room at MyMichigan Medical Center in Alpena. The child was deceased.

She was charged with one count of homicide-felony murder and two counts of child abuse-first degree. Her boyfriend at the time, Aaron J. Trout, was also charged in the child's murder. A jury found him guilty of second degree homicide and child

abuse. He was sentenced to 55 to 90 years for homicide and 30 to 60 years for child abuse

Pursuant to a plea agreement that was signed on June 6, 2023, the homicide charge and one count of child abuse – first degree were dismissed. The terms of the agreement are, "The defendant will enter a conditional plea of guilty as charged to count two (child abuse – first degree). The defendant has the right to appeal the factual basis of the plea relating to a failure to protect her child from a known danger.

"Prosecutor agrees to a sentence of: A term of years sentence with a 15 year cap on the maximum-minimum sentence. Further this sentencing agreement is contingent upon her truthful testimony at trial, and she shall not be sentenced until after co-defendant Aaron Trout's prosecution is resolved."

Pavelka's attorney, Matthew J. Wojda, called Dr. Jef-

frey Kielisziewski, an expert witness, to explain to the court Pavelka's mental status. He testified that she is diagnosed with "clinical post-traumatic stress disorder (PSTD) and major depressive issues." He explained that she also exhibited "learned help-lessness" that is commonly seen in domestic violence situations, where people feel

Claw Academy provides students nontraditional approach to high school

Students of Alcona High School's Claw Academy have finished their first semester, but have already begun to see great success.

Claw is an alternative high school education model that combines a small classroom atmosphere offering online learning. It is housed in a two-room building across the street from the high school which used to be called the "blue house."

With two staff support mentors, Shelly Hoffmeyer and Joy Bullis, guiding students, the academy offers a personalized approach to learning.

Hoffmeyer explained when they first began signing students up last year they thought about six students would give it a try. She was delighted when 21 juniors and seniors jumped on board in September.

According to Alcona High School Principal Christie Thomas, of the 21 students, 12 are on track and have been successful in passing all their classes. "All the seniors are on track to graduate this year.

An additional six students are ahead and have started their second semester early.

"We anticipate two or three may have their whole year complete by the end of February," Thomas said.

Just three students of the 21 have not had success with the program and will be either going back to face-to-face education at the traditional high school or will be attending some other form of education/school.

Thomas said the students accepted into the program were very credit-deficient and probably would not be able to graduate with their class.

"They just were not thriving at traditional high school. For many, there were social issues. Here there is very little drama, it's a small class and they get along like a family," Thomas said.

Hoffmeyer said the biggest draw for the students to attend Claw Academy was because students can set their own outcome. "They start out coming in four full days per week, but once they are on track and successful at pass-



He also described Pavelka's "flat demeanor" when she testified without emotion as dissociative affect. Dissociative disorders are mental health conditions that involve experiencing a loss of connection between thoughts, memories, feelings, surroundings, behavior and identity.

"She has underlying significant mental illness. She was intoxicated with marijuana quite a bit. She was in

She is working on herself..." Wojda said. He asked Frawley to consider a minimum of seven years and a maximum of 20 years for Pavelka.

Following the brief testi-

Judge Frawley called for victim impact statements.

Gannon McConnell, father of Jayde, spoke to Pavelka during his victim impact statement. "There is so much I want to say, but I know I'll never be able to have the time... My daughter changed every single soul she encountered - and her siblings are the same way... they really miss her, especially Renee. She will never be the same. She knows everything - she was abused too (by Trout) ...

"There (were) 80 plus injuries-she was tied up, starved, beaten... and where were you? She was looking for you to help her... you took my children from me, and you blamed me for what he did! I didn't do any of these things.

You took them and... went to him? You said you were looking for love... that's crazy. I gave you stability, warmth and love... The only good decision you've ever made was choosing me as their father.

"This is unspeakable. It still doesn't make sense. You robbed me of saying goodbye. Renee lost everyone – her best friend, her mother, her family... Because of you, Violet will never know what it is like to have parents... I could talk about what I've lost for an eternity," McConnell said.

"My daughter was potty trained by March 21 (2022) when you took them from me... I think she was trauma regressed... What was it for? Revenge? Love? I bet Jayde loved you until the day she

"You knew who he was... you put them in hell. Why? I appreciate that I have Renee and Violet to fight for. I will never give up. I will always love you for the rest of my life. But, not as much as my children. I would die to protect them," McConnell said.

Chelsea Fultz and Victoria Pavao, sisters of Pavelka, made impact statements to Judge Frawley. "As a mother, I could never understand why you let this happen," Fultz said. "Jayde's life should have been more important than yours... Renee... She's the strongest person I know and she's only five years old."

"So many people failed Adrienne... But, as a mother, I fail to understand how you didn't save her..." Pavao said.

Paternal aunt Patricia Brown spoke to Pavelka. "You brought her into my life for an entire year.... I know you were scared... but what do we do, as moms when we are scared? We protect our children... you ran from the only person who could protect them – by brother (Gannon). I wish you had protected her when it was needed. You did it when it wasn't needed, with my brother. You knew how to do it. You did it then when it wasn't needed. Why didn't you do it when it was? You let monsters around her... I am so proud of my brother, there is no one better to take care of your children."

Pavelka also gave a statement. While reading from papers she held while standing before the court, her hands shook, and tears rolled freely down her face.

"I am sorry. Although, it feels pointless. I am sorry to Jayde. She paid the highest price. I will never be able to forgive myself. I'm sorry for Renee who lost her sister and best friend. I'm sorry for Violet who will never know Jayde.

"I am sorry for Gannon. I am sorry to Barb Cassidy (paternal grandmother). I am sorry to my own mother and father. I am sorry to my sisters. I'm sorry to Nicole and Patricia (paternal aunts)..." Pavelka said. She named many others as well.

"A week ago, we all sat here in this courtroom for the sentencing of Mr. Trout. I called him a monster," Judge

Frawley said. "I don't consider that we have the same situation today."

Prior to the sentencing date, Frawley said she listened to and watched audio and video recordings of Pavelka in the hospital, at the Michigan State Police post and in the police vehicle while she was taken to family members. "I heard your repeatedly and hysterically saying you wanted to die... that you didn't deserve to live," Frawley said.

"I do believe that you are genuinely remorseful because of the loss of Jayde and not your situation... But it doesn't mean anything does it? Jayde is still gone... Since this case began, the only image in my mind that I have of Jayde is from the autopsy photo with angry bruises, ligature marks, open wounds...

"Then after the sentencing, I saw a photo of her in life... that photo captured all the life and joy and hope that a two-year-old should enjoy... It broke my heart... I can't imagine the emotional and

physical pain she suffered all while her mother was watching it happen.

"I understand learned helplessness, PSTD... However, a parent has a duty to protect their child. I have to balance all of this - Miss Pavelka's remorsefulness, her intelligence, youth, and consider the situation she was in at the time. You are bettering yourself. It is also clear that you can be manipulated," Frawley said.

"It's too late for Jayde. This is a life that was taken that's as serious as it gets. I don't think you inflicted the abuse, but you didn't do anything to help her. It's a tragedy of epic proportions," Frawley said.

She sentenced Pavelka to 15 to 40 years in prison. "You are an intelligent person. I hope you take this opportunity to better yourself," Frawley said.




Maintaining an outdoor compost pile through winter months will produce fertilizer for planting in the spring, and can act as a secondary heat source for a greenhouse. To keep compost active over winter, feed it the right balance of green (nitrogen) and brown (carbon) ingredients. Green scraps will be produced in your kitchen over the winter, but most of the brown matter such as dried leaves, straw and plant debris will have been produced in the fall. 



ing their classes and doing the work, they can adjust their schedule to a once-a-week check-in, once a week to work, two mornings or two afternoons to work. Whatever works for them. They set their own parameters which has made a huge difference in motivation," Hoffmeyer said.

There are five students who attend Claw Academy in the morning and then go to career technical education classes in the afternoon. Some

check in with Hoffmeyer and Bullis after. One student does art at the high school after her morning classes at Claw and one attends Claw in the morning and then attends traditional high school classes in the afternoon.

Bullis and Hoffmeyer explained the academy is very laid back. "If a student wants to wear their slippers and pajamas to attend class they can. We don't get stressed out about things like that."

Hoffmeyer said Graduation Alliance courses push the students to do more research on their own. "If they get to a knowledge base they don't understand, they must do the research. It's not all video watching like the other online program the school utilizes called Edgenuity.

"Since this is our first year here, we are still getting set up. We need some lounge chairs and other seating still for the break room, but even

students attend Claw in the morning and then work in the afternoon. A handful are even working full-time jobs to support themselves.

There are five students at Claw who are McKenny Vento eligible. The McKinney-Vento Homeless Assistance Act authorizes the federal Education for Homeless Children and Youth (EHCY) Program.

"That could mean they don't have a home at all, are doubled up (sofa surfing) at other homes, living on their own supporting themselves at 17, which we do have, or they could be underhoused with no water or power.

"It makes it very hard to attend traditional high school and learn under those conditions," Hoffmeyer said.

Thomas said Hoffmeyer and Bullis make a dynamic mentoring team for the students offering guiding support. "The students have access to everything they would have at the high school building, counselors and therapists come to assist students. Special education, Michigan Works, and Michigan Rehabilitation come in. Whatever services or events the high school offers, students can receive at the Claw including breakfast and lunch.

"Since they are still students of Alcona High School, they may participate in prom/dances, go to sporting events and join clubs, whatever the high school offers," Thomas said.

Hoffmeyer explained Alpena Alcona Area Credit Union sends an employee over to work with students teaching them life skills such as banking, credit card borrowing and more. The students have also taken two field trips this school year to Kalitta Air and Moran Iron Works.

A few of the students go to the high school in the morning to weight-lift and then During breaks, the students are welcome to the small coffee bar and snack area set up in the hallway which was purchased by community donations through an Amazon wish list.

The online courses Claw students take are through Graduation Alliance which offers courses for students off-track to graduate or have dropped out of school and are coming back to earn their diploma. "The courses are hitting the same standards as a traditional classroom, but are much more condensed," Thomas said.

without that, the kids are doing well. We have a good dynamic going. They get along, squabble like family and keep each other accountable. It's nice to see them relaxed and enjoying school," Hoffmeyer said.



while learning online, Ms. Hoffmeyer or Ms. Bullis are very understanding and offer help," Alyssa said.

For the first time in her younger brother's three-yearold life, Alyssa feels like she is setting a good example.

Alyssa has always dreamt of having a career in the culinary field and will be looking for a job this summer she hopes will carry into her senior year because Claw Academy allows for both school and work schedules.

Tammy Graham, a single mother of junior Josie Graham, said her daughter was not doing at all well at the traditional high school and her grades were deeply affected. "Josie has social anxiety something fierce and was not able to do the work. She'd get distracted by things going on in the larger classrooms, all the high school peer pressure and drama. She was failing half her classes.

Tammy explained because Josie's anxiety would manifest into physical ailments, stomach pain, etc., she would have to pick her up from school at least once or twice a week. "Every week was like that. It was overwhelming for both of us.

"Now she's happy. She likes the small class size and is bringing home As and Bs," Tammy said. She explained Josie attends Claw Academy just twice a week and already

has most of this year's classes finished.

Tammy felt a lot of the accolades go to the academy support staff of Hoffmeyer and Bullis. "They make her feel comfortable there and assist when she needs help. They are just fantastic. This program has truly been heavensent," Tammy said.

Stephanie Martin is the older sister of senior Paige Rupright, who took her little sister in to raise in 2020. She explained by taking her sister in, for the first time in a long time, Paige finally had a stable home life. Still, because she was bounced around so much, not staying in one school for longer than a year, academics didn't come easy.

"The small class size, the support Ms. Hoffmeyer and Mrs. Bullis offer and the online version of school have made a tremendous change. I think online education is revolutionary for the school. Kids can work at their own pace and not feel pressure because the student next to them has already completed the assignment. They can proceed as they understand the assignment.

"Before Claw Academy every morning was a fight to get her to school. Now, she wakes herself up, she's ready to go and looks forward to it. This has helped her a ton. She's confident and positive. It's heartwarming and makes me very proud. Without the Claw Academy, Paige would not be graduating this year. I hope this program continues for other students," Stephanie said.



February 17, 1949 ~ The Michigan State Conservation Commission voted this week to turn over the property of the Harrisville Fish Hatchery to the city. It was ordered that all the property east of the D. & M. Railroad property, including all the buildings and equipment, be included in the grant. Milo N. Johnson attended the session in Lansing as the representative of the City. It was stated by the City Council that the request was made for the property in view of making a recreational park.

It is planned that the two ponds east of the main building will be filled in, and tennis courts will be constructed. Also that ice rinks will be made on this sight in the winter months. It was requested of the State Department that the two ponds west of the main building be maintained as trout fishing ponds for public use. This was withheld until the commission is assured that no charge will be made for fishing.

The Harrisville Hatchery was dosed last month, after protests from every sportsmen's group in Northeastern Michigan. The Commission, upon advice from the head of their Fish Division that the local hatchery had outlived its usefulness, ordered the hatchery closed.

- On March 4, 1933, in the midst of the Great Depression, Franklin D. Roosevelt was inaugurated as the 32nd U.S. president. He would later notably lead the country out of the Depression and to victory in World War II.
- On March 5, 1963, beloved American country western singer Patsy Cline, whose rich, soulful voice made her one of the genre's classic performers of such ballads as "I Fall to Pieces" and "Crazy," died in an airplane crash at age 30.
- On March 6, 2018, the world's oldest known message in a bottle was discovered by Tonya Illman in Western Australia as she walked on the beach with her husband, Kym. The bottle had been thrown overboard from the German sailing ship Paula in 1886 as it crossed the Indian Ocean, and said only, "Could the finder please plot the coordinates it was found, and the date it was found, and send it back?"
- On March 7, 1965, up to 600 nonviolent activists marched to help African American citizens obtain the right to vote. Despite the peacefulness of their actions, the protesters were brutally attacked, with one woman, Amelia Boynton, beaten to the point of unconsciousness.

• On March 8, 1986, 29-year-old tennis star Martina Navratilova became the first in her sport to earn more than \$10 million in prize money when she won the U.S. Women's Indoor Championships in New Jersey.

• On March 9, 1611, Dutch astronomer Johannes Fabricius and his father, David, first observed sunspots, which are areas of reduced surface temperature. Johannes wrote and published a 22-page pamphlet on their findings, "Account of Spots Observed on the Sun and of Their Apparent Rotation with the Sun," though his father initially disagreed with his son's conclusion.

• On March 10, 1949, Mildred Gillars, aka "Axis Sally," became the first woman in American history to be convicted of treason. Gillars worked for Nazi Germany's state radio program during World War II, and from 1942 to the end of the war broadcasted Nazi propaganda in an effort to convince U.S. soldiers to give up the fight. Records of the broadcasts eventually convicted her when she was later arrested and returned to the States.

I have an original booklet with about 30 to 35 pages of those strips through the years. My copy is a little over 49 or 50 years old.
